

# **Elected Officer Descriptions for 2023 Voting**



This month you may read the job descriptions for the jobs that will be up for election at our November meeting. They have been copied from our club By-Laws.

Some officers will be running again for re-election and others may not run. In either case, please read the following and consider if you would like to serve the club in any of these capacities. Those currently serving will not be insulted if you decide to run yourself or to nominate another club member. The nomination meeting will be held in September and the Voting meeting in November.

If you are unable to attend either of these special and important meetings, please remember to send Anthony Bliss your signed proxy form. This form is available for you to print and mail on our website under Member Info >Forms, Rules and Policy.

**Vice President:** The Vice President is responsible for arranging, planning, coordinating, and scheduling all shows and other duties as assigned by the President. The Vice President replaces the President if he is unable to complete term of office. In the absence of the President, the Vice President shall chair monthly meetings of the LIGRS, as well as meeting of the Board of Directors.

**Treasurer:** The primary responsibilities of the Treasurer are maintaining a current accounting of the LIGRS finances, the timely reconciliation of those accounts with monthly bank statements, the reimbursement of expenses, both routine and otherwise, the safekeeping and maintaining financial records as well as drafting and filing necessary forms and documents with the appropriate governmental entities. In addition, the Treasurer is responsible for collecting all renewal dues, forwarding said dues information to the Membership Director in a timely manner. The Treasurer shall also be responsible for other duties as assigned by the President.

Membership Director: The primary responsibility of the Membership Director is the recruitment of new members. The Membership Director is the primary contact with prospective members to determine their interest in LIGRS and its activities as well as accepting new applications and first-time dues payment, forwarding said payment to the Treasurer in a timely manner. The Membership Director is responsible for providing new members with membership cards, name tags and a copy of LIGRS roster and By-Laws in accordance with the LIGRS Publication Distribution Policy. The Membership Director is also responsible for issuing membership cards to dues paying members on an annual basis. The Membership Director is responsible for all membership records, including changes of information. These records are to be always kept current and in good order and are to be available for review. The Membership Director is also responsible for: maintaining a current membership roster, the annual distribution of that roster to the membership in accordance with the LIGRS Publication Distribution Policy, maintaining and distributing sign in sheets for monthly meetings, developing and maintaining records of attendance at monthly meetings, distributing the LIGRS newsletter in accordance with the LIGRS Publication Distribution Policy, and other duties as assigned by the President.

**Directors at Large:** The Directors at large are the liaisons between the membership and the Board of Directors, and any other duties as assigned by the President.
