## 11th Annual Highlands Juried Art Exhibit At Maxfield Engine House, Boonton NJ Exhibit Opens Sunday, October 20, 2024

The 11th Annual Highlands Juried Art Exhibit opens to the public with a free preview Sunday, October 20, 2024 from 2:00 to 5:00 p.m. The exhibit features an impressive mix of original photography, paintings, sculpture and mixed media, all inspired by the landscapes, flora, fauna and historic and cultural resources of the four-state Highlands region, with particular emphasis on the New Jersey Highlands. The exhibit will be held at the newly restored Maxfield Engine House, 713 Main Street, Boonton NJ. Regular visiting hours through December 29 will be posted on the web site.

## Artists' Reception and Announcement of the Award Winners on Sunday, November 3, 2024

The winners of the competition will be announced at the Artists' Awards Reception, Sunday, November 3, 2:00 to 5:00 p.m. The event is free and open to the public. Cash prizes totaling \$1,200 will be awarded for first, second and third places in the Fine Art and Photography categories; Honorable Mentions and Youth Awards will also be announced. From among the juried entries, Hal Bromm. curator and founder of his namesake gallery in New York City, will select the fine art winners; Dwight Hiscano, founder of the Highlands Juried Art Exhibits, will select the photography winners; and Paul Jach and Kristy Brucale Jach, of Speakeasy Art Gallery, Boonton, NJ, will select the Youth award winners.

To qualify for the exhibit, artwork submitted for the competition required approval by a panel of jurists: Dwight Hiscano, award winning landscape photographer and founder of the Highlands Juried Art Exhibit; Elliott Ruga, Policy & Communications Director at the New Jersey Highlands Coalition and award winning photographer and filmmaker; Donna Compton, current Highlands Juried Art Exhibit curator and director and founder of Compton Gallery, Boonton, NJ; Paul Jach and Kristy Brucale Jach, curators and co-founders of Speakeasy Art Gallery, Boonton, NJ; Mitchell Rosenzweig, award winning painter, photographer and filmmaker; and John Castronovo, fine art and photography printer and founder of Tech Photo, Boonton, NJ.

## **ABOUT MAXFIELD ENGINE HOUSE**

The Center for the Study of Cities and Small Towns (CSST) Foundation renovated the firehouse according to a preservation study done by researchers from Penn Praxis at the Weitzman School of Design, University of Pennsylvania. Constructed in 1893 by civic-minded Boonton citizens led by then City Council president, Esli B. Dawson, great, great grandfather of CSST board members, Ryan Dawson of Mendham and Rebecca Birch of New York City, the firehouse occupies a prominent location in the center of Boonton, NJ's Main Street Historic District. It has served a variety of functions since the town's fire engines became too large for its original use.


