1. **MEDIUMS ACCEPTED:** Jurors will consider two- and three-dimensional paintings, drawings, pastels, original prints (lithographs, etchings, monoprints, serigraphs, etc.), mixed-media, digital art, ceramics, sculptures and photographs. Abstract images are also accepted, as long as they are inspired by the Highlands. *No artificially **generated** (AI) images, or portions of images, are allowed.*
