**The undersigned**, Codename: WileyCardone, being duly sworn, hereby deposes and says:

1. I am over the age of eighteen and am a resident of Arizona. I have personal knowledge of the facts herein, and, if called as a witness, will and can testify completely thereto.
2. I suffer no legal disabilities and have personal knowledge of the facts set forth below:
3. I was given authority from Mr. Scott Blackwell, the Progenitor and Protectorate, as well as the sole signatory owner and guarantor of the Company Enterprise Units, the particulars of the Operating Nodes of operations that Mr. Blackwell and his particularly well managed and specifically contracted services providers were contracted to do, across the multiple divisions of his organization.
4. I was given authority from Mr. Blackwell to pick up a particular specific registered bullion portfolio from Morning Star Storage, Lock Unit #1140, located at 19400 Fl-44 Eustis, Florida 32736
5. On 06.03.23, I flew from Phoenix, AZ arriving into Orlando, Florida that same evening. I picked up a midsize SUV rental and got a hotel for the night in the Orlando vicinity.
6. On the morning of 04.04.23, I drove to the Morning Star Storage in Eustis, Florida, arriving late morning into the gated storage facility and parked to locate unit #1140.
7. I located #1140 and used the key that Mr. Blackwell had provided for me to access the locker and opened the roll up storage door. I immediately could see most of the contents and though something did not look right based on what I was expecting.
8. I quickly scanned through the contents and did not locate any of the primary bullion portfolios that were supposed to be in stacked boxes containing the various layers of the bullion that Mr. Blackwell had procured for several of his operations and Company Corporate Enterprise Commerce trading programs.
9. According to the instructions and the ledgers of the bullion portfolio layers of hard assets that were in the copies of the accounting ledgers that I was provided; there was nothing there in the locker apart from one sack of old junk silver half dollar coins.
10. I then took a look a quick photo and went outside the storage building, where I had cell service, to contact Mr. Scott Blackwell and inform him of my findings.

11. After communicating with Scott what was found, I went back to the locker and took more photos and video of the locker and its contents.

12. Shortly afterwards I proceeded to load up the contents of the locker into the rental SUV, thoroughly inspecting and taking photos before and after, while communicating with Scott the entire time the locker was emptied of all contents, closed then locked the locker.

13. The only contents of the expected bullion portfolios that was located were the 1 sack of old half dollar junk silver coins and 1 gram valcambi platinum bar.

14. After packing everything up and continued discussion with Scott, I then proceeded to start on the drive back to Arizona from Florida. I left without what should have been in the calculus of the Bullion portfolio accounting ledgers of just North of \$380,000.00 or up to \$400,000.00 USD in precious metals that obviously had been stolen from that Locker#1140.

**15. WHEREAS;** I was given authority from Mr. Scott Blackwell to access and pick up that particularly well identified, expertly contract accounted for; and a very substantial store of privately very closely held CORPORATE and TRUST PROPERTY FAMILY OFFICE MULTI-GENERATIONAL WEALTH BUILDING STORES of ACCOUNTED FOR and SECURITY LOCKED BULLION PORTFOLIOS in HARD ASSETS. Because I have been instructed professionally by Mr. Blackwell with his Accounting and Ledgers for these properties, I knew that those Bullion Properties specific delineations of 'title of entity and possession via CHECKING ACCOUNT PURCHASES by Mr. Blackwells' company banking records;
