- I then met up with Mr. Scott Blackwell in Sedona I think this was June 2019. Mr. Scott Blackwell and I had a beautiful short amount of time together before [REDACTED] showed up.
- I invited [REDACTED] because I don't go off with men I don't know alone. This was a mistake because [REDACTED] ended up doing many things that were extremely inappropriate.

- We went down to Phoenix and stayed in an airbnb down there.
- We met some greasy Mormon at the golf resort in Scottsdale who faked that he could do a bank deal with [REDACTED].
- The greasy Mormon also tried to offer up two women to [REDACTED], possibly his Mormon wives.
- This made me very upset because I loved [REDACTED] I didn't appreciate that this Mormon dude would do such a thing right in front of my face.

 - [REDACTED] had nothing nice to say about Mr. Scott Blackwell and insulted his platform and called it illegitimate and tried to convince me it was somehow fraudulent, and he certainly wouldn't purchase so much as \$1000 of services to get capital exponentiation.
 - This was very humiliating and frustrating to me because I was trying to pay for [REDACTED] entire business by involving [REDACTED] because it was my job to find people who would grant money to the Institute, and here I found the greatest person possible to do that and [REDACTED] was treating him like garbage.
 - After Mr. Scott Blackwell left [REDACTED] bought me flowers and told me how horrible it was the way I had been treated by [REDACTED] and used his misunderstanding of the platform to try to say I was getting defrauded and then used that to perpetrate criminal acts on me at my job, namely [REDACTED] because that is when he started moving in on me.
 - At some point after this I think [REDACTED] came back to San Anselmo and we made amends.
- He stayed up in my room at the house I lived in on San Anselmo Ave. in San Anselmo. We were talking to the pejoratively monikered "fat Mike" aka Michael Huggins fake representative of the [not] World Bank from Las Vegas on the phone in the room of my house.

- We started calling him "████ Mike" later after we realized he robbed us and he didn't work for the World Bank at all, because also I had made him this amazing salad and he was like 'that was the best salad of my life' and it was contextual irony because he looked like he never had eaten a salad in his life and we were upset by getting robbed.
- "████ Mike" aka Mr. Michael Huggins was pretending to be so spiritual and saying the bank deal they wanted to do with us was spiritually based to help the little guy.
- I came up with a bunch of prayers for him and we all did a prayer together [which is now super embarrassing because it was fraud and I was vulnerable and believed he was legit and opened my heart to him and his friends]
- We also went up to the Robson house mansion and gardens patio in San Anselmo and did a prayer meditation for "████ Mike".
- I had emailed people and invited them to this prayer session.
- This is when I first heard about Matthew Schleuter.
- Mr. Scott Blackwell and I stayed one night at the inn in San Anselmo when my salty unhygienic roommates kicked us out of my house, because they said they didn't like the sound of Mr. Scott Blackwell being on the phone all day and were super rude to us.
- We called ██████████ and informed her of the platform. Thinking we would become enriched w bank deal w █████ Mike and Fake World Bank while we were at the inn I came up with a list of charities to fund which I still want to fund.
- I think after that Mr. Scott Blackwell and I went down to San Jose to meet ██████████
- Mr. Scott Blackwell left and I continued to do paperwork projects for Mr. Scott Blackwell remotely.
- Not too long after this he told me he was going to Las Vegas to do a deal with ██████████ Mr. Michael Huggins.
- I was so excited I asked to come with thinking it was all legit and wanting to be part of something exceptional, especially since my art was going on the paperwork.
- I was hoping it was going to be an outcome where I had legitimacy and influential people seeing my art and trading and benefiting others via funding SOSIEV, REXUS, etc.
- Mr. Scott Blackwell and I stayed at an Airbnb of this ██████████
- ██████████ aka Mr. Michael Huggins started showing up every day with his assistant Hector who was saying he was like the prince of Peru or some South American country and he was carrying a machine gun in a tennis racket with him every day.
- Mr. Michael Huggins friend Hector was always talking about how his sister was a witch and what her prophecies were for the future which was frightening.
- I was terrified of the machine gun in the tennis racket that they kept pulling out.
- "████████" aka Mr. Michael Huggins told me he stopped paying his rent during covid which was a red flag. If he was so rich why would he stop paying his rent? I began to become confused.
- This is when they were saying they wanted to have the World Bank back up a bond with Mr. Scott Blackwell's companies' metals and collateralize it.

- They were also saying there was some kind of Russian extraterrestrial and they kept putting her on the phone but she sounded like all she cared about is 'when are you going to give us the money'.
 - There was another guy they kept putting us on the phone with asking for help to fund kids computers at a school in Philadelphia or somewhere equally as impoverished saying he was going to be the next president. He was super obsessed with becoming President of the United States.
 - Mr. Michael Huggins and Hector showed up every day harassing us to do work for them but the real 'work' they wanted was for us to give them some giant handful of cash.
 - Mr. Scott Blackwell gave them some money that there was a cash receipt for that I made the cash receipt form.
 - Mr. Scott Blackwell came up with the micro-cap program which was supposed to have been all the dividends that would get drawn off the bonds "rolls and extensions"
 - Because it was over so much money Mr. Scott Blackwell started having people come in to join the micro capital program to exponentiate their capital for them and enrich them on the local level out of this deal.
 - Mr. Scott Blackwell and I were working 12-14 hours a day setting things up with financial institutions and I was creating all the documents and was the admin/secretary for the whole ordeal.
 - As I was typing it up I was thinking to myself [REDACTED] 1 is this real 2 am I going to be legally liable if things go sideways because the volume on the rolls and extensions were so high and there were already red flags but at this point it was too late my friends and family put their money in.
 - At this point I did not have any background in finance I was simply contracted in in a services management agreement which was mostly about creating paperwork for Mr. Scott Blackwell's company, as well as graphic design.
 - I did want my friends to benefit from this deal if it was real so Mr. Scott Blackwell offered them to purchase services but no one really knew what that meant and thought of it as an investment and thought they were getting this money amount back that the chart said which was into the nine figures in some cases.
 - These friends/family did not seem to understand they were purchasing services and credits not making an investment and were using the wrong language which made me nervous and I tried to explain as an authorized representative that was not the case but even I was a bit confused as to what it really meant or what was the timeline for exchanging the credits or getting privileges within Mr. Scott Blackwell's platform.
- [REDACTED] came and had a great time with us and purchased well as with the gold bullion.

• In total [REDACTED]

- I also felt responsible however because I introduced [REDACTED] and I did not know how many of her friends ended up being involved in the microcap such as [REDACTED]

- Not sure if I am forgetting anyone because I am going by memory and it has been several years.

I already wrote this affidavit once before for the section regarding The Las Vegas 'guild of grifters' but it seems to have been stolen we cannot find it right now – it may have more detail because it was closer to the time of the crimes

- Mr. Scott Blackwell's friend [REDACTED] from Utah showed up who has the minerals on his land to also be present to the deal.

- [REDACTED].
- [REDACTED] the alchemist came to visit us during this time.

- We took photos of an empty abandoned Las Vegas strip.

- There was a lot of drama because Leslie was abusing her worker while Mr. Scott Blackwell was away and screaming that she was going to rip out his new teeth with pliers, it made me cry and start having a stress breakdown.

- I was staying up late to work all night and not sleeping also.

- [REDACTED] and also the apparent crime happening in front of our faces from Fat Mike aka Mr. Michael Huggins, Hector and friends caused us to get upset and fight.

- I started investigating him because I was upset my friends and family seemed to have lost their money into a scam because clearly the Fake World Bank deal seemed like fraud of some type especially the swearing in.

- Also in Las Vegas I attended a swearing in of Scott Blackwell as some kind of royal officer court of the crown of England and were telling me I was going to dance with prince Charles at a ball which I was not impressed by nor did I believe.

- I recorded all my phone calls of Matthew Scheluter where he admitted to committing various financial fraud against people in the town and crazy things about his cult, I got about 10 hours of recorded audio material in my archives.

- By the time I got to Sedona I already decided I didn't want to meet with Matthew Scheluter and I think I told Mr. Scott Blackwell by this point I had been recording him

and gathering evidence and Mr. Scott Blackwell convinced me that Matthew Schleuter was part of the fraud and a con artist.

- I had already figured this out on my own by interviewing him on the phone on recorded calls for over 8 hours while I was investigating him for myself.

- Matthew Scheluter then - still at the Chocolatetree restaurant in Sedona AZ - standing outside in front and in front of others that were dining - threatened Mr. Scott Blackwell to me and told me he was going to have people in the government related to his Dad physically 'pickup' and kidnap Mr. Scott Blackwell and said they would then "take care of him".

- I told him he just threatened to kidnap and possibly kill a man and to get away from me and I will not be party to such crimes.

- I reported the crime to Mr. Scott Blackwell immediately after.

- On the same trip I met up with Mr. Scott Blackwell and stayed in a rental home for 3 months in Village of Oak Creek around March 2021 where we conducted operations and I learned office and filing management aspects from Mr. Scott Blackwell as I executed various tasks and projects for him as well as the job I still had.

We met with Brad the lawyer Mr. Morgan Langan and Mr. Floyd Ingram about opening

[REDACTED] helped Mr. Scott Blackwell get special tax free no social security number trust account.

We had a party for some people in Sedona including [REDACTED]

- There was a "fat Mike" style guy with a bald head named Marty and a bunch of gold and diamond jewelry that was not actually "fat mike" that was coming over to see all the paperwork and he was tire kicking and being rude and acting like it was all fake and he was I think friends with "fat Mike".

He was making rude untoward comments like Mr. Scott Blackwell wouldn't be able to afford to melt down the metal and if it was real he would have by now or something to that effect.

- Mr. Scott Blackwell and I set up viewing tables for the community to see everything which was a ton of work.

- Mr. Scott Blackwell and I spent tons of time making the capsules and the QZT 19 products.

frustrated that he never got the bank rolls and that there was crime.

He told started slandering what I was involved in and saying negative things about me and the platform.

- I was getting increasingly upset

I tried to convince Mr. Scott Blackwell to just give it back so they all stop asking me what happened and think poorly of me.

- yelled at me and we stopped being friends over that and the fact that I told him he needs to stop being upset because he was always cheap and it is real.
- No one got paid back all we did was work it had already been a year since we had done the microcap program and it was all stopped down and everyone thought I was a scam.
- of Silicon Valley and the inventor of aka 'Mr. Silicon Valley' seemed to have lost respect for me after that as well as who I ended up
- I was devastated as these were important relationships to me and my attempt to become more professional and have a standing in society and a career.
- We left the airbnb and went our separate ways.
- I saw Mr. Scott Blackwell again after this for my birthday in October of 2021 where I drove out to AZ because I knew we would have a great time together.
- We drank champagne and played with bullion in the parking lot and had a lot of fun.
- In around November 1 2021 I moved to a trailer in Cornville AZ.
- Mr. Scott Blackwell came to visit periodically and we talked about me doing client services out of there.

- I helped Mr. Scott Blackwell build the Sedona West elements and fixed the flyer for him to be extra beautiful which took an extraordinary amount of time to build out these elements, of which there are cash receipts for all the work I did

- All my cash receipts are in my storage unit in Sedona as well as platform binders and papers stocks etc.

- At this point Mr. Scott Blackwell contracted to have his condo be a work node for Mr. Scott Blackwell's platform.

- Mr. Scott Blackwell came to visit my trailer periodically and stayed over a few times and we mostly had a good time as we worked on building out Sedona West platform

- We made tons of paperwork and I worked on his website and photos.

- We also made chocolate again and I taught Mr. Scott Blackwell how to temper chocolate which was closely held IP that took me thousands of dollars and man hours and working inside TOP TIER NASA LEVEL chocolate

factory to acquire that almost no one in the world was allowed into that I had to do essentially 1.5 years of slave labor to learn about.

- The same guy that thought he lost 1K\$ in micro-cap program and chewed me out who had been my esteemed partner and colleague previously for years.
- [REDACTED] refused to sign the contract for Scott's platform and still has not to this day.
- One day Mr. Scott Blackwell told me that Maia Peerzada had hijacked [REDACTED] house and claimed he assaulted her.
- I asked [REDACTED] about it and he said he did grab her shoulders, but he said she was not hurt and she was blowing it way out of proportion and it was not grounds to steal his house.
- I did not know who to believe.
- The day before Mother's Day 2022 Mr. Scott Blackwell asked me to help him get his stuff out of [REDACTED] house related to his various enterprises, "the contracted node".

I regretfully obliged and he stayed at the trailer the night before so we could wake up super early.

- We asked my 2 friends [REDACTED] to help us and be the ones to knock at the door to get the belongings.
- The day prior [REDACTED] had been over to the trailer, I think it was to fix some plumbing issue for me, and he happened to meet Mr. Scott Blackwell.
- He thought he could help retrieve Mr. Scott Blackwell's belongings because he knew Maia and agreed to come along also as he appeared to be a neutral party and wanted to see it peacefully resolved.
- We didn't know [REDACTED] had always been on Maia Peerzada's side and was definitely not on Mr. Scott Blackwell's side, he had made it seem like he was a neutral party and cared about mediating a fair resolution.
- If we had known this we wouldn't have asked him to mediate.
- Later I found out he had other criminal incidents in the town involving breaking into the house of his x-wife and had other incidents that involved the police department of Sedona, Arizona.
- We woke up very early and went over to the house.
- I told them to wait until we see her leaving and then just use the key to enter the premises to retrieve Mr. Scott Blackwell's belongings but nobody wanted to wait or do a stake out, but I felt it would create the least drama.
- No one listened to me.
- [REDACTED] went up to the door at first with I think [REDACTED] there from the beginning as well.
- [REDACTED] came back to the car and said that when Maia Peerzada came to the door she had a gun.
- They got freaked out and wanted to leave and bailed out even though they had taken payment and not retrieved the belongings.

- They refused to write an affidavit or document their experience as requested by myself and Mr. Blackwell.

_____ turned out to not be a neutral party and he was fully on Maia Peerzada's side and did not really attempt to get any of Scott's belongings and did nothing when she wouldn't hand Mr. Scott Blackwell's stuff over as far as I remember.

- Somehow the police got on the phone with Mr. Scott Blackwells while we were in his truck and they referred to me by my legal name which I never gave them. They said something like "Who is _____ Is that you Ma'm?"

- Not feeling I could lie to the police I affirmed my identity.

- My private closely held legal name that apparently Maia Peerzada had gotten some how, which I assume was by pilfering through Mr. Scott Blackwell's paperwork which she later admitted to to me.

- I do not have my legal name on the internet and have attempted to remove my legal name from the internet entirely because my father was a corrections officer and I was told to live in privacy to avoid any potential retaliation against his family.

- To be exposed like this to the police made me absolutely enraged, and Mr. Scott Blackwell and I argued severely because he was so upset about his assets getting pilfered through and stolen, and I was freaking out because the mircocap people never got paid back and I thought I was going to go to jail now.

- Mr. Scott Blackwell was so bereft and tired _____

_____ he literally just lost everything he owned to this woman Maia Peerzada.

- He was so irate when we got back to the trailer he could not function from the distress of this situation and I was left to clean up the mess with him.

- I tried to help him but nothing could comfort him or make it better.

As a result I asked him to leave my trailer and told him never to come back because I couldn't handle the drama anymore.

- I freaked out and thought I was going to end up going to jail because of the crimes in Las Vegas against Mr. Scott Blackwell and my people who put money in, and now there was a police report with my name on it in Sedona.

- I was terrified of Maia Peerzada telling all the people who purchased services from Mr. Scott Blackwell and expected returns wether or not it works that way it seemed that that's what they believed; I was afraid of her giving them all my legal name, which I believe she did.

- I thought the responsible thing to do would be to warn people so they don't loose money or the police would have no mercy for me and I now believed I would eventually be in trouble of some kind which I didn't understand but I felt responsible for introducing my best friends and family to this man to which all I knew was that there was a significant amount of crime around and I didn't understand how to resolve it.

- To top this all off there was an argument between my long time friend _____ had picked up her misplaced phone from the outdoors which cast even more drama and controversy on the situation

that I didn't want to be part of but got dragged into by [REDACTED] because she had seen us together frequently and she told me everything that happened in that situation.

- And then on top of that there was an argument between Mr. Scott Blackwell and my [REDACTED] over a vehicle purchase that I was forced to hear about from [REDACTED] whose surrounding controversy I was also unwillingly dragged into and reputationally damaged over because I was staying at her house when it happened from being displaced from my trailer due to lack of working vehicle and fear of retaliation over all this mess.

- The crimes were not getting resolved fast enough to save my reputation from the microchip people who were all asking questions and texting me.

- [REDACTED] was very upset and said Mr. Scott Blackwell embarrassed her in front of some woman on a private jet on the tarmac and further disparaged his character to me as a result.

[REDACTED] as a result told me she was possibly losing [REDACTED] as her benefactor. I can't remember if she said she definitely did or not loose [REDACTED] support. She then ended up moving in with [REDACTED] the [REDACTED].

- I called [REDACTED] on a recorded phone call to try to tell her not to put up her money.

- I wrote a letter to the Tobacco guy [REDACTED] to try to stop him from giving Mr. Scott Blackwell money assuming he was thinking he is investing in Mr. Scott Blackwell not knowing Mr. Scott Blackwell is the one who gave [REDACTED] [EXHIBIT A]

- I did not think it was fair that Mr. Scott Blackwell was going to spend a bunch of money on this Las Vegas trip knowing that the MicroCap people did not have a resolution to the crime yet and not fully understanding the tokenization system or timeline of fluidity of exchange and didn't understand they were unrelated fund silos.

- I wrote a letter to Nolan Newberry Jr. on Facebook which he did not write back to. [EXHIBIT B]

and a letter to [REDACTED] [EXHIBIT C] saying the same things as well as a letter to [REDACTED] in [REDACTED] [EXHIBIT D] and put up a warning notice on Facebook [EXHIBIT E] thinking this was the right thing to do because the 'micro cap' people were never refunded and I had seen the crime with my own eyes.

- I just wanted the drama to be over and to do the right thing.

- It was confusing to figure out what was really going on because of all the people who tried to convince me this was a scam from the beginning and attacked me for my love for Mr. Scott Blackwell.

- I still didn't believe it was a scam but I also didn't want to go to jail and there had been no resolution and it had been over a year and I was getting harassed.

- I saw [REDACTED] a couple weeks after this in town in Sedona and he wanted to know if I turned against Mr. Scott Blackwell yet or not. He suggested I don't want to be known as the person in town that sided with a criminal and that I need to help Maia Peerzada because she is going to be homeless and I will have a terrible reputation if I don't help her and I could go to jail.

- I saw Maia Peerzada around this time in 2022 while she was still squatting in [REDACTED] house where I met her for the first time at a dance party at Ulitimate Light Mission where she told me she was going to get Mr. Scott Blackwell and [REDACTED] arrested and she had my legal name also and I am also responsible.
 - She told my legal name to [REDACTED]
 - I also attended [REDACTED] event to warn people not to put money in because I was afraid of the community becoming victimized as I did not really understand what was going on and I could not take any more as the 'micro-cap' people were already harassing me and asking if they got robbed and what am I going to do about it.
 - I don't know who of the micro-cap people Maia Peerzada got the information of and it seemed like the instances of perturbation were increasing.
 - I started to get a restraining order against Mr. Scott Blackwell for fear he would retaliate but decided not to go through with it because I was afraid he or his team would retaliate even further for the restraining order.
 - I was also terrified of Nolan Newberry Jr. who seemed like a violent drug addict vibe.
 - Afraid for my life, I moved out of my place to live [REDACTED].
 - Also my car had broken down and no one from the platform would help me get transportation and I could not afford to take care of it anymore because of things also shifting with my job due to all the stress drama crime and then my employer harassing me.
 - I also lost my job [REDACTED] which further complicated my stress and upset over everything else going wrong and my stress and rage breakdown over the financial losses and damage to my reputation at perceived losses even if they were not really lost it was not properly communicated to the individuals in the microcap program or at least that's what they were telling me.
 - At some point Ms. Maia Peerzada texted me and got my number from [REDACTED].
- She asked me to write her a statement for her court case against [REDACTED] Mr. Scott Blackwell.
- She also told me over the phone when we finally talked that she called the FBI and opened a case against Mr. Scott Blackwell and that she gave them my legal name and phone number which I was very upset about because I felt like I got robbed by the people in Las Vegas, Mr. Scott Blackwell had still not returned their money, and they were all mad at me and I didn't know if now I am going to jail for something I truly thought was legitimate.
 - Maia Peerzada wanted me to write her a statement for her court case against [REDACTED] and saying she was desperate and homeless.
 - She instructed me what she wanted me to have the statement be like by sending me an example I should follow.

- I assumed if I did not go along with this FBI agent was going to come after me or I would be in trouble for the microcap people's loss or WMO/ECI non-performance on the schedule of performance because Maia told me they are already investigating me.
- This was compounded by the fact that she told me she has a very close personal relationship with at least one officer of the Sedona Police Department.
- I felt terrible about what happened and still wondered if I did the right thing.
- I was so angry from all the drama and breakdowns I did not want it to continue.
- I wrote the statement for Maia in an attempt to help her to not be homeless and to personally not be legally liable.
- I also found this person on Facebook who was saying he had been defrauded by Mr. Scott Blackwell, his name was Mr. Jeff Grunow. [Exhibit F]
- Mr. Jeff Grunow and I texted about bringing these crimes to justice as I was very upset as I was also orchestrated [REDACTED] due to these crimes of the people in Las Vegas and the 7 to 9 figure returns suggested to the microcap participants was not going to happen.

- My disgruntled texts to Mr. J. Grunow did not lead to any further action taken by me; nothing discussed in the texts was acted upon by me, such as reporting any evidence to the state of Arizona contact Mr. Grunow was suggesting I report to.
- I have not turned in and will never share any evidence or any information about Mr. Scott Blackwell's platforms or enterprises to any government agencies.
- I did not talk to Scott Blackwell for approximately three years after June of 2025.
- I wrote Mr. Scott Blackwell to try to work it out and he was understandably upset which was compounded by the fact that apparently Mr. Nolan Newberry Jr. took what I wrote him and used it to allegedly rob and attempt to physically hurt Mr. Scott Blackwell and lie about me.
- I had absolutely no knowledge of such events prior to contacting Mr. Scott Blackwell in April of 2025.
- I have not benefited in any way from Nolan Newberry Jr. or his crime and theft schemes against Mr. Blackwell or from Mr. Patrick Potter and his theft schemes against Mr. Blackwell.
- I have no knowledge of any events regarding Nolan Newberry Jr. stealing or taking anything from Mr. Scott Blackwell or attempting to hurt him or hire someone to hurt him.
- I was not aware Mr. J. Grunow was either involved in any of these crimes or fraud schemes, as I was completely unaware of the robbery, attempted murder or fraud schemes against Mr. Scott Blackwell.
- I am disgusted Mr. Nolan Newberry Jr. and Mr. J Grunow and Mr. Patrick Potter could act as if not helping me solve the crimes, then using my complaining about getting

robbed to justify further crimes, and then never they themselves attempt to solve the original crimes that they used as some kind of justification apparently and allegedly.

- I never wished Mr. Scott Blackwell physical harm.
- I wish the best for Mr. Scott Blackwell and never wanted to be involved in any of this drama.

- This whole experience has been terrifying.

- This was a distorted attempt to resolve the years long damages caused to my reputation by crime against Mr. Scott Blackwell's platform as well as crime against personally me my friends and family.

- I lost many friends over thi [REDACTED]
[REDACTED] + probably more I can't remember now and people in the town that heard about these events from third parties.

- I lost the respect of [REDACTED].

- I contacted Mr. Scott Blackwell and attempted to create a resolution so he or his team does not retaliate against me, not knowing of the additional crimes done to his platform by Mr. Nolan Newberry Jr. Mr. J. Grunow and others including the crimes during and after 2023 described to me by Mr. Scott Blackwell on Telegram app in April 2025.


- Upon this contact this is the first time I found out about Mr. Nolan Newberry Jr. attempting to cause injury to and also robbing and ransacking Mr. Scott Blackwell and his nodes in Earth Day 2023 which I had absolutely zero knowledge of.
