**The undersigned**, Scott Blackwell, being duly sworn, hereby deposes and says:

1. **I am over the age of 18** and am a resident of Arizona. I have personal knowledge of the facts herein, and, if called as a witness, could testify completely thereto.

2. **I suffer no legal disabilities** and have personal knowledge of the facts set forth below.

3. **I have been the progenitor and founder of an organization that is made up of a specific fabric of operating units and technologies** that I established a management operation to manage the overall aspects of many layers of minerals and precious metals ores and also bio-available minerals. I am reporting the facts that I have been informed of by Robby Mattson, a business establishment owner and individual that I was informed of, who was holding "Share Unit Certificates" for a Company, known as Western Minerals & Ores Corporation. I was informed that Nolan Thomas Newberry aka Nolan Knight, who had served as a SECRETARY of WESTERN MINERALS & ORES CORPORATION for several years, had organized a gathering of local people through connections that were directly known and entertained by Nolan Knight. The report regarding the gathering that Nolan Knight had organized and utilized to conduct a promotion was conducted solely by Nolan Knight; this activity was unknown to anyone at Western Minerals and Ores Corporation and was only discovered during Easter holiday time 2024. The following paragraphs are background, back drop and contain other specific context, information and concerns that are preemptive to what Primary Protected Eyewitness [disclosed to public safety officers and coded enforcement procedural due process], of which Eye Witness statement here, *has been derived from their recorded transcription*, which is emphasized below, towards the end of this Affidavit of Fact.

**TORT CRIMES. LIBEL – SLANDER and HATE CRIMES are part of this Affidavit of Fact.**

These areas of this Affidavit of Fact may be accessed on line through internet servers that serve the massive degree of data, information and facts related to the full spectrum of information that has been prior to this Affidavit of Fact and will be involved in the aftermath of the legal-services-delivery aspects of where this Affidavit of Fact is delivered to. **Therefore**, the TORT and LIBEL-SLANDER and HATE CRIMES that surround before, during and after this Affidavit of Fact has been generated, relate directly to the certain particular embedded data forensic information and intelligence services work together with what is in the dossiers which cover the entirety of the Backdrop and back-story to the criminal career of Nolan Knight at Felony scale and the other Felony scale criminals that Nolan Knight assembled to conduct the related criminal activities that are EXHIBITS to this Affidavit of Fact; or are part of the larger body of dossier materials that have been filed with various archives and placed on specific servers for Internet disclosure to 'authorities and law enforcement by Mr. Blackwells' technologically advanced facilitation engines to assist in coordinating

factual anti-tort, anti-libel, anti-slander, anti-defamation, anti-hate crimes and other of the layers of criminal acts and actions taken by Nolan Knight and his criminal gang.

**Therefore:** also this background and backdrop is relevant to providing for certain select authorities, law enforcement agency layers at 'higher-court-services' levels of entry of this data; has been completed; also, that is relevant to this Affidavit of Fact and also relevant to the aftermath of Nolan Knights' long term campaign of violence and related malicious schemes and malfeasance, severely collaterally damaging collusion with other individuals identified who have been in criminal collusion with him and from continued contiguous observation, still are.

**Of substantive relevance to this Affidavit of Fact** as to it's backdrop and introductory information; It is important to note that I am a severely abused victim of manufactured **TORT for EXTORTION to utilize as a lever to conduct the other Crimes such as the espionage, trespassing, breaking & entry, sabotaging of enterprises, theft and high-jacking of high-net-worth liquidity assets of our organization**, of our families properties, of our clientele assets and certain strategic assets kept in storage vault lockers for long term liquidity positions in macro and bitcoin and other areas such as the real world assets in stable coins, RTFs and in-house interchange which at this time has cost over \$120 Million USD metrics pegged to the US Dollar; all of which is directly related to the tortious interferences, tort crimes and related libel, slander and severe abuses conducted by Nolan Knight and due to those malicious torts, libel, slander, long term hate crime campaigns by identified tort criminals and extortion criminals; other facets of this Affidavit of Fact in EXIBITS and DOSSIERS or ONLINE UPLOADED EVIDENCE; do also cover tort crime abuses that involve the thoughtless and abusive behavior recorded and filed against former clients that became poisoned and corrupted by the well documented perpetration of non-stop abusively criminal violent **TORT CRIMES**.

**Therefore, this introductory region of this Affidavit of Fact.** That it is important to know by readers of this document, that TORTS and DEFAMATION and HATE CRIMES were used as malfeasance and unlawful incitement of others corrupted individuals or corrupted licensed professionals; in a vicious long term perpetration of a filthy well documented, tort crime hate campaign, that was and is yet still being unlawfully utilized against me as an excuse to perpetrate the defrauding of my good and proper name and enterprise-commerce platform and related other aspects of the fabric of the mosaic of an organization that became an alternative matrix.

**EGGREGIOUS TORTIOUS CRIMINAL ACTIVITY, WIDESPREAD** in the Neighborhoods negatively impacted by Nolan Knight and his professional felony scale Thugs and corrupted licensed practitioners and a specific identified especially undesirable and dangerous 'licensed private eye'. The TORTS and the MALFEASANCE related to the TORTS, the Libel, the Slander, the Defamation and Hate Crimes that are attached to the crimes which Nolan Knight and his professional THUGS used were violently and maliciously utilized to perpetrate their crimes and their intention was to conduct a final act of homicide against Scott Blackwell; and although they have not been successful to date of such intention, it has not been a scenario which isn't under the acute awareness of and defense of by Mr. Blackwell and others who are aware of such intentions perpetrated by Nolan Knight and his felony thug accomplices and aiders, abettors and harbingers of this egregious scale of long term perpetrations; therefore the extensiveness of the multi-pronged and technologically supported aspects of the source of this Affidavit of Fact: let it be further known in detail that being Nolan Knight and his gang of Thug felony level accomplices are still operationally active and extremely dangerous; they did/does and are still perpetrating their torts, libel-slander and hate crimes for their own purposes to profit, cause continuous collateral-damages, cause hard, unlawfully incite others against me and my family, friends, organization etc.; in order to continue to rob, steal, cheat, dilute and continue to use the high net worth value of the many

assets that they highjacked which are on our company and operations general ledgers, in profit and loss sheets, in balance sheets and reported for 8 years into the IRS and into the Management aspects of managing the massive volume of insulated and protected assets; this criminal, this thief, this miscreant, this degenerate, this drug addict, this marauding threat to the public safety and peace across our neighborhoods was, is and has been permanently collaterally-damaged, disrupted and pollutes our otherwise very prominent and successful enterprise-commerce operations units and in general these TORT CRIMES which are HATE and DEFRAMMATION CRIMES were also perpetrated by Nolan Knight, who knew better; and who decided to line his own pockets with liquidity capital assets of the operational enterprise commerce and interchange platform that I had architected and built. This particular aspect of the organized criminal torts and defamation crimes that have been perpetrated against me and the organizational matrix that I founded and created, also have been criminally assaulted by 3<sup>rd</sup> parties not even related to our enterprises who are people that utilized the abusive criminally manufactured torts in a manner that caused them to be removed of any client or customer privilege that at one point, they had: now no longer due to their criminally abusive collusion and tortious interferences from getting involved in the TORT TROLLS; who are also listed in the ledger of criminal individuals that have been reported and blacklisted and are summarily as a result of their participation in torts, libel, slander and hate crimes, became 'persona non grata' and removed from our enterprise-commerce awards *accordingly*.

**4. There were other people that were at the gathering that Nolan Knight had organized, who no one at Western Minerals and Ores Corporation even knew of or had ever heard of,** who were also connected with Nolan Knight who Nolan Knight had brought into the perimeter of the Company known as Western Minerals and Ores Corporation. It is important to note that these particular people were never introduced to the founder and chief operations officer of Western Minerals and Ores Corporation, either. One of those connections was Doug Trakes, who Nolan Knight was involved with in different conversations and illegal activities, regarding their endeavors in the North Phoenix neighborhoods and across a broad swath of other neighborhoods. Those endeavors were not legal endeavors; Nolan Knight was manufacturing bulk quantities of illegal steroids and redistributing those drugs into the neighborhood connections that he had cultivated across multiple gyms and enterprises across a broad swath of neighborhoods and multiple states. One of these individuals was Doug Trakes; now deceased; however relevant to statements related to the illegal activities of Nolan Knight and this Affidavit of fact regarding what he did with Western Minerals and Ores Corporation with no authorization from the owner(s) or anybody in corporate operational capacity. Nolan Knight is on his own with this aspect of his many various criminally malicious nefarious activities.

**5. These identified individuals and all other related individuals that are tied into this Affidavit of Fact,** are included below in this Affidavit of Fact because they attended a gathering that Nolan Knight had organized. Again, this event was never any event that anyone at Western Minerals and Ores Corporation knew about until Easter holiday of 2024. The individual that is a witness to several other people who brought this level of detail to my attention, and whereby I and others found it necessary to interview. At the time of this interview, it was an Easter Sunday morning year 2024. We went to the establishment that one of the Primary Eyewitness whom operates enterprise location and who is an owner operator of, known as [protected information]. A professional witness who will not be mentioned in this affidavit but will emerge in another Affidavit that will refer that Witness name and account of this interview will follow this Affidavit of Fact as an "EXHIBIT" to this Affidavit of Fact. We went to [enterprise establishment] sat down with the well-known respected proprietor; there are as well, as referred to above, the two professional witnesses, to go over the details of what had been brought to our attention about "Nolan Knights' nefarious unauthorized promotions and sale of stolen blank share unit certificates".

6. **The following is an account of information, evidence, statements and circumstances** what I encountered during 2024 Easter Holiday time. I was brought into the attention to this information by business owners, who own established operations in Phoenix, Arizona. The information is directly related to a gathering of people in the home of Debra Mattson, who is the sister of Robbie Mattson who operates the Bhudia Bella establishment next to the closely proximal Tuti Santi Restaurant.

7. **This report is precise.** This report carry's specific data to alleviate any false evidence appearing real or manufactured to appear real against Mr. Blackwell; heretofore as follows contains what represents the quoted statement of Mr. Robbie Mattson, an owner operator of Tuti Santi. Mr. Mattson proceeded to welcome us into the Tuti Santi restaurant and bar during off hours. During the time we sat down in the restaurant with Mr. Mattson; and he stated the following as transcribed from an Otter A.I. powered recording of the talk session.

8. **Many other documents and dossier level stacks of forensic evidence is logged on internet servicers that accommodate all Affidavit of Fact statements that are available, such as this one;** which pertain to this Affidavit of Fact, from for example. the two professional witnesses regarding this Affidavit of Fact. There were two professional reliable witnesses at this talk session. One was there to ask questions that were pertinent to the extended investigations into the criminal activities of Newberry / Thomas / Nolan aka Nolan Knight and the other particularly malicious individual that he recruited to assist him to conduct multiple felony counts of various layers of crimes committed by Nolan Knight and the others that aided and abetted him; Nolan Knight had been violently attacking not only Western Minerals and Ores Corporation but also many innocent people and especially did he focus his criminal assaults against Mr. Blackwell.

9. **Nolan Knight premeditated and engaged in a complex series of schemes with other identified felony level criminals and unlawful abusers of their professional license to 'practice law or conduct private eye services' to commit the multiple felony level crimes** that he committed against our companies, against our trusts, against our family offices, against our people and for the purposes of defrauding, trespassing, high-jacking, conducting unlawful violent crimes of espionage, soliciting others using corrupt torts, libel, slander to conduct unlawful incitement of law enforcement to 'do harm' to others; while scheming, plotting and planning over a great deal of time with the 'identified and reported others that are also fully identified and thoroughly reported in very orderly dossiers of Affidavits of Fact, police reports, intelligence reports and information reports that add up to inarguable proof of the crimes that were committed by Nolan Knight and his neighborhood THUG network; and others' who perpetrated the material reported and material forensic grade evidence that has been via great lengths of procedural due process filings to secure the arrest, containment and detention of these perpetrators with Nolan Knight who perpetrated these crimes.

11. **Nolan Knight conducted a long term violent perpetration and campaign of felony level multistate crimes** against the aforementioned and multiple operations of the companies, the organization of Mr. Blackwell and related other multiple family offices and many people who were severely negatively impacted and who have suffered severe catastrophic collateral damages from these crimes that Nolan Knight and his felony thug network of thieves, drug dealers and fraud/extortion and tort crime specialists committee with him; obviously for a percentage of 'the take'. 10. **A PUBLIC MENACE. A PUBLIC SAFETY ISSUE.** This Affidavit of Fact described a PUBLIC MENACE with multiple FACES and PLACES of OPERATIONS of this PUBLIC MENACE embodied in the individual known as Nolan Knight aka Newberry / Thomas / Knight. This Affidavit of Fact is but one of the many Affidavits of Fact that have been generated by multiple professional witnesses and operations professionals along the way in the reporting of the crimes that Nolan Knight and Jeffrey Grunow committed; as well as others who either aided and abetted them or were part of a long term premeditated set of multiple schemes hatched by Nolan Knight and his criminal associates to trespass on, defraud, steal vehicles and break into privately held security vaulted assets of high net worth value that Nolan Knight certainly did not have any authority or permission to access, much less trespass on and highjack.

12. **"I have been an active entrepreneur and business owner in Phoenix, Arizona.** I am well established as a business owner and am making a statement regarding an event that was organized by Nolan Newberry who is the individual that came to visit myself and my sister, some other friends. We also knew Doug Tracks who is now deceased. My sister [a local enterprise operator] was talked into hosting a house gathering and Nolan Newberry aka Nolan Knight was there and is the individual that promoted an opportunity to us. He presented and sold us the opportunity. We have never heard from him since the time he came and promoted the opportunity. Some other folks that we know heard that this house gathering had occurred and they wished to speak with me about it. They informed me that they are the original founders and co-founders of the Company which is referred to and known as Western Minerals & Ores Corporation. We were promoted to and that we did an exchange of funds and provided our funds to Nolan Thomas Newberry aka Nolan Knight who knew Doug Trakes and did a "promotional party of Western Minerals & Ores Company" without authorization to engage in that activity where Nolan Knight sold share units using *BLANK* stolen share unit certificates.

I hereby attest to these facts of what occurred with Nolan Newberry Knight aka Nolan Knight who promoted the opportunity of those share units but we now find out that he did not have the authority or the permission to do that kind of exchange with us. Nolan Knight provided in exchange for our funds for what he was promoting and in which he provided us with a 'blank share unit certificate': which were "Capital Stock of Western Minerals and Ores Corporation 'Assets and Precious Metals backed'.

**Nolan Knight aka Nolan Thomas Newberry single-handedly set up the gathering and single-handedly promoted the opportunity** for this during the time the house gathering at my sister Deby Mattsen' home. The date of this occurred in mid-April of 2020. I believe that it was approximately April 15th through the 20th of April in 2020. Since then, I have not seen or heard from Nolan Knight aka Nolan Thomas Newberry since then. Nolan Knight took \$ \_specific deposits from myself and our community of people \_00 in the form of \_funds provided\_ and Nolan Knight, while at the house the gathering occurred at [ protected eye witness ] which is a Phoenix homeowner where Nolan Knight; provided us w Western Minerals & Ores Corporation share unit certificates, but he did not sign the certificates. They were blank.

There were absolutely no signatures on the share units that Nolan Knight had obviously stolen from the Company and utilized to represent and unlawfully take funds with. Nolan Knight also did not provide any of the extensive required paperwork to validate the particulars of that type of any exchange. It is now in the first week of June 2024 and I'm responding to a visit with me by an agent of the owners of the mineral ores company. I provide this the above statement and related information and facts, for the record, as 100% true and correct."

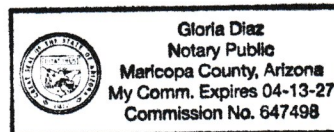
