

FAQs

1) Who can participate in this summer camp?

- ✓ Any Open to students aged 5-12 years who are passionate about learning Art & Craft.
- ✓ Participation is strictly limited to registered students only.
- ✓ Students who have not completed the registration fee payment will not be allowed to join the Summer Camp.
- ✓ This is a fun-filled and engaging activity designed especially for kids.
- ✓ All classes will be conducted online via Zoom or Google Meet or MS Teams.

2) What will I learn (Indicative. The list may vary as per the choice of faculty)?

- ✓ Drawing and Coloring.
- ✓ Making Clay at home and Crafts with clay.
- ✓ Glass painting.
- ✓ Doodling.
- ✓ Paper Quilling.
- ✓ Dot Art
- ✓ Glue Resist
- ✓ Use of Soft Pastels
- ✓ Use of Watercolor
- ✓ Use of Oil Pastels / Crayons/ Sketching

3) Will I be provided with the art materials to do the classes?

- ✓ No. However, the list of required material will be sent via e-mail before the start of the summer camp or after successful registration.

4) Do I have to separately register for these activities?

- ✓ No, all the above are included in the Art and Craft summer camp.

5) What are the various session timings for the art and craft classes?

Timings as per Indian Standard Time (IST)

Batch: Friday (Craft): 5.30 pm to 7 pm; Saturday (Drawing): 11 am to 12 noon

Timings as per Dubai Time

Batch: Friday (Craft) - 4 pm to 5.30 pm; Saturday (Drawing) - 9.30 am to 10.30 am

The above is an indicative timing. Any changes to the above will be informed to you via email.

A total of 8 days in a month will be the learning time.

6) When does the summer camp begin?

✓ The Summer Camp will run whenever a batch is created. The first batch runs from Beginning of May to end of May. Other batches: Beginning of June to end of June, Beginning of July to end of July, 2026.

7) What will be the batch size?

✓ A typical batch will be 8-12 students at max, depending on the number of registrations received. We will try to optimize it to the best so that each student can get personal attention from the trainer.

8) What is the cost of the complete course?

✓ **For Indian Resident Student:**

○ Art and Craft Course: Rs. 1500 per participant

✓ **For International Students:**

○ Art Course: AED 150 / USD 50 / Euro 50 per participant


10) Is there a dress code?

✓ There is no dress code. Participants can wear any comfortable outfit of their choice.

11) Who do I contact for any query or clarification?

✓ You can send us an email with your query on schoolalerts.helpdesk@gmail.com and we will try to revert within 48 hours from the receipt of your query.

12) In case of absenteeism, can I get a complimentary class?



✓ No. However, each session will be recorded, and the recording will be uploaded on social media. The link to the recording will be shared with the absentees so that they can consume it at their leisure. The recording will be available only for a limited timeframe.

✓ In case there are any parallel sessions with the same content, we will try to accommodate you for the missed session. But it is non-committal and only if there are available seats.

13) Are there any prizes for work submission / assignments?

✓ Yes. The participant/s who have submitted their work/assignments regularly and the best of out the received ones, will be awarded at the end of the sessions. Best Craft-maker and Best Artist (Drawing) will be awarded. There may be a greater number of prizes (at the discretion of the trainers). E-Certificates will be awarded.

14) Can I continue with regular classes if I wish to continue learning?


✓ Yes, you can discuss with the faculty and continue with our regular monthly classes.

15) I have attended previous Art & Craft Summer Camp sessions. Will the subject items to be taught in Summer Camps be different than the ones learnt in earlier sessions?

✓ Yes, if you have participated in our previous seasons of Summer Camp, the items to be taught will be totally different than the ones learnt earlier.

Rules and Regulation

- 1) Schoolalerts is organizing these activities with Experts who are associated with us. The faculties will be provided by the Schoolalerts.
- 2) By registering for the course, the students, and parents pledge to participate in the fairest manner and assure not to adopt any malpractices or unfair means.
- 3) Only paid registrants can take up the course and no siblings or parents will be allowed. Participant can login only from one device. Login from more than one device is not allowed. Participants are requested to check their audio and video before the session timings and not during the session.
- 4) The participant indemnifies Schoolalerts Solutions Pvt. Ltd., its directors and employees of any direct or indirect losses which may arise or be incurred by the student during participation or course of the event.
- 5) Any cost involved in transportation, purchase, repair, internet connectivity, etc. will have to be borne by the participant. Schoolalerts will not be responsible for any additional cost incurred by the student for participating in the summer camp.
- 6) The course fee once paid is non-refundable.
- 7) Only in case of medical exigencies and upon production of necessary documents, the fees will be refunded after necessary adjustments depending on the number of classes attended. A Cancellation fees of Rs. 500 or equivalent in other currency will be deducted from the refund. For example, if a participant has completed two sessions and then applies for cancellation, the amount deductible will be Rs. 750 or equivalent in other currencies. (Rs. 125 x 2 completed session + Cancellation Fee of Rs. 500). An application in written with necessary supporting should be emailed to us at schoolalerts.helpdesk@gmail.com.
- 8) No refund or cancellation request will be entertained in case of any absenteeism or reason except for Medical.
- 9) Post the start of the course, the timings may be decided by the instructor and students, mutually, depending on their comfort. Else, the timings given by us and selected by the participant while registering will stand as-is for your session.
- 10) Schoolalerts take no responsibility in case any of the details provided in the registration form by the participant / student / parent is fake, non-operational, or wrong.
- 11) The participant always agrees to abide by all rules and regulations of Schoolalerts.
- 12) Any assignment given needs to be submitted in PDF/JPEG format within the time limit specified by the Instructor / Teacher / Moderator.
- 13) In case of network issue or absenteeism at participant's end, the Instructor / Teacher / Moderator will wait for a few mins and then go ahead with the session. Such participants can go through the recorded session at leisure.



14) Limitation of Liability: Any claim whatsoever, direct, or indirect, will be limited to the registration fees paid by the participant. Schoolalerts liability will be restricted to the registration fee received from the participant only. No other claims will be entertained.

16) Force Majeure: In case of any unforeseen circumstances or Force Majeure, Schoolalerts will take necessary step which may include re-scheduling, change of dates, medium, process, policy, etc. and the same will be informed to the participant as and when required.
