

# Your Human Rights

They are Universal. Adopted by the General Assembly of the United Nations in 1948, the Universal Declaration states fundamental rights and freedoms to which all human beings are entitled.

**Article 13.1:** Everyone has the right to freedom of movement and residence within the borders of each state.

**Article 13.2:** Everyone has the right to leave any country, including his own, and to return to his country

**Travel BANNED**

**Article 18:** Everyone has the right to freedom of thought, conscience and religion; this right includes freedom to change his religion or belief, and freedom, either alone or in community with others and in public or private, to manifest his religion or belief in teaching, practice, worship and observance.

**Churches CLOSED**

**Article 19:** Everyone has the right to freedom of opinion and expression; this right includes freedom to hold opinions without interference and to seek, receive and impart information and ideas through any media and regardless of frontiers.

**Worldwide CENSORSHIP**

**Article 20.1:** Everyone has the right to freedom of peaceful assembly and association.

**Protests BANNED**

**Article 23.1:** Everyone has the right to work, to free choice of employment, to just and favourable conditions of work and to protection against unemployment.

**Article 23.2:** Everyone, without any discrimination, has the right to equal pay for equal work.

**Small businesses CLOSED**

**Article 26:** Everyone has the right to education.

**Schools CLOSED**

Whereas it is essential, if man is not to be compelled to have recourse, as a last resort, to rebellion against tyranny and oppression, that human rights should be protected by the rule of law.

# How were your RIGHTS taken away?

On March the 16th 2020, our rights were taken away under the Coronavirus Act 2020 and the Public Health Act 1984. They have yet to be restored. The UK is on the precipice of the biggest Human Rights disaster in half a century. The prospect of health passports could see segregation imposed throughout the population. The consequences of the health passport would be to create a discriminatory two-tier society, in which the poorest and most disadvantaged, will be denied basic social and economic opportunities as well as restricted civil liberties. Fundamental Human Rights are inalienable and are given at birth, they must not be subject to any government demands or conditions.

## Coronavirus Act 2020

**Schedule 21** gives arbitrary powers to the police, immigration officers and public health officials to detain “potentially infectious” members of the public, including children, potentially indefinitely, in unidentified isolation facilities.

**Schedule 22** gives Ministers the power to single-handedly ban any type of gathering, including protests, vigils and political assemblies.
