Re: COVID19 Vaccine Passports

I write to you, in your capacity as my local Member of Parliament and representative to the UK Government, in order to formally request and implore you to oppose the introduction of vaccine passports and any other form of coercion to accept vaccination against one's beliefs and wishes, and oppose discrimination against people who elect not to be vaccinated.

I am extremely concerned for the future health and freedom of both myself and the citizens of this country in general, in view of the current Government plan to introduce and encourage the use of vaccine passports in the UK. This plan is completely unjustified by the relevant vaccine performance and disease data and clearly constitutes government-mandated coercion to accept medical treatment which is in breach of UK Law and international human rights treaties, in particular, the Public Health (Control of Disease) Act 1984, paragraph 45E Medical treatment states that, in relation to health regulations set out in paragraphs 45B & 45C:

- 1. Regulations under section 45B or 45C may not include provision requiring a person to undergo medical treatment.
- 2. " Medical treatment " includes vaccination and other prophylactic treatment.
