To the men and women of the WHO (World Health Organisation), all concerned parties pertaining to contents of the Proposed Pandemic Preparedness Treaty.

A clause must be included that states:

Under no circumstances shall the WHO or any Health Security Agency of Nation States have the authority to impose any health measures whatsoever that breach the International Human Rights Laws established by The Nuremburg Code and all Unalienable Rights in Natural Law must be protected on pain that a breach of this edict will render the entire WHO Pandemic Treaty invalid.

The WHO Pandemic Treaty must include total adherence to moral and ethical laws and Unalienable Rights*** above all other instructions, mandates, directives or advices. Avoidable harms such as lockdown measures must be excluded for the following reasons;

- The primary cause of deaths and harms ongoing of men, women and children since the covid-19 pandemic began as irrefutably established by the worldwide consensus of expert witnesses, is government overreach and misappropriation of control by coercion and force, not the virus purported to cause the disease known as covid-19.
- People have been terrorised by false information such as the asymptomatic spread myth, the unfit for purpose false positive generating PCR tests and alarmingly high death rates which bear no resemblance to the actual low death rate from covid-19 alone when extracted from deaths caused by co morbidities. This is undisputed by governments and WHO.
- Catastrophic mistakes have been made by governments and individual living men and women not because of any lack of control measures but intrinsically because those measures have been implemented based on a complete misunderstanding of

the real world actual severity of covid-19, (not mathematical models) which now reveal the disease to be much less deadly than predicted and more akin to seasonal flu than a Great Plague.

- Misappropriation of deaths on a colossal scale worldwide falsely attributed to covid-19 has astronomically inflated the death statistics, exacerbated the collective fear and generated an authoritarian tyrannical approach to individual rights and freedoms that has done more harm than good, and will be felt for generations to come while we learn to live with the disease.
- Since covid-19 has been proven beyond any doubt by a world wide consensus of highly reputable epidemiologists, scientists and medical doctors to be highly preventable and treatable* without the need for damaging government measures or dangerous experimental vaccines** across all ages; locking down living men women and children into their homes, preventing and restricting travel, destroying businesses and damaging families and communities which depend for their wellbeing on interconnectedness that can only come from close contact is not only unnecessary but unlawful under International Natural Law which is sacrasanct.
- Therefore it is imperative that this treaty include legally binding measures to prevent such harms. A clause must be included that states: Under no circumstances shall the WHO, National Health Security Agencies of Nation States or any other overseeing agency have the authority to impose any health measures that breach the International Human Rights Laws established by The Nuremburg Code and all Unalienable Rights must be protected.
- Covid-19 injections (mRNA gene therapies) must not be mandated due to the following facts emerging since the Pfizer was forced by Supreme court to release their trial safety and effectiveness data which is damning.

The Original, Permanent, Unalienable Rights of every Man or Woman, include:

- The Right to Life, Freedom, Health and the Pursuit of Happiness
- The Right to Contract, or Not to Contract, which is Unlimited
- The Right to Earn a Living Income by being Compensated with Wages or a Salary in a Fair Exchange for one's Work
- The Right to Travel in the Ordinary Course of one's Life and Business
- The Right to Privacy and Confidentiality, free from Unwarranted Invasion
- The Right to Own, and Hold Property, Lawfully without Trespass
- The Right to Self-Defence when threatened with Harm, Loss or Deceit
- The Right to Due Process of Law, with Notice and Opportunity to Defend
- The Right to be Presumed Innocent, suffering No Detention or Arrest, No Search or Seizure, without Reasonable Cause
- The Right to Remain Silent when accused, to avoid Self-Incrimination
- The Right to Equality in the eyes of the Law, and to Equal Representation
- The Right to Trial by Jury, being an Impartial Panel of one's Peers
- The Right to Appeal in Law against Conviction or Sentence, or both
- The Right to Expose Knowledge necessary to one's Rights and Freedoms
- The Right to Peaceful Association, Assembly, Expression, and Protest
- The Right to Practice a Religion, and to have Beliefs, of one's choosing
- The Right to Love, and to Consensual Marriage with Children, as a Family
- The Right to Security from Abuse, Persecution, Tyranny, and War
- The Right to Refuse to Kill under command, by reason of Conscience
- The Right to Live in Peace and be left alone when Law-Abiding

If the WHO cannot prevent further deaths and injuries from medical interventions such as experimental covid-19 injections, you have no authority to impose mandates of any kind or conduct any leadership to direct or dictate governments and nation states to use them.
