The Universal Declaration on Bioethics and Human Rights

Article 6: Consent

1. Any preventive, diagnostic and therapeutic medical intervention is only to be carried out with the prior, free and informed consent of the person concerned, based on adequate information. The consent should, where appropriate, be express and may be withdrawn by the person concerned at any time and for any reason without disadvantage or prejudice.

Vaccinations are NOT mandatory in the UK. It is therefore within my rights to refuse the Pfizer Covid19 vaccine. This is a rushed vaccine, untested properly on animals, and it has been reported that mice and ferrets died in long-term vaccine trials.

The Federal Drug Administration in the USA says the vaccine is expected to cause the following serious morbidities/mortalities: i) Guillan-Barre syndrome; ii) acute disseminate encephalomyelitis; iii) encephalitis; iv) convulsions/seizures; v) stroke; vi) narcolepsy; vii) anaphylaxis; viii) acute myocardial infection; ix) pericarditis/myocarditis; x) autoimmune disease; xi) deaths; xii) pregnancy and birth outcomes; xiii) acute demyelinating diseases; xiv) non-anaphylactic reactions; xv) thrombocytopenia; xv) disseminated intravascular coagulation; xvi) venous thromboembolism; and xvii) arthritis and arthralgia joint pain.

European scientists have demanded that the European Medicines Agency (EMA) immediately call a halt to all Covid19 vaccination and current ongoing phase 3 trials as the vaccine components will cause significant morbidity and mortality through: i) hyperinflammatory response; ii) a cytokine storm; iii) dysregulation of the immune system; iv) deadly reactions to the vaccines polyethylene glycol.
