### 306 Pharmacy Services Associate II

**Experienced Para-Professional** 

Responsible for support functions for a mail order pharmacy operation. Works with the Auto Packer and fulfills over the counter orders, ability to use the bar code machine, e-mail, file room software, and other support system work. Researches problem orders, handles member/plan correspondence, works rejects, overrides and basic claims issues, along with working multiple source systems, or Mainframes. Requires a High School diploma or GED; 1-3 years of related experience; or any combination of education and experience, which would provide an equivalent background.

Responsible for complex support functions for a mail order pharmacy operation. Primary duties functions of the Pharmacy Svc's Assoc II. **Management** 

Responsible for the interpretation and data entry of prescriptions. Enters data of prescription orders and validates member information on member prescription requests. May stock, dispense or package medication for review by pharmacist. May maintain, order, receive, and stock drug inventory. May be required to contact physician offices for clarification, etc. Requires High School diploma or equivalent and up to 1 year of pharmacy experience, or any combination of education and experience, which would provide an equivalent background. State Tech-in-Training certificate may be required in applicable state(s). Must obtain State Pharmacy Tech certification within 6 months.

## 506 Certified Pharmacy Technician II

**Experienced Para-Professional** 

Responsible for the interpretation and data entry of moderately complex prescriptions. Resolves issues of prescription orders ensuring timely and accurate claim processing using multiple source systems. Dispenses and packages prescription drugs for review by RPH. May be required to contact physician offices for clarification, etc. Provides feedback to pharmacy technicians' areas for improvement. High School diploma required. Some college preferred, and up to 2 years of pharmacy experience, or any combination of education and experience, which would provide an equivalent background. Requires current State Pharmacy Tech. Certification or National Certification based on applicable state(s) requirements.

### 507 Certified Pharmacy Technician III

Senior Para-Professional

Responsible for the interpretation and resolution of complex issues allowing for timely and accurate deliveries. Resolves exceptions to the order flow process using appropriate systems and validates member information on member prescription orders. Enters data of prescription orders and may contact physician offices for clarification. Monitors, tracks, resolves, and reports daily shipments using UPS internet based tools. May stock, dispense or package medication. Requires High School diploma or equivalent and 3+ years of retail or managed care experience, or any combination of education and experience, which would provide an equivalent background. Requires current State Pharmacy Tech. Certification or National Certification based on applicable state(s) requirements.

#### 510 Clinical Pharmacy CSR I

**Entry Para-Professional** 

Responsible for providing customer assistance to members and physician offices in addition to entering prescriptions and assisting with the fulfillment of orders. May be working in a call center environment handling inbound calls and some follow up calls. Answers calls and questions on prior authorization, general questions and some confidential information. Responds to member and physician inquiries regarding pharmacy benefits. Confirms member orders via phone and coordinates delivery of product. Reads physician prescriptions and enters orders to ensure proper medication and dosing. High school diploma or equivalent required. Entry position with prior customer service or prescription processing preferred. Certified Pharmacy Technician preferred.

#### 511 Clinical Pharmacy CSR II

**Experienced Para-Professional**
