

Officers have attended this training representing over **1,239** Law Enforcement agencies in 41 states and 8 federal agencies including DOD (JSOC) and over a hundred community corrections/probation agencies including U.S. Probation, in addition to various mental health personnel including child protection and prosecutors. Approximately **5,154** officers and approximately **1,000** mental health professionals (CPS, CAC) and prosecutors have attended this training since 2001. The training has been held in 35 states.
