1 This matter came on regularly before the Court for hearing on May 7, 2025, before the Hon.  
2 Elihu Berle, in Department 6 of the above-entitled Court. Shaun Martin appeared for Plaintiff Younes  
3 Younes.

4 Having reviewed the moving and opposing papers on Plaintiff's Motion for Certification of  
5 Class Action; and oral argument of counsel having been received by the Court, the Court finds,  
6 adjudges and orders as follows:

- 7 1. There is an ascertainable class composed of all persons whose property was  
8 converted by Defendants using fake online platforms and then routed and  
9 deposited at the OKX and Binance Deposit addresses set forth in Paragraph 22  
10 of the Complaint in this action.
- 11 2. It is not practicable to bring all members of that ascertainable class before the  
12 Court.
- 13 3. The questions of law or fact common to the claims of the ascertainable class are  
14 substantially similar to, and predominate over questions that affect each  
15 individual person of the class.
- 16 4. The claims of the plaintiff named above are typical of the claims or defenses of  
17 the ascertainable class.
- 18 5. The plaintiff named above will fairly and adequately protect the interests of the  
19 class.

20 **IT IS THEREFORE ORDERED THAT** the motion of Plaintiffs for an order certifying the  
21 class in the above-entitled action is GRANTED.

22 It is further ordered that:

- 23 1. The above-entitled action is certified as a class action and will proceed as a class  
24 action.
- 25 2. Plaintiff Younes Younes is certified as the representatives of the class.
- 26 3. The named plaintiffs' counsel, Shaun P. Martin and DTO Law, are certified as  
27 counsel for the class.
