IF YOU WISH TO PRESENT AFFIDAVIT OR OTHER DOCUMENTARY EVIDENCE TO THE COURT OR TO EXAMINE OR CROSS-EXAMINE WITNESSES ON THE APPLICATION, you or your lawyer must, in addition to serving your Notice of Appearance, serve a copy of the evidence on the Applicant's lawyer or, where the Applicant does not have a lawyer, serve it on the Applicant, and file it, with proof

of service, in the office of the Divisional Court where the application is to be heard as soon as possible, but at least four days before the hearing.

APPLICATION

- 1. The applicant makes application for:
 - (a) A declaration that the decision of the Ministry of the Environment, Conservation and Parks dated August 31, 2021, to move forward with the demolition of the MacDonald and Hyatt Houses at Sandbanks Provincial Park, is of no force and effect;
 - (b) A stay of the decision of the Ministry of the Environment, Conservation and Parks dated August 31, 2021 to demolish the MacDonald and Hyatt Houses at Sandbanks Provincial Park for 3 months, during which time the respondents are directed to:
 - (i) seek proposals for adaptive re-use of the houses as an alternative to demolition, as required under the Standards and Guidelines for Conservation of Provincial Heritage Properties, with oversight from the Ministry of Heritage, Sport, Tourism and Culture Industries in consultation with Municipal officials and the community; and
 - (ii) conduct a compliance review, as required under the Standards and Guidelines for the Conservation of Provincial Heritage Properties, including consulting with relevant stakeholders such as the applicant, the Prince Edward County Heritage Advisory Committee, the Architectural Conservancy of Ontario and other interested members of the public;
 - (c) The applicant's costs of this application on a substantial indemnity basis; and
 - (d) Such further and other relief as counsel may advise and this Honourable Court may permit.

2. THE GROUNDS FOR THE APPLICATION ARE:

- (a) The Standards and Guidelines for Conservation of Provincial Heritage Properties (the "Provincial Standards and Guidelines") require all Ministries and public bodies that have been prescribed by Regulation to identify, protect and care for provincial heritage properties they own and manage;
- (b) The Ministry of Heritage, Sport, Tourism and Culture Industries (the "MHSTCI") is responsible for administering the Provincial Standards and Guidelines. The Provincial Standards and Guidelines are prescribed by Regulation to apply to the MHSTCI, and to the Ministry of the Environment, Conservation and Parks (the "MECP"). The MECP owns the MacDonald and Hyatt Houses at Sandbanks Provincial Park. Therefore, the Provincial Standards and Guidelines apply to MHSTCI, MECP and the MacDonald and Hyatt Houses;
- (c) The responsibilities of MHSTCI include interpreting and communicating the Provincial Standards and Guidelines to the MECP, as well as monitoring and reviewing compliance by the MECP with the Provincial Standards and Guidelines;
- (d) The MHSTCI's monitoring and reviewing for compliance in this case has been limited. By February 6, 2020, MHSTCI absolved itself of these responsibilities, notwithstanding the fact that numerous submissions and activities have occurred since then. Further, specific requests to MHSTCI to fulfill these responsibilities have not been responded to;
- (e) Amongst these responsibilities, the Provincial Standards and Guidelines require best efforts to be made to preserve, reuse or readapt buildings;
- (f) On May 28, 2021, Ontario Parks (where the MacDonald and Hyatt Houses are located) announced a new policy to seek innovative ideas and proposals from the private and not-for-profit sectors for new recreation experiences at provincial parks, such as could be facilitated

and achieved by the preservation, reuse or re-adaptation of buildings such as the MacDonald and Hyatt Houses (recreation being defined by the Province's Ontario Trillium Fund as "Physical activities engaged in for the purpose of health, well-being or enjoyment with the primary focus on human activity.");

- (g) MECP has had more than three (3) months to consider how the new May 28, 2021 program offers an alternative to demolition, as required by the Provincial Standards and Guidelines. However, there is no evidence that MECP has considered this alternative;
- (h) demolition of the MacDonald and Hyatt Houses appears to be imminent;
- (i) there are serious issues to be tried;
- (j) the harm of demolition will be irreparable and the balance of convenience clearly favours granting a stay;
- (k) Sections 4 and 6(2) of the Judicial Review Procedure Act, R.S.O. 1990, J.1; and
- (l) Rules 40 and 68 of the Rules of Civil Procedure, R.R.O 1990, Reg. 194.
