### **UNFINSHED BUSINESS:**

- 1. Irrigation pipeline issue at Grangeville 6.5-acre farmland. Roger is still in the process of getting a bid to repair the pipeline. Talked to Roger on April 15. Waiting for a response from Roger.
- 2. Sunflower Niche. It was decided to contact Lee and Associates and find the cost to draw up plans for the niche area.
- 3. Update on Ethics Training. BBK has online on-demand for \$75/ person and In-person is \$2000. CSDA has a webinar in October for \$125/ person.
- 4. Groundwater Sustainability forms. All Lemoore and Sunflower wells have been registered with South Fork GSA. Mid Kings GSA will not be ready for well registration until the end of the year.
- 5. Sunflower Wells. Three of the wells have been completed and are pumping good. Lemoore is responsible for well 1 and 2 and Lessee is responsible for number 3.

#### **NEW BUSINESS:**

- 1 Maintenance report. Preparing for Memorial Day. Starting to hedge Oleanders, Bottle Brush and canopy the elm trees. We are edging and string trimming, setting monuments and have finished fertilizing. Taylor Cemetery has been weeded and pre-emergent has been put down. We will put up flags and ribbons for Memorial Day.
- 2 Preparing 2025-26 Budget. Discuss Prices, Niche, Irrigation system, Phone lines. Discuss adding 13 pre-buried vaults in section 6. Consider a contract for the District Manager.
- 3 Burials for April 2025: Lemoore 10, Grangeville 7, Sunflower Fields 6, **Total burials 23.** (9 were cremations).
- 4 Income for April 2025: Endowment Care \$7,060.00, Usable Income \$64,705.00, Non-usable Income \$20,440.00. Total deposits were \$92,205.00.
