

Subscription Offerings

Pay as you go plan: Our pay as you go plan allows you to sign up for free and purchase evaluations on demand. Evaluations purchased never expire and there are no contracts or monthly fees. These accounts are only available for Behavioral Health Providers that perform less than 1,000 assessments annually and using our cloud services. Payers, Governments, 3rd Party providers, and integrations are not eligible for the pay as you go plan.

Corporate Plan: Our corporate plans are for organizations that will be performing 1,000 or more evaluations annually or require features only offered on corporate accounts. Corporate accounts require a minimum 1yr agreement. The grid below provides an overview of the features provided for each plan.

Feature Descriptions:

Training:

Training is provided live via 3 hour GotoTraining sessions. The training covers the tool itself including the 7 dimensions, levels of care, as well as how to apply the tool.

Sub Accounts: If your organization has multiple staff performing assessments Deerfield can setup your account as a parent account. This will allow you to create sub-accounts for all your evaluators. You can setup both shared and individual accounts. You can also apply a security policy to them to control login attempts, lockouts, timeouts, etc. Sub-Account functionality must be enabled by Deerfield.

Custom Security Settings: LOCUS Online supports custom security settings. These are based on Windows active directory domain standards and include the ability to enforce password complexity, password reuse, login attempt failures, account lockout thresholds and more.

Custom Data Entry Settings: LOCUS Online allows for the entry of Patient Identifiers and other data into free text fields. Depending on your organizations data security practices you may want to opt out of entering this data. These fields can be disabled for corporate accounts when necessary.

Custom Privacy/EULA Contracts: Users of LOCUS online must adhere to our End User License Agreement (EULA) and our Privacy policy. If our EULA or Privacy policy won't work for your organization, Deerfield will work with you organization to tailor an agreement that is mutually acceptable. This is only offered to corporate accounts.

Data Export Capabilities: LOCUS Online provides the ability to bulk download assessment data for import into your Electronic Records System / Care Package for further reporting and data analysis. This functionality is only available for corporate accounts.

Content Licensing for Insurers/MCO's: For organizations that are required to provide LOCUS content to their providers and/or patients in the form of the tool itself or portions of the tool for use with patient/provider communication this licensing is included with your corporate account.

Transparency Portal: LOCUS Online provides the ability for insurers/MCO's to share the LOCUS tool and documentation with providers and patients via a special web portal login that is managed via their LOCUS online admin account. The portal provides an easy mechanism for ensuring patients and providers can easily access the latest version of the tool. This portal also allows for patients and providers to perform an actual LOCUS assessment and view the results.

Integrations / API: For organizations looking to integrate LOCUS/CALOCUS into their EHR or other electronic systems a corporate plan is required. Corporate plans include licensing to duplicate the tools or use Deerfield's API. All integrations require certification from Deerfield and must meet Deerfield's General Acceptability Guidelines.
