- Thomas Excavating = \$34,500

• Review and Discussion of Public Bids

The Board reviewed each bid, noting that Thomas Excavating was the lowest.

Thomas pointed out that he does have a bid bond, through West Bend Insurance, will be doing this work with John Prah, and can start the job any time. He pointed out he would prefer to start now, versus waiting till May 1st, as he has other projects coming up. Kautza stated he could start tomorrow, if he liked.
