Right-of-Way Excavation and Overweight/Oversize Permits (Contact Chairman, Tony Kautza, at 715-610-1655):

The Town does not charge for these permits, but do require permits be approved by the Town Chairman, prior to any work taking place.

Birnamwood Area Emergency Services (BAES) - Fire and Rescue Calls:

Per the contract between the Town and BAES, any charges for Fire and Rescue Calls will be billed to the Town. The Town will then invoice the responsible party for those costs incurred for the private incident.

Zoning/Building Permits:

The Town of Plover falls under Marathon County Zoning Rules and Regulations, and the Town does not issue any building permits.

For any building project 101 square feet and over, a Zoning Permit from Marathon County Conservation, Planning, & Zoning (CPZ) is required.
