**RESOLUTION FOR ELECTORS TO ADOPT THE TOTAL TOWN TAX LEVY
AT SPECIAL TOWN MEETING OF TOWN ELECTORS**

Resolution No. 10.01-2023

Whereas, Wis. Stat. § 60.10(1)(a) authorizes the Town Electors of a Town to adopt the Town Tax Levy at a Town Meeting of the Electors;

Whereas, a Special Town Meeting of the Town Electors has been called and properly noticed to approve the 2023 Total Town Tax Levy (to be collected in 2024), pursuant to Wis. Stat. § 60.10(1)(a);

THEREFORE, the Special Town Meeting of the Town of Plover, Marathon County, Wisconsin, by a majority vote of the eligible electors duly assembled and voting on this 10th day of October, 2023, hereby resolves and orders as follows:


1. The Town Electors of the Town of Plover, Marathon County, Wisconsin, adopt the Total Town Tax Levy for 2023 (to be collected in 2024) in the amount of \$250,289.00.
2. The Town Clerk shall properly post or publish this resolution as required by law under Wis. Stat. § 60.80(1)(a) within 30 days after its adoption.
