Steve Thompson, N11251 County Road Z (Village of Aniwa), who runs the Hogarty Church, at 179705 State Highway 52, briefly walked in to the meeting to make his comment on the Gunderson Conditional Use Permit request (discussed at the 6:00 p.m. Town Board Meeting). He stated he has no issues with the shipping containers on that property. He commented that a previous employee with the County had told Gunderson the containers were okay. Kautza commented on how things have changed with the County Zoning and how because Gunderson is under a certain amount of acres, in order for him to keep his shipping containers, he needs to obtain the Conditional Use Request. Thompson agreed that the containers allow Gunderson a place to store his outdoor belongings, in order to keep his property clean.
