School Fees and payments 2025

Dear Parent/s

This letter is to notify you of the fee structure for 2025. Please note that all parents must complete the attached fee form indicating which method of payment you would prefer in 2025.

Parents are either billed monthly over 12 months or can choose to pay annually in advance and take advantage of a 5% discount, if the annual fees are paid by the 28th February 2025.

Monthly fees are payable in advance at the beginning of each month by no later than the 7th

Kindly take note that a 2.5% late payment fee will be charged for fees paid later than the 7th of each month if arrangements has not been made with the office prior to the cut-off date.

Registration Fee:

There is a once off registration fee for new children. As from the 1st January 2025 Namibian taxpayers will pay N\$5,000.00. Non-Namibian taxpayers will pay N\$ 10,000.00. **The payment of this fee secures a place for your child upon payment and is not refundable.**

Fees Tables:

As of January 2025, we will have two fee tables.
