TERMS AND CONDITIONS
1. We reserve the right of admission and the right to request a parent to remove a child from Fowler House International High School, should we consider this to be in the best interest of the parties involved.
2. Fowler House International High School is a non-denominational English Medium School.
3. School fees are payable on or before the 25th of the month. Fees paid after the 5th will be subject to a late fee penalty of 5%. Should fees be outstanding for 2 or more months the child may be suspended from school and the account will be handed over to our attorney for collection. Refunds are not made for cancellation of application, absence due to illness or holiday.
4. Fees are calculated on an annual basis and charged monthly over a period of 12 months (January – December).
5. Two months' notice, in writing, is required before removing your child from our school, or payment in lieu thereof will be required.
6. Under no circumstances shall registration fees paid to the school be refunded or applied toward outstanding school fees. All registration fees are strictly non-refundable.
