

## RELEASE, WAIVER, AND INDEMNIFICATION

I, \_\_\_\_\_, in consideration of being permitted to participate in the OCTOBER 12, 2019 UF-LSU FOOTBALL BUS TRIP (“Event”) in NEW ORLEANS, LOUISIANA and BATON ROUGE, LOUISIANA (“Location”) offered by the NEW ORLEANS GATORS ALUMNI CLUB (“Club”) do hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the New Orleans Gators Alumni Club, University of Florida Foundation, Inc., the University of Florida Alumni Association, Inc. the University of Florida, the University of Florida Board of Trustees, Board of Governors of the State of Florida, and their respective current or former officers, servants, agents, or employees (individually and collectively, “Released Parties”), with regard to any and all liability, claims, demands, actions, and causes of action, or related to any loss, damage, or injury, including death, that may be sustained or incurred by me, or to any property belonging to me, during or as a result of my participation in the Event or any activities in connection with the Event, whether caused by the negligence of any of the Released Parties or otherwise.

I agree to indemnify the Released Parties from any loss, liability, damage or cost the Released Parties may incur due to my presence in or at the Event, whether caused by the negligence of the Released Parties or otherwise.

I assume full responsibility for and risk of bodily injury, death, or property damage due to the negligence of the Released Parties or otherwise while in or at the Event or while competing, officiating in, working, or for any other purpose participating in the Event. I acknowledge and understand that the Released Parties are not liable for any lost, stolen, damaged, and/or forgotten property before, during or after the Event. I further release the Released Parties from any claim whatsoever on account of first aid treatment or service rendered to me during participation in the Event.

I acknowledge, understand and agree that there shall be no refund made unto me for this Event by the Released Parties except in the case of the October 12, 2019 University of Florida vs. Louisiana State University football game being canceled or postponed for reasons beyond the Club’s control.

I acknowledge and understand that this Release must be submitted to the Club at least twenty-four (24) hours prior to the Event or I forfeit my spot for the Event and will not receive a refund. I further acknowledge and understand that one Release must be signed per participant.

I expressly agree that this Release, Waiver, and Indemnification (“Release”) is intended to be as broad and inclusive as permitted by the laws of the State of Florida and that if any portion of the agreement is held invalid, the balance will continue in full legal force and effect.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT:

1. I have read the foregoing Release and understand its significance. I am signing the Release voluntarily as my own free act and deed.
2. I am at least 18 years of age and fully competent (or a parent or guardian signing for a minor).

3. I execute this Release for full, adequate, and complete consideration, fully intending this Release to be binding on myself, my spouse, my family, and my heirs, assigns, and personal representatives.
