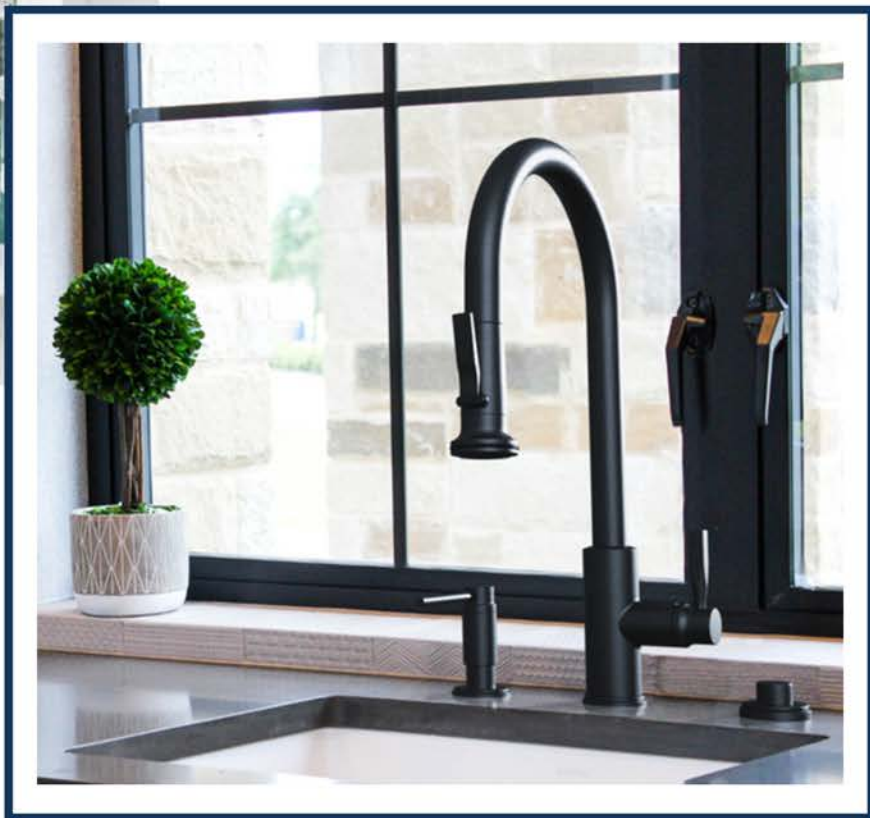

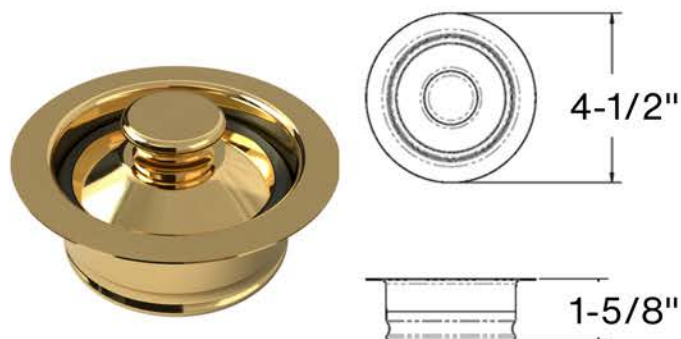

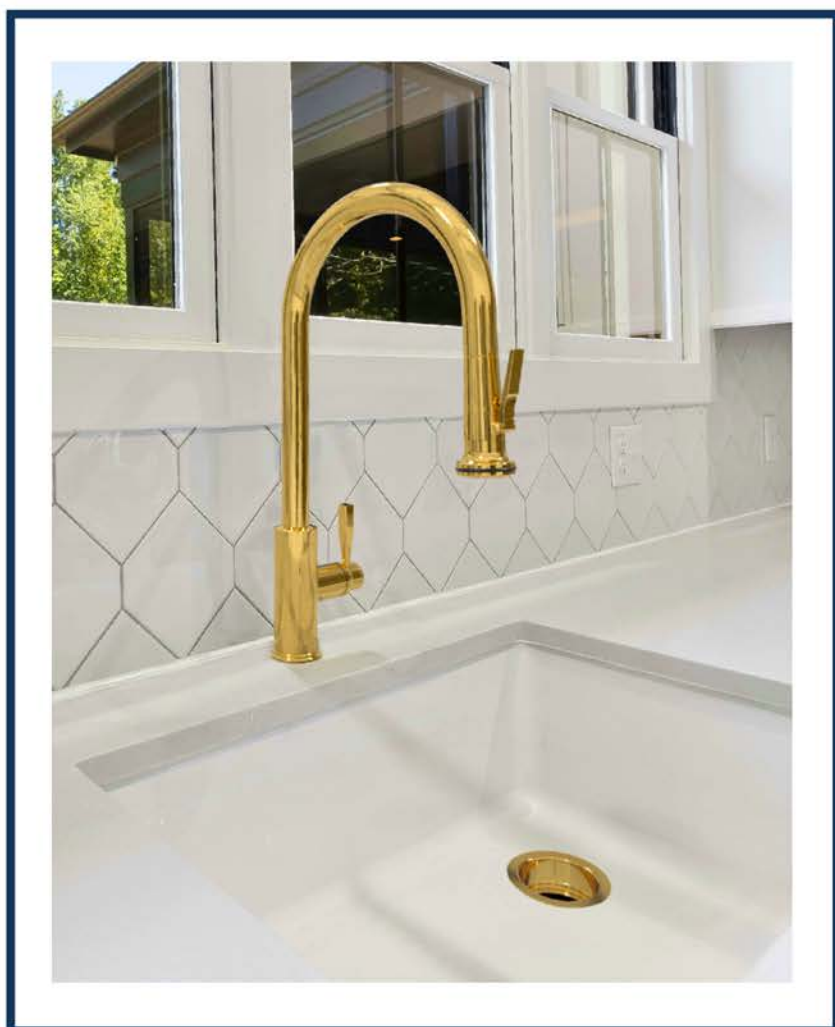

## FINISH WARRANTIES

---

For a warranty claim for finish, a valid dated bill of sale or receipt from purchase must accompany any warranty request. The warranty will be void for unintended use damage, lack of cleaning or improper cleaning and maintenance techniques directly resulting in a damaged finish.

**Aspect does not offer a warranty on any drain finish.** The finish warranties below are for faucets and accessories only.

### LIFETIME WARRANTY

Aspect carries a lifetime warranty on the following finishes:

### 7 YEAR WARRANTY

Aspect carries a 7 year warranty for the original purchaser from the date of sale. Warranty applies to normal wear for the following finishes:

*Chardonnay - CD*

*Matte Black - MB*

*Polished Nickel - PN*

*Satin Nickel – SN*

### NO WARRANTY

Aspect does not offer a warranty on living finishes. The rate of deterioration will vary either from exposure to chemicals, perspiration, climate conditions, or other factors. Tarnishing or excessive wear of these finishes is therefore, not a defect, but a normal process, which is unavoidable. Under these circumstances, products will not be repaired or replaced under warranty for normal tarnishing or wear finishes.

# ASPECT BY WATERSTONE CARE AND CLEANING GUIDE

**ATTENTION:** Aspect offers six finishes for its products. Every finish is unique and requires different techniques for care and cleaning. Find your product's finish in the sections below, and carefully read and follow directions for that finish.

## CLEAR PROTECTIVE COATED FINISH

*Chardonnay - CD*  
*Satin Nickel - SN*

### ABOUT YOUR FINISH:

These finishes have a clear protective coating on them. Even though they have a protective coating, they are only considered semi-durable. If the outside clear coating is scratched or damaged in any way, the base metal finishes exposed will oxidize. Always wipe your fixture down with a clean soft cloth and keep it clean and dry after use.

### CLEANING CAUTION:

Never use cleaners with bleach, abrasives, vinegar or acidic organic cleansers. Never use any type of abrasive pad, cloth or sponge. This can remove or dull the protective coating and damage the finish.

### IMPORTANT NOTICE:

It is the responsibility of the customer to check for any material finish defects **BEFORE** installation.

### SUGGESTED FINISH MAINTENANCE PROCEDURE:

1. Do not allow water spots to dry on fixture. Keep the surface area clean and dry after use.
2. Periodic cleaning can be done by using a mild diluted glass cleaner (we recommend Windex). Apply a mild cleaner to a soft clean cloth, and periodically wipe your fixture down to remove water spots and surface debris.

## LIVING FINISH

*Unlacquered Polished Brass - UPB*

### ABOUT YOUR FINISH:

These finishes are considered Living Finishes and have **NO PROTECTIVE COATING** on them. Living finishes are finishes that have a very shallow patina on their surface. Essentially, the finish is what nature would do to the surface over a long period of time. The finishes are intended to change with time and generally darken slightly where they are not being touched, and highlight where the high use points are on the fixture. These finishes are not durable, and are easily scratched or scuffed. Aspect initially applies a wax to the finish surface to help protect and prevent the finish from exposure to air and oxidizing prior to installation.

### CLEANING CAUTION:

Never use cleaners with bleach, abrasives, vinegar or acidic organic cleansers. In addition, hand oils, soaps, and acidic fluids can damage the finish. Never use any type of abrasive pad, cloth or sponge. This can remove, dull or damage the finish.

### SUGGESTED FINISH MAINTENANCE PROCEDURE:

1. Do not allow water spots to dry on the fixture. Keep the surface clean and dry after use.
2. Periodic cleaning can be done by using a micro-crystalline wax (we recommend Renaissance Wax). Apply the wax with a soft non-abrasive tissue paper, and gently buff the wax with a soft clean cloth to help remove surface spots and add a protective coating to the finish.

## POWDER COATED FINISH

*Matte Black - MB*

### ABOUT YOUR FINISH:

These finishes are powder coated color finishes. They have **NO ADDITIONAL PROTECTIVE COATING**. These finishes are not considered durable finishes and can be scratched, chipped or scuffed. If the exterior color coating is damaged, the exposed metal base will oxidize. Always wipe your fixture down with a clean soft cloth and keep it clean and dry after use.

### CLEANING CAUTION:

Never use cleaners with bleach, abrasives, vinegar or acidic organic cleansers. Never use any type of abrasive pad, cloth or sponge. This can remove, dull, or damage the finish.

### IMPORTANT NOTICE:

It is the responsibility of the customer to check for any material finish defects **BEFORE** installation.

### SUGGESTED FINISH MAINTENANCE PROCEDURE:

1. Do not allow water spots to dry on the fixture. Keep the surface clean and dry after use.
2. Periodic cleaning can be done by using a mild diluted glass cleaner (we recommend Windex). Apply a mild cleaner to a soft clean cloth, and periodically wipe your fixture down to remove water spots and surface debris.

## PLATED FINISH

*Chrome - CH*  
*Polished Nickel - PN*

### ABOUT YOUR FINISH:

Polished Nickel is one of the most durable finishes Waterstone offers. The best general maintenance is regular cleaning. Always try and keep your finishes clean and dry. Trapped moisture on the surface of your finish can lead to staining. Nickel plated finishes are very tarnish resistant. However, they will tarnish over time from hand oils and exposure if not regularly cleaned and polished. They are not indestructible and can be scratched and marred.

### CLEANING CAUTION:

Never use cleaners with bleach, abrasives, vinegar or acidic organic cleansers. Never use any type of abrasive pad, cloth or sponge. This can remove or dull the protective coating and damage the finish.

### IMPORTANT NOTICE:

It is the responsibility of the customer to check for any material finish defects **BEFORE** installation.

### SUGGESTED FINISH MAINTENANCE PROCEDURE:

**Cleaning Supplies:** isopropyl alcohol, Microfiber cloth

1. Do not allow water spots to dry on the fixture. Keep the surface clean and dry after use.
2. Periodic cleaning can be done by applying isopropyl alcohol with a soft clean cloth to gently remove surface spots.

### SUGGESTED PROCEDURE FOR CLOUDY, TARNISHED OR WATER SPOTTED FIXTURES:

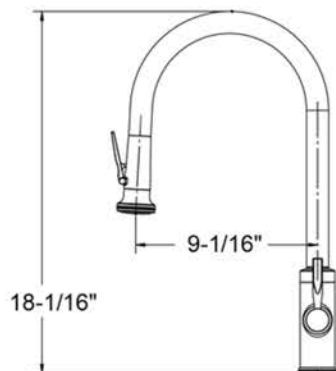
**Cleaning Supplies:** Simichrome polish, Microfiber cloth (2), (Optional: Flitz Faucet Wax)

1. Prepare the location by following the maintenance procedure listed above
2. In a well ventilated area apply a small amount of polish to the trouble spot on the faucet.
3. Using the microfiber cloth polish until cloth turns black or trouble spot is removed, take care to remove all excess polish.
4. Buff Surface with clean microfiber cloth to a brilliant luster.
5. (Optional) Using clean cloth apply Flitz faucet wax to all areas and let dry to a haze.
6. (Optional) Buff wax until haze is gone.

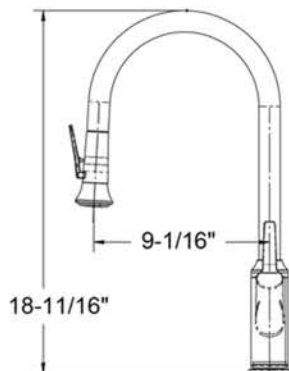

# POLICIES

---

This policy became effective on June 22nd, 2024, all distributors and dealers doing business with ASPECT BY WATERSTONE or "ASPECT" on and after that date are bound to the terms and conditions of this policy.

## TERMS AND CONDITIONS

ASPECT has established a Minimum Advertised Price (MAP) for all products. The Aspect MAP is calculated at .75 times (25%) off the current Aspect Retail List Price in effect. This means that the advertised "Net Price" to the end user (The Aspect Retail list price less all discounts, coupons, allowances, and free goods or services offered with Aspect Products) must not be below the current ASPECT MAP. ASPECT may engage in monitoring of advertised prices of product sales in all channels, whether directly or via the use of third parties. Third parties retained by ASPECT may engage in monitoring of product sales by distributors and dealers to verify that the terms of this policy are being upheld. ASPECT reserves the right to change the MAP on 30 days written notice.

The MAP policy applies to any and all advertisements and any quotes, bids, estimates, and invoices in media, including, but not limited to, inserts, newspapers, magazines, catalogs, public signage, billboards, and any other print media, television, radio, email, internet websites, or other commerce, flyers, posters, coupons, brochures, and use of hypertext transfer protocol or internal links to a web-based shopping cart and any other electronic media.

At no time may a distributor or dealer make any statements or other indication on any advertisements that a price below ASPECT'S MAP can be obtained by contacting the distributor or dealer, visiting the distributor or dealer showroom, clicking through to another price on a website, or any other means. A distributor or dealer may not use any ASPECT name(s), trademark(s), logo(s), patent(s), or product name(s) in a way that is not in accordance with this Policy or violates ASPECT'S MAP. This includes all product images, brand logos, and any and all copyrighted materials.

## VIOLATIONS

In the event that a distributor or dealer violates this policy:

**FIRST VIOLATION** – ASPECT will notify the offending distributor or dealer in writing of the violation. The distributor or dealer will have ten (10) calendar days to correct the violation of the MAP Policy and comply with ASPECT MAP.

If the distributor or dealer fails to correct the violation within the provided time, ASPECT will decrease the discounted price at which the distributor or dealer purchases ASPECT products by 10 percent for a period of ninety (90) calendar days. Additionally, ASPECT will remove the distributor or dealer from all links and listing on ASPECT'S website, and the distributor or dealer will be suspended from all sales programs offered to the distributor or dealer including but not limited to rebates, early pay incentives, freight programs, and sales incentives. If at the end of the 90-day suspension period the distributor or dealer has complied with the policy and not otherwise violated the MAP, then the distributor or dealer will be reinstated to full status, and the suspended distributor or dealer programs will be re-started.

However, if the distributor or dealer continues to be in violation of the MAP policy at the end of the ninety (90) day suspension period, it will be considered a second violation.

**SECOND VIOLATION** – At this time all pending orders will be immediately cancelled, and ASPECT will not accept any new orders. ASPECT will notify the distributor or dealer in writing and at its own discretion and without liability under any existing contracts or agreements, initiate the process to terminate the distributor or dealer authorization to sell ASPECT products.

## UMRP POLICY

At this time ASPECT does not have a UMRP but reserves the right to change this with 30 days written notice.

## TERMS AND CONDITIONS

---

### PAYMENT TERMS:

Regular payment terms are Net 30 days, DOI with credit approval. Aspect by Waterstone also accepts payments made by VISA, MASTERCARD, AMERICAN EXPRESS and DISCOVER credit cards. Starting July 1, 2024 – If you choose to pay your invoice(s) with a credit card, you'll be charged a 3% surcharge. We do not accept debit card payments.

Aspect shall have the option to charge 1½% interest on all past due accounts monthly. In the event of legal action to collect any past due amounts, the buyer shall be responsible for all attorney collection fees, court costs or other fees reasonable and proper for such collection(s).

### FREIGHT:

All orders are F.O.B. Murrieta, CA. In general, all goods are shipped UPS ground unless otherwise specified by the customers Purchase Order. Shipments that can be consolidated to a pallet size may be shipped via common carrier. Customer preferred shippers or method of shipment will be accommodated providing such preference is listed on the customers Purchase Order.

### PRICING:

All prices and terms are subject to change without notice.

### CLAIMS:

All claims for shortages or damages must be made within ten (10) days from receipt of merchandise. Claims for merchandise delivered damaged must be filed with the delivery carrier within 7 days. Request an immediate inspection by the carrier.

### RETURNS:

All returns are subject to the terms and conditions of the Aspect warranty. A RETURNED GOODS AUTHORIZATION number (RGA #) must be obtained by the customer from the Aspect Customer Care Department prior to any merchandise return. The RGA # must appear on the return packing slip/document and a copy of the approved pending RGA form must be in the box with the returned unit. Upon inspection, Aspect, at its option will either repair or replace the item if the defect falls under the guidelines of the warranty. New, unused and sealed merchandise in its original packaging of current design purchased within the last 12 months that is accepted by the Company for return is subject to a 35% restocking charge. If the product returned is damaged by the recipient or damaged in transit for return, Aspect has the right to rescind the restock fee and charge up to the full purchase price of the unit. All credits provided for returned product or otherwise are only valid for 90 days from date of approval and issue by Aspect. If unused by the recipient after 90 days the credit is null and void, and the RGA product will not be returned. Credits can only be used for Aspect merchandise ONLY.

#### MINIMUM ORDER:

Order minimum is \$50.00 for an active account.

#### DEFAULT:

If a customer is in default under any order of contract with Aspect, or if Aspect at any time shall not be satisfied with its customer's financial condition or responsibility, Aspect shall have the right, without prejudice, to legal remedy including suspending deliveries until such default or condition is remedied.

#### TITLE:

All merchandise is sold subject to these conditions and shall remain the property of Aspect until paid for in full, with the provision that all risk of loss or damage to merchandise is assumed by the customer.

## ORDER FULLFILLMENT POLICY

---

The customers order will be entered into the order fulfillment system on the day the order is received, providing the order is received by 2pm Pacific Standard Time.

An order confirmation will be faxed or emailed to the customer within one working day of the entry of the order into the order fulfillment system. The order confirmation will contain anticipated ship date information and a listing of all items and the customers cost pricing of these items.

The factory will endeavor to ship all orders received as quickly and completely as possible in a single shipment.

The factory will ship a customer's order complete whenever the customer places such a request in the body of their purchase order. Without this specific written request, Aspect will ship partial shipments as they become available.

## DROP SHIP POLICY

---

**ASPECT DROP SHIPMENT OUT OF REPRESENTATIVES REGION POLICY** Aspect is committed to keeping our direct customers "selling field" as level and even as possible. Our customers invest in product displays, inventory, training of their sales staff, etc. Therefore, we wish to assist our customer's efforts to obtain excellent margins when selling our products.

Aspect will accept all orders from our direct purchase customers in qualified credit status and ship those orders to the customer's immediate local trading area. Any customer may certainly re-ship our product(s) after they receive them at their location of business.

We will drop ship our product(s) for our direct purchase customer(s) within the geographic boundaries of their assigned Representatives Selling Region. We will not drop ship outside of these areas.

## WARRANTY POLICY

---

#### Limited Lifetime Functional Warranty

Aspect by Waterstone supports their workmanship with a Limited Lifetime Functional Warranty. All Aspect products manufactured by Aspect, excluding drains carry a Limited Lifetime Guarantee against functional defects in material or workmanship in a residential application. Aspect products will be free from defects in material and manufacturing workmanship, however, any damage due to improper installation, product abuse, product misuse, improper maintenance, alterations or accidents by a contractor, service company, or homeowner, are excluded from this warranty. Proof of purchase, from the original consumer, must accompany all warranty claims.

#### All products must be registered on our website to activate the warranty.

In the event of a problem with the product, Aspect has the option to repair or replace the defective part/product, at our discretion, and may require the product be returned for inspection. If the product should develop any leaks or functionality issues, Aspect will provide the necessary parts, at no cost, in order to return the faucet to fully functional condition.

Aspect is not responsible for any labor charges incurred by the purchaser to repair, replace, install or remove the product(s). Aspect is not responsible for any indirect, incidental or consequential damages, losses, injury or costs, of any nature, relating to the product, except as provided by law. This warranty is in lieu of and excludes all other warranties, conditions and guarantees, whether expressed or implied, statutory or otherwise, including, without restriction, those of merchantability or of fitness for use.

This warranty is valid only when products are purchased through an Authorized Aspect Dealer/Distributor. Aspect will not honor this warranty if the products are purchased from any unauthorized dealer, third-party vendor or online seller. The warranty applies to Aspect faucets installed in the United States of America, Canada and Mexico only.

**WARNING** – Aspect by Waterstone advises all of our customers against the installation of any brand of in-line water chiller unit with our faucets. Compressor style chiller units have been proven to arbitrarily exceed the standard household in-line pressure ratings, causing the faucet inlet connection line to burst and create the potential for water damage claims in the field. **INSTALLATION OR USE OF AN IN-LINE WATER CHILLER WITH AN ASPECT FAUCET, OF ANY KIND, WILL VOID THE WARRANTY.** Aspect will only recommend the installation of a water chiller in the vented side (in place of a hot tank) with one of our Hot Only or Hot and Cold Filtration Faucet models.

This warranty gives you specific legal rights, and you may also have other rights which vary from state/province to state/province. The above limitations or exclusions may not apply to you.
