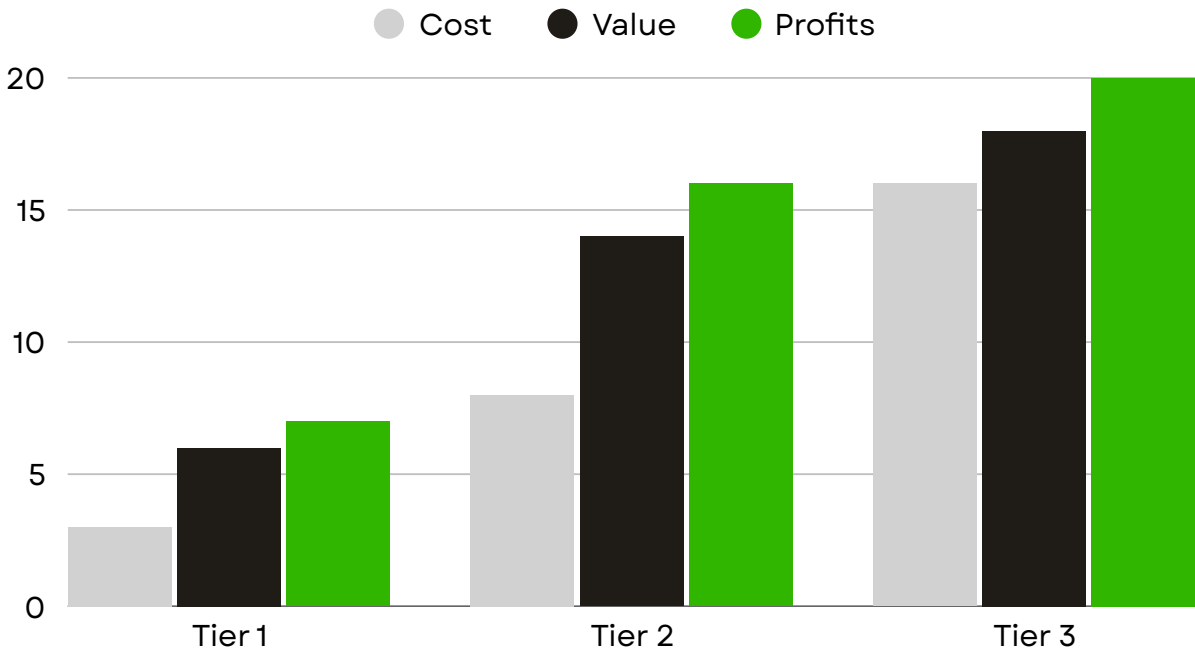

Tier 2: Growth Intelligence

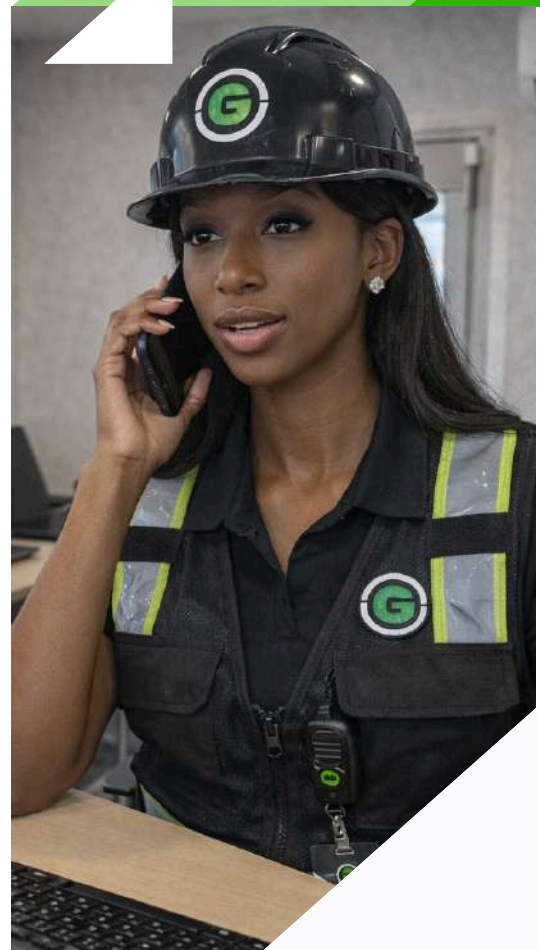
