What do you do when you're faced with a challenge that appears to be insurmountable? The year 2023 presented the everyday person with opportunity to engage with public figures, celebrities, and influencers, for the first time after Covid, without an event ticket or a paid subscription. By-standers of the incident jumped onto a bandwagon, camouflaged as a social experiment, to only find out that they were contributing to the mass manipulation trafficking **scheme**. Like any other assignment, CEO JAS decided to travel to Denver, CO after applying Executive for an Assistant position for **Harvest** Church. Although the intentions weren't set with employment in

mind, the itinerary took a turn when the bishop of the church, a church revealed as a front to cover criminal activity such as murder, human sex trafficking, cyberstalking, and extortion, became fixated on the evangelist. **Foreman**, hungover with Satanism and Witchcraft, placed a target on her back.

For over a year and a half, Foreman and his accomplices plotted to steal intellectual property and her corporations while trying to coerce the rising executive into believing her purpose was to be a prostitute. Fighting for her life, CEO JAS reported several incidents to local PD. Aware that the chaos aenerated in her life was sourcing from Foreman, the activist began to speak out against the matter on her social media platforms. Struggling to gain income due to the scheme tethered to her devices, emails, and social medias, CEO JAS put her faith in the Lord and worked the law. murder and a cover up. The victim of the scheme reached out to the churches that were associated when the "social experiment" first rocketed. While trying to gain information, to put together the pieces for law enforcement to understand the matter, she was lied to, turned away and ignored. She sent several emails asking to speak with the pastors and bishops, that she knew were contributing via social media, and never received a response.

She emailed numerous lawyers to seek advisement and because Foreman, day in and out, stalked CEO JAS, they were instructed to deny her counsel or do what many others did, ignore. Overtime, those who sympathized drew concern and to prevent the conversation from the assailants continuing, decided to wipe their hands clean and directed her family to

falsely-commit her to an insane asylum. Literate of the law and being 100% sane, CEO JAS was able to advocate her way out of a cycle that would've destroyed all credibility.

Currently, Jas Lundie has six cases pending with the United States District Courts and it appears as if obstruction of justice is at play. Out of all of the police reports and FBI complaints filed, Foreman is still terrorizing her life with a voodoo doll. In order to prevent disability, a coma, or death she is working tirelessly to have him arrested.
