Prior to his tenure with Starlight Starbright, Rafe managed the reorganization and legal separation of the Jewish Community Centers of Greater Los Angeles, developing and implementing a long-range strategic plan to resolve debt while re-investing in programs to insure the financial stability of independent locations.

At Project Angel Food, Rafe implemented cost-saving measures in conjunction with his oversight of government grants to enhance the production, distribution and quality of more than 1,000 meals delivered daily throughout Los Angeles County to homebound individuals living with HIV/AIDS and other serious illnesses.

He designed an infrastructure that supported the organization from startup through a 350% growth period, including the creation and implementation of centralized accounting and financial systems to unify the regional offices throughout the United States.

He has been a featured lecturer to accounting professionals, board members, and students on topics relating to practical business operations as well as managing organizations through mergers, growth, and crisis.
