6. Ethics Advisory Committee Report

- a. Tracey years in the making, thank Chantal for the heavy lifting. Revising the Constitution. Have an Ethics Committee, can have a forum, decision making that situations that occur, have a platform. In 2020 two cases are closed. 2021 two cases are open, Provincial Directors have been notified and is a confidential process. There is an ethics advisory policy.
- b. Chantal many documents and there is a reason, mechanism is meant to take complaints, address them in the EAC, there is space for appeals, VP has part of the appeal process, there is a process to deal with serious situations. We have a system in place for confidentiality reasons, for consistency reasons, and have a place for ppl to go. Seeking to have Chair and Co-Chair in place, as well as an Executive CAWF sitting member. Looking also for volunteers to investigate certain claims need to nominate someone. Documents have been shared with everything to view the processes. Need to be added to CAWF website. Talk about how it can be visible, and easy to access the documents. All of these should be in one place to be easily accessible to understand

the process and make an informed decision. If there is a criminal activity - the committee needs to know and there is a process around that and create virtual files and communicate with the proper people and create a safer place for pullers. How do we get this known to the athletes? It's not only a place for dealing with incidents, it can also be a place for consultation. If you are interested, you need the skill set. Curious what the best way to let the masses know. Can be operational now, but there are some key pieces missing.

- c. QUESTIONS: Rick willing to put it on the website. Need to work with every Province. There is a vetting process to open an investigation. Jason being confidential and in the process of suspension, it does get suspended and the provincial body informed, how do we keep it confidential within the province. Chantal the confidentiality is regards to why, we will not share the why, going to share there has been a suspension dolled out and it started, won't be notified as to the why. Cases by case basis, as an example not permitted by law to be around at law around under the age of 18, that is the conversation we have to share. Legal ramifications for that person, they have restrictions on their own. Holding records for 7 years. Tracy any of the individuals with the offences, they have also been notified in writing and at the end.
- d. Luc who is involved in the complaint? Chantal have the right to know it has been dealt with. Not investigating criminal matters.
- e. Charlie an athlete had a restraining order against someone else and both go. Chantal both know they cannot be together, and someone needs to be inquire if that other person is going.

7. Approval of CAWF Constitution amendments

- a. Rick to introduce. Highlighted in yellow, housekeeping issues, minor word adjustments.

- b. Article 4, no. 3 a bit of a mistake on the words.

- c. Article 10, no. 10. Work under the leadership of the executive committee. Rick moves / seconded by Dave passed
- d. Article 30, doping, cannabis struck from the list in Canada. Put a disclaimer, only for testing in Canada. Luc questions does that apply to any CBD type products. Rick answers Yes. Luc questions testing the athlete, are they also testing referees, Rick answers Officials never get tested. Ryan questions do we know if officials are tested. Rick answers None that we know of. Any tests put forward in Canada, that cannabis will be excluded from the ban list for testing in Canada.

- e. Transgender in sports board of directors in 2015, anyone that wants to compete, that they must keep their testosterone level below 3. Had a lawyer involved. Follow the IOC and WAF. Chantal bring up the levels from IOC because they were significant. I've been competing against two trans, either aligned with WAF or IOC, if we are different, how do they adjust. Align ourselves with one or the other. Worried from a human rights perspective, if the levels are so low, that means they cannot compete.

Rick suggests developing this policy, trans study southern California, they can make a level whatever you want. Women tested were in the low 1. IOC is allowing each sport to determine the level. Is it achievable? Ryan comments, early 2021 stated that males genetic males up to a 50% strength advantage to females. Someone who only loses about 5% in a 12th month period. Don't like having the advantage, doing it at the cost of genetically making, sure it's inclusive and not exclusive at the same time. WAFs stipulated over time, IFA has started, do we know what the IFA or WAF stands on it? WAF took from IOC. Charlie comments - agrees with Ryan, way too much of an advantage. Have something, can change later. Transgender athlete - put a disclaimer at the end of the paragraph that speaks to the athlete responsibility to inform themselves about the restrictions at WAF and IFA. level 3 for a full 12 months.

- i.Rick to introduce, issues with no provinces are wanting to host it. Wanted to have a discussion about why. Possibly because of covid and the several postponements that Darrell had to deal with. Don't need a commitment, just how can the CAWF as an organization help the provinces. Any province willing to host the nationals, appoint certain ppl within each province to help with national committees. Vivian suggested creating a National's Committee. Darrell got a document that laid out the stuff and criteria. It may need to be updated. Rick can update it. Keith, who has hosted many, encourages everyone to host Nationals and give it a try.
- b. Mandatory Vaccination

Rick to introduce, someone brought up the issue about being vaccinated. CAWF does not want to impose mandates. Airlines could make it mandatory. Maybe Hotels too. Putting on events, what are the regulations within the province. Chantal, suggests consulting with their medical practitioner. Need to look into the regulations, not all provinces know what they are doing with mandates. Should be up the person, but usually it's up to the provincial government. For an event they should not be telling them. Promoter would have to do it. Anthony question - are the referees going to wear masks. Rick answers - Long way down the road and see what the regulations are down the road. Could be optional. Contact sports will be based on provincial guidelines. Every province is planning their own way to be vaccinated. There is nothing in the rules about face coverings.
