# Paperless Registrations Now Available!

As part of the board's commitment to keep the cost of registrations and transfers affordable for our members, CSBA and CLRC will now be offering a Paperless Registration option for breeders who no longer wish to receive a hard copy of their registration papers.

Along with this paperless option, breeders will also now be able to print a non-official copy of a registration paper through their "Manage My Account" on the CLRC website.

Breeders will have the option to move to the paperless registrations with future registrations, however hard copy registration papers for animals already registered will still need to be kept.

This is completely optional, however if you opt-in you will need to contact CSBA to opt-out. Individual registration papers may be requested, but there may be an administrative fee from CLRC.

Paperless registrations will be available at \$8 per animal (plus applicable taxes and levy).

## Paperless Registrations - Frequently Asked Questions

### Is this a mandatory change?

No. This is a completely optional function for breeders. You will be asked to opt-in to make the change.

#### Once I move to paperless registrations, can I switch back?

You will need to contact CSBA to switch back to hard copies of registration papers.

#### Will I still receive a paper copy of my registrations?

No. Once you opt-in to the paperless system, no new Certificates of Registration will be printed for animals that you register *or* that are transferred into your name.

## Will my animals still show up in my Manage My Account and online in CLRC's Search the Registry?

Yes. Official pedigree information for all registered sheep in the CSBA herdbook will still be available online via the CLRC website.

#### How can I get a copy of a Registration Paper?

Digital 'unofficial' registration papers will be available in PDF form, can be accessed for any sheep you own through the Manage My Account on the CLRC website. If you require a hard copy of an official Registration Paper, you will need to contact CLRC. Fees may apply.

#### Will I still receive an invoice?

Yes. All invoices will be emailed, rather than mailed.

NOTE: If a payment is not received, the registration will be held (i.e. not visible via Search the Registry or Manage My Account) until the payment is received.

## What if I am transferring an animal with no physical registration paper to someone who has not opted in to the paperless system?

If you are transferring to someone who has not opted-in to the paperless system, once the transfer has been processed, a hard copy paper will be issued to the buyer, at no charge for the first buyer and \$1.75 +tax per extra buyer thereafter to cover postage costs.

What if I'm selling my animal through a sale and need to provide a Registration Paper? CSBA and CLRC will work with any organization hosting a purebred sale to offer a Transfer Authorization Form that will be used in place of signing the back of the Registration paper. If you need a copy of this form please contact CSBA.

## Can I use GenOvis/EweManage/EweByte files to submit Paperless Registrations?

Yes. You are still able to submit registrations using your herd management software.
