Press Release April 1,2022 - CSBA AGM and Board of Directors Update

The Canadian Sheep Breeders' Association just held their 133rd Annual General Meeting on Saturday March 26, 2022 in Fall River, Nova Scotia. The minutes from the meeting will be available on the website as well as all the provincial reports, president's report and GM Report. We were also able to host a zoom meeting along with the in-person AGM which encouraged producers from across Canada to join. As we weren't able to complete this last year, it was a special day for the board, to present Trenholm Nelson and Bruce Sinclair with the awards for their service to CSBA. Bruce had stepped down from this role as president but continued to be an integral part of the board of directors. Trenholm Nelson of Quebec was awarded a plaque for his 23 years of service to the board. Trenholm also held the presidency role for 7 years during his time on the board. He had resigned from the role of board of directors but was thanked for all his significant contributions over the years.

The CSBA board of directors announced that Keith Todd of Ontario will remain in the role of president and Bernadette Nikkel of Alberta will join as Vice President. The CSBA also announced a new Executive which is being held by Bruce Sinclair of Nova Scotia and Johanne Cameron of Quebec. All of these directors bring extensive industry experience and knowledge to move the sheep industry forward. Thank you to the remaining board of directors as they continue to represent CSBA at their provincial level.

The CSBA would also like to thank Delaney Hopkins for her role as Junior Director over the past year and appreciates her input and perspective.

The 134th AGM is set to take place in Saskatchewan.

This past year, the Sheep and Goat industries launched a collaborative project over the next three years for improving and integrating genetic improvement services in Canada. This project is funded in part by the Government of Canada under Agriculture and Agri-Food Canada's Canadian Agricultural Strategic Priorities Program. AAFC will contribute \$495,000 over three years to match co-funding provided by the Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA), the Ministère de l'Agriculture, des Pêcheries et de l'Alimentation du Québec (MAPAQ) and the project partners. There are several objectives to this project and more information can be found on the website at www.sheepbreeders.ca.

One of the main objectives of this year's meeting was to examine the Constitution and move towards a smoother transition as we rely more on electronic communications. One aspect of making the registration system more efficient and economical is the ability to complete these options online. As CSBA experienced another loss this year financially, we encourage you to have a valid email address on file with CLRC so that you remain up to date with CSBA communications as we move away from costly postage mailings.

The PSBO and CSBA look forward to seeing you at the All Canada Classic this year in Ancaster, Ontario July 7-9. More information can be found on the website at www.sheepbreeders.ca or contact the PSBO

This process allows the buyers to see exactly what they are buying without varying fleece lengths. Wool breeds are encouraged to send pictures or videos of parted fleece along with complete animal shots. Photo and video clips will be included in the DLMS online catalogue.

The 2023 All Canada Classic is set to take place in Barriere, British Columbia.

The board also moved to proceed with the recognition of the Valais Black Nose Sheep Breed. This will be voted on by membership in the upcoming year so please be sure to send in your ballots when the constitutional amendments are circulated with membership updates. We would like to thank the Canadian Valais Blacknose Sheep Society for submitting a comprehensive proposal for the New Breed Recognition Process.

Congratulations to the 2022 Photo Contest Winners. First place went to Nicole Ridder for Karlstern Farms with the photo "Gazing over his Kingdom". Communiqué de presse -1er avril 2022 - Mise à jour sur l'AGA et le Conseil de la SCEM

La Société canadienne des éleveurs de moutons vient de tenir sa 133° assemblée générale annuelle le samedi 26 mars 2022 à Fall River, en Nouvelle-Écosse. Le procès-verbal de la réunion sera publié sur le site Web de la SCEM ainsi que tous les rapports provinciaux, le rapport du président et le rapport de la DG. Nous avons également pu organiser une réunion en distanciel parallèlement à l'AGA, ce qui a incité les membres de partout au Canada à se joindre à nous. Comme nous n'avions pas été en mesure de tenir notre AGA l'année dernière, celle-ci était fort attendue. Le conseil d'administration a pu remettre à Trenholm Nelson et à Bruce Sinclair les prix pour leurs longs services à la SCEM. Bruce s'était retiré de son rôle de président mais avait continué à jouer un important rôle au sein du conseil d'administration. Trenholm Nelson, du Québec, s'est vu remettre une plaque pour ses 23 ans de bons services au sein du conseil. Trenholm a également occupé le poste de président pendant 7 ans au cours de son mandat au conseil d'administration. Notes to the Financial Statements as at 31st. December, 2021

1). Summary of significant accounting policies Nature of Business

The organization is incorporated under the Laws of Canada. The primary purposes of the organization is to provide a system of registration for purebred sheep in Canada, including establishing standards, assisting breeders and maintaining breeding records.

The organization is a non-profit organization and is exempt from income taxes under the Income Tax Act.

Revenue recognition

The association follows the deferral method of accounting for contributions, Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when received if the amount to be received can reasonable be estimated and collection is reasonable assured. Endowment Contributions are recognized as direct increase to Net Assets. Restricted investment income is recognized as revenue in the year which related expenses are incurred. Unrestricted investment income is recognized when earnt.

Investments

Investments are carried at the lower of cost and net realizable value.

Financial Instruments

The Association's financial instruments consist of cash, short term investments, accounts receivable, investments and accounts payables. Unless otherwise noted, it is managements' opinion that the association is not exposed to significant interest, currency or credit risk arising from these financial instruments. The fair market value of these financial instruments approximate their carrying value, unless otherwise noted.

2021 General Manager's Report

This year marked a few changes as Jane Underhill stepped down as General Manager in April of 2021 and I returned to help fill in with the transition. I ultimately was reinstated in August of 2021 and am thankful to be back in this position with CSBA. Although Covid conditions created alternate environments for us all, CSBA continued with the second All Canada Online Purebred Sheep Sale. This sale generated \$59,776 for producers across Canada. We look forward to having the All Canada Classic Show and Sale in Ancaster Ontario July 7-9, 2022. Financially, this year, CSBA experienced a loss of \$27,849 but was anticipated as per our budget. There was a 13% decrease in membership but registrations remained consistent and transfers increased by 10%. In 2021, 254 free memberships were handed out for members purchasing a purebred animal for the first time (down from 477 in 2020) and bulk discount amounts were credited back in the amount of \$25,055.

The board's significant accomplishments in moving forward with the CSBA's business plan in 2021 included:

- funding commitment to new research projects: Dave Barrett (Sheep Producers of Nova Scotia) \$3000 over two years, Societe des éleveurs de moutons de race pure du QC for Fresh Semen Project \$5000, University of Laval for Pregnancy Toxemia Project \$2100 over 3 years, National Integrated Services project \$20,000 over 4 years, CarLa Saliva Research Project for \$10,000 over 3 years.
- continuing the 6th annual photo contest (winners were Mia Westergaard and Ashley Miller)
- continuing the Junior Director position that was filled by Delaney Hopkins
- bulk discount option for registrations and transfers: pricing breaks in place based on the number of animals registered each year. A rebate is calculated and applied to membership accounts.
- sponsoring the 2021 All Canada Online Purebred Sheep Sale and All Canada Classic in 2022
- maintaining an equal partnership in the support of GenOvis (Canada's genetic evaluation program) (\$10,000/year) and assisting in translations for breeder group meetings
- continue with providing the "Guide to Breeding Stock Selection", or "conformation booklet" as new copies were printed in 2021
- funding The Royal Agricultural Winter Fair (\$1500), Agribition (\$500) and 8 provincial level 4-H shows (\$250 each)
- continue to provide social media options through the CSBA website, Facebook and Classic Facebook accounts

The Purebred Sheep Breeders of Ontario and the CSBA are preparing for the 2022 All Canada Classic, which will be held in Ancaster, ON from July 7-9, 2022.

The board and I look forward to hearing from you so that you are properly represented in the CSBA's decisions and actions.

This year we welcomed Linda Brandes back as General Manager after a short leave. Linda quickly got to updating and modernizing the CSBA website. I encourage our members to take a look at the new design and feel free to make suggestions of content you would like to see. We welcomed Delaney Hopkins from Ontario as our new Junior Director. We also welcomed Sylvain Blanchette to the Board as a new Quebec Director replacing long time Director Trenholm Nelson. Sylvain comes to us with a wealth of knowledge after working at CEPOQ for many years.

I am extremely proud of our Board of Directors. We have a very well rounded, experienced group that offer opinions and see the enormous potential for the industry. Directors, which are providing direction on a modern Canadian sheep Industry. Part of providing direction is not always making the popular choice, but recognizing the need for change for the overall good of the entire sheep industry. We often hear of the inconsistency of lamb from our processors and this being one stumbling block for expansion. Ultimately, as producers and Directors of this organization the end goal of consistent quality lamb guides our decision making process as our rams filter out into the commercial sector.

It has been an honor serving the Industry in this role for the past year and I look forward to the coming year to build on our successes from 2021.

2021 proved to be a year of turmoil for BC sheep producers. First we had a 'Heat Dome' covering the province in June that lasted for 3 weeks. Record high temperatures were endured throughout the province causing drought conditions and early harvest of a much reduced yield of hay. Half normal yields were reported even with irrigation, lower without. Lamb growth was stalled, with temperatures in the high 30's and well into the '40 's C. At our farm in the southern interior, we had temperatures 45+ for numerous days. Sheep hid in the shade with much reduced consumption for most of the days. With the hot and dry weather conditions, came extreme drought and forest fires. People, including farms and animals were evacuated for weeks. Many farms remained 'in' to help protect their properties and care for their animals despite being on an evacuation order. Some who evacuated were moved more than once to avoid newer fires.

Fall hay crops were somewhat better than the earlier cuts as the heat subsided and some rains came. But... then came the November atmospheric rivers in southern BC. Hundred year flooding happened, flooding farms and towns, causing major evacuations and demolished 2 of the 3 highways leading from the Fraser Valley to the Interior. The third highway, remaining open by a 'hair'. Virtually all transport of goods from the coast to the rest of Canada had to travel a single lane road, with many washouts and repairs going on. Feed was of major concern for many animal producers, as was groceries to stores. Restoration of many farms will take years to recover, if ever.

All this, in the middle of a pandemic, and the sheep industry holds as strong as ever. Market lambs produced in BC rarely see a grocery store, most are sold independently. That market continues to be limited by slaughter and processing capacity.

Sales for purebred/registered breeding stock saw strong sales for the second year in a row. Many small acreages looking to produce something on their land. Consumers are looking for locally produced food.

BC Purebred Sheep Producers Association is sponsoring three \$250 prizes to 4H open fairs in 2022, to augment the one offered by CSBA. The prize is money towards the purchase of a purebred lamb for the following year. We also offer \$50 prize money to the Champion Ewe lamb at any fair having more than one club compete.

BCPSBA is planning an online sheep sale in July, similar to CSBA's Classic 2021.

The Classic 2023 is being planned for Barriere, BC and will include a Junior show.

ALBERTA SHEEP BREEDERS' ASSOCIATION REPORT

I am pleased to present the 2021 provincial report for the Alberta Sheep Breeders' Association. Unfortunately, we could not meet in person again for either the AGM or the biannual symposium.

2021 proved to be another quiet year, and we hope to be at the beginning of resuming some normalcy. We continue to rely on technology to keep us connected, and we miss the opportunity to get acquainted and get reacquainted with each other and meet new producers.

The ASBA Sheep Symposium was due to be held this past October, but unfortunately, we could not host this biannual event. Instead, we opted for a webinar to keep in tradition with hosting a learning event every other year for producers and breeders in Alberta. We look forward to when we can once again meet in person. The next symposium will typically be in 2023, the 27th anniversary of this event. Currently, we are looking at moving the event to October of 2022 and are working on deciding the timeline and practicality of planning an event in a much shorter timeframe.

ASBA currently encompasses all current CSBA members residing in Alberta and has an active board of directors who continually seek ways to promote the purebred sheep industry.

Our 2021 year was a mixed bag as we once again we cancelled our summer Grasslands show but continued the sale online with DLMS Livestock Auctions. CWA made the decision to be open for business and we were able to successfully host our CWA show and sale. Credit must go to the CWA board for making the tough choice to be open with a lot of difficult restrictions but it was a tremendous success in spite of the cloud of the unknown factors that could have shut it down.

Grasslands 2021 was held as a Racetrack Style Sale with bidding closing on July 23rd. We had 32 lots with gross sales of \$39196.00 with an average of \$1225.00 per lot. Top selling ram was a Suffolk ram lamb that sold for \$3800.00 consigned by struck farms purchased by Darrell Fehr. Top selling ewe was a Canadian Arcott ewe lamb consigned by The Govan Ranch & Paige Govan that sold for \$1725.00 purchased by Devin Harlik & Travis Schoeder. Commercial pens of ewes were all purchased by Eric Millen from Nova Scotia. Sale results were outstanding and plans are under way for the 2022 Grasslands show and sale in Humboldt for July 22nd -25th. Sale will be live and available on-line with DLMS.

SSBA returned for the 50th CWA from Nov 25th-27th. We had a full schedule once again with our judge, Jordan Bell, from Stayner, Ontario tasked with placing the 120 entries on conformation and breed characteristics. Mr. Bell did a splendid job and we thank him for his decisions and comments. Thursday showcased the market lambs and commercial ewe shows. Grand Champion Market Lamb was awarded to Kimdain Sheep (Kim & Diane MacDougall) shown by Josie Moats and the Reserve Market Lamb was awarded to MacKid's Sheep (Courtney MacDougall) shown by Carson Moats. Next we congratulated Lois Trowell of Ward Suffolks from Saltcoats, Sk with her Grand Champion Commercial Ewe. Reserve Commercial Ewe was shown by Royce Lodeon of Double L Farms, Fox Valley, SK. Champion and Reserve banners for Commercial Pens were both awarded to Tyler Fettes, FX5 Livestock, Melfort, Sk.

Sheep shearing and foot trimming demonstrations are always a crowd favorite with Bethan Lewis of Kirkella, Mb with assistance from Jason Struck of Pilger,Sk. performing the tasks. They explained the entire process as they went about the task at hand. Once again they had a packed crowd at their demonstrations which concluded with handing out bits of the shorn fleeces while answering numerous questions. Thank you for a job well done.

The Supreme Ram Banner went to a Charollais Ram exhibited by Gavin & Isabelle Nicol of Sandy Hill Charollais, Red Deer, Ab. Supreme Champion flock was awarded to the Canadian Arcott flock exhibited by Matt Govan & Family of the Govan Ranch, Englefield, Sk. The Premier Exhibitor was Royce Lodeon,

Double L Farms, Fox Valley, SK and the Rookie of the Year award was presented to Jon Wright of CJL Livestock, Pangman, Sk.

Saturday featured our junior show. Thirteen junior exhibitors provided a very positive projection for the future of our industry. Special thanks to all the young parents and their parents for keeping the sheep industry vibrant. This was followed by our SSBA sale of 42 lots which averaged a record average of \$858.00 per lot which is almost \$300.00 higher than any other CWA sale. Special thanks to our sponsors our Judge Jordan Bell, our auctioneer Scott Johnstone, veterinarian Kent Wier. And barn boss Marg Simon. Most importantly a HUGE thank you to everyone who contributed before during and after to make our 2021 events the huge successes we could not have done it without the input of each and every one of you. We are looking to getting back to some sense of normal in 2022.

2021 Ontario Report to the CSBA

The Ontario Purebred Sheep Industry had 299 members registered with the CSBA in 2021 with 2068 registrations and 1584 transfers. Lamb prices remained strong in 2021 and this led to a good demand for purebred breeding stock. Livestock producers in Ontario are looking at the sheep industry as a viable enterprise to add to their operations.

The 2021 Classic Show & Sale was also cancelled due to the pandemic and replaced with an online format. The Purebred Sheep Breeders of Ontario (PSBO) look forward to hosting an inperson Classic in July 2022. The PSBO awarded their Post-Secondary Scholarship to Delaney Hopkins & Ashley Miller.

The Ontario Sheep Farmers (OSF) organization set a new direction for their organization and implemented a new five-year plan, *Building Strength for a Better Future*. There are five key pillars in the plan that will be used to guide projects and programs, community, prosperity, mastery, invest and operations.

The Ontario Lamb Producers Caucas (OLPC) continues to have a membership and Board of Director with the Canadian Sheep Federation to represent producers of Ontario at the National Federation. They are in the process of setting up a training program for ultrasound pregnancy detection starting in August of 2022.



NS CSBA Director Report 2022

For the second year running Covid has made face to face events impossible until recently. Here in Nova Scotia exhibitions were cancelled, a few 4H events were held with small numbers. Meetings on the most part were virtual which has become the norm. There is still very high demand for market animals as well as breeding stock here in Nova Scotia.

The Purebred Sheep Breeders Association of Nova Scotia decided to have a virtual Atlantic sheep sale using DLMS timed auctions. All animals were slick sheared with 25 entries from Nova Scotia, New Brunswick, and PEI averaging 717 dollars. The top selling ram consigned by the Agriculture College going for \$1300, and the top selling ram consigned by Breckrow farm receiving \$1000. Buyers were from Nova Scotia, New Brunswick, Prince Edward Island, Alberta, Saskatchewan, and Quebec.

We have been releasing quarterly newsletters to our members containing current issues from the sheep industry, reports from sheep specialists, a lamb recipe, a section on Ask Ted Semple DVM about sheep health, and producer profile on one of our provincial purebred breeders.

Our AGM was held on December 11th, 2021, virtually using zoom using zoom with members only. Our board has remained the same with Kathy Vallis stepping down as secretary and Janessa Henry taking over the reins. We want to thank Kathy for her dedicated time and service to our provincial association.

The sheep producer's association of Nova Scotia has been busy this past year with various projects on the go. In conjunction with the Department of Agriculture a survey was released to identify challenges for many producers dealing with veterinary and laboratory services. The survey will help to improve services in animal health and welfare, food quality, food safety and food security. A sheep conference and their AGM was held November 12th and 13th 2021 in the Debert Hospitality centre. Sessions measuring success on numbers and money, turning pasture and forage into profit, the farm management toolbox, farm financing, livestock research, and to end with a fireside chat. A second survey was released by sheep producers association of Nova Scotia, Nova Scotia cattle producers, Nova Scotia Department of Agriculture, on Nova Scotia environment climate change. Questions asking how climate change has directly impacted farmers, challenges they have experienced, and concerns moving forward.

The Nova Scotia Department of Agriculture has launched the cattle and sheep industry development program with the goal to improve industry competitiveness and resilience by providing funding assistance. The program addresses tight cash flow, provide upfront interest payments, on cattle and sheep loans which are deferred for two years. Sheep Producers association of Nova Scotia we are also continuing a virtual farm tour focusing on local sheep farms highlighting their operations and discussing their management.

Dear members,

Sadly, since Covid most provinces have been unable to host any kind of agricultural fair, exhibition or event without it being held virtually. Perhaps with restrictions being lifted slowly, we will see the return of these events gradually. Fortunately, many sheep producers have been enjoying good prices for lambs and increased demand for breeding stock also, nevertheless, prices for feed, fertilizer and fuel have reached exponential prices and predicted to continue to rise.

In NB our annual provincial meeting was well attended via zoom. We have seen several new large producers relocating to our province from Ontario and the west. Producers were presented a SHEEP ACTION PLAN, by the dept of agriculture. Last year they hired a consultant to put together a 10 year plan on how to work with producers of all commodities for the province to become self-sufficient in food production. Of course, this is a draft plan that many found very ambitious, ...but this is what builds the foundation for unity and discussions on how to grow and make our farming community sustainable and viable. Attendees included dept staff, NBSBA board members as well as provincial sheep producers. Topics ranged from prolific breeds, accelerated lambing, feeding sheep and lambs, cost of production model, pasture raised lambs vs housed fed lambs, Veterinarian services and vet fees, educational workshops, and various projects available under the CAP program. Realistically the NB sheep has lots of room for growth. The Atlantic provinces including NL have seen an annual decline in production over the past several years. There are many resources in each province that collaboratively all could benefit, ..this is an avenue to be considered, ...STRENGTH IN NUMBERS! To name a few, there is the NSAC, Perrennia, the Atlantic Sheep sale hosted by the PSBANS, the ASL stockyards weekly sale as well as new Sheep Breeding sale, Northumberlamb Abattoir that is Federally inspected, Atlantic Vet College and the Maritime Beef test station that has begun a RAM evaluation project that they hope can be done yearly, -Also SPANS has held their first virtual sheep conference last fall. There are probably a few more I haven't mentioned also. We are also fortunate to have two national associations being CSBA and the CSF that are a wealth of information from research projects, registrations of purebred animals, GENOVIS program, breed directory, scrapie surveillance, traceability, agroledger, only to name a few. 
