**At the scene of an accident:**

1. Obtain the following:

- Name, address, and phone number of each driver, passenger, and witness. Obtain a driver's license number for each driver.
- License plate number, insurance company, and policy number of each involved vehicle.
- Photos of vehicle damage and accident scene.

2. Report the accident to the proper authorities.

3. **Do not admit fault.** An investigation may later reveal you were not responsible for the accident.

**KEEP THIS CERTIFICATE IN YOUR VEHICLE AT ALL TIMES.**

Arizona law requires you to possess evidence of financial responsibility within your motor vehicle. This card or an image of the card viewed on an electronic device meets that requirement and is satisfactory evidence if you are asked to verify financial responsibility on the motor vehicle.
