## How to Fill-Out Form 56 Page 1

- Use your All Caps name from your original (first) birth certificate. Put '-VESSEL' after your vessel name. Example: JOHN QUINCY PUBLIC-VESSEL
- 2 Identifying number: Use the federal reserve bank routing number found on the back of your Social Security card. Include the beginning letter of the number. If you do NOT have a bank routing number on your SS card, use the birth registration # (also called State File No.) from your state issued birth certificate. **DO NOT** get a new Social Security card in order to fill out this form. The birth registration # is sufficient.
- 3 Decedent's social security no.: Enter your social security number. DO NOT put your SSN in square brackets.
- Your federal overlay mailing address in ALL CAPS.
- 5 Your federal overlay city, 2 digit state abbreviation and zip code IN ALL CAPS
- 6 Fiduciary name: Your current name in upper and lower case. Put '-Executor' (for males) or '-Executrix' (for females) after your current name. Examples: John Quincy Public-Executor Jane Ann Public-Executrix
- Your non-federal address. Upper and lower case. All words spelled out. NO abbreviations. Example: c/o rural route 123 First Street
- 8 Your non-federal city, state (spelled out) and zip exempt Example: Anywhere, Pennsylvania zip exempt
- 9 1g: Check the 'Other' box and type exactly what is shown on the Form 56 sample template
- 1b: Date you were born. Example: 1/2/1961
- 3: Check the 'Other' box and type exactly what is shown on the Form 56 sample template
- 4: Check the 'Other' box and type exactly what is shown on the Form 56 sample template
- CAUTION: Only use this statement if your current name is different from your original birth name. Otherwise, leave this statement off your Form 56.

  Hand print this statement in purple ink. Important: The date your BC (birth certificate) was recorded is the FILE DATE (sometimes called registered date) shown on your BC. This is the day your vessel was created. Executor if male, executrix if female. At the end of the statement, put your initials in cursive writing at a 45 degree angle.
- Here is where you will use your 'CERTIFIED TRUE COPY' stamp. **AFTER** you have completed and autographed Form 56, you will make several color copies of your Form 56. **One** of your color copies **DOES NOT** get the CERTIFIED TRUE COPY stamp. This is the copy you will record with. The number of color copies you need with the stamp depends on how many recipients you are mailing the Affidavit of Status to. Refer to Form 56 Process instructions. Autograph your current name in cursive, parse syntax, purple ink directly under the CERTIFIED TRUE COPY stamp. Example: **By:: John-Quincy; .Public:**

## How to Fill-Out Form 56 Page 2

- 6: Check the box at the end of the statement. **Caution:** most people miss checking this box and have to start the Form 56 process all over again. **CHECK THE BOX:-)**
- 6c: Check the 'Other' box and type exactly what is shown on the Form 56 sample template
- Your autograph, in cursive, parse syntax purple ink Example: By:: John-Quincy; .Public:
- Handwrite in purple ink Executor or Executrix as applies
- 18 Handwrite in purple ink the date you autograph Form 56
- OPTIONAL, NOT REQUIRED: you will only be able to use this statement if you have registered mail tracking number label on-hand. And that is because you have to make your TRUE CERTIFIED COPY(s) of Form 56 before you go to the post office to mail. Pay close attention the 'usa' is NOT in all caps and that 'Private Registered Indemnity Bond' has the first letters of each word capitalized. Hand print this statement.

**General:** as always, anything shown in red ink on the template is to draw your attention. Change the color as needed to blue or purple.

When you fill out the a downloaded Form 56 from IRS.GOV, the type will appear blue. This is OK.
