**ORDER GRANTING MOTION FOR
APPROVAL OF COMMUTATION
AGREEMENT**

Petitioner, COMMISSIONER OF INSURANCE, STATE OF NEVADA¹, as Receiver (“Commissioner” or “Receiver”) for FRIDAY HEALTH PLANS OF NEVADA, INC. (“Friday Health” or the “Company”), filed a Motion for Approval of Commutation Agreement (“Motion”) which came for hearing on September 30, 2025.

By and through the Motion, the Receiver on behalf of Friday Health, sought approval of a commutation agreement with Odyssey Reinsurance Company, a reinsurance company domiciled in Connecticut (“Odyssey” or the “Reinsurer”) and provided a copy of the proposed Commutation

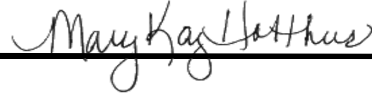
1 Agreement (“Commutation Agreement”) which the Receiver believes is in the best interest of the
2 receivership estate and would result in a payment of \$190,255.00 to the Receiver, for the benefit of
3 claimants.

4 The Court, having reviewed the Motion, and noting that no opposition has been filed, and
5 good cause appearing therefor, GRANTS the same. The Motion is granted for good cause shown
6 based on the reasons set forth in the Receiver’s Motion and as unopposed under EDCR 2.20(e).
7 Based on the foregoing,

8 **IT IS HEREBY ORDERED** that the Court approves, ratifies, and confirms the Commutation
9 Agreement and the transaction contemplated thereby.

10 **IT IS SO ORDERED.**
