Agreement ("Commutation Agreement") which the Receiver believes is in the best interest of the 1 receivership estate and would result in a payment of \$190,255.00 to the Receiver, for the benefit of 2 claimants. 3 The Court, having reviewed the Motion, and noting that no opposition has been filed, and 4 good cause appearing therefor, GRANTS the same. The Motion is granted for good cause shown 5 based on the reasons set forth in the Receiver's Motion and as unopposed under EDCR 2.20(e). 6 Based on the foregoing, 7 IT IS HEREBY ORDERED that the Court approves, ratifies, and confirms the Commutation 8 9 Agreement and the transaction contemplated thereby.
