**PROPOSED ORDER 1**

**ORDER GRANTING PETITION FOR**  
**APPOINTMENT OF COMMISSIONER AS RECEIVER**

On June 1, 2023, Petitioner, Scott J. Kipper, Commissioner of Insurance, State of Nevada (“Commissioner”) filed in this Court a Petition for Appointment of Commissioner as Receiver, Temporary Injunction, and other Permanent Relief (“Petition”) for Friday Health Plans of Nevada, Inc. (“Friday Health”) initiating this proceeding. On the same date, the Commissioner also filed a Motion for

1 Injunction (“Motion”) to enjoin providers of health care services to Friday Health members from  
2 interfering with their contractual obligations and from interfering with the Commissioner’s efforts to  
3 ensure Friday Health members receive the health care services to which they are contractually entitled.

4 The Court, having reviewed the points and authorities along with relevant exhibits filed in support  
5 of the Petition, including the consent of Respondent, finds that good cause appears to grant the Petition.  
6 The Court also finds that a hearing is not necessary in this matter because Friday Health consents to this  
7 Petition and a hearing would unnecessarily increase costs and delay this matter. The Court also finds  
8 that Friday Health’s members are entitled to continue receiving health care services under their health  
9 insurance contracts. Accordingly, the Court hereby grants the Petition, and the requested relief as  
10 follows:

11 IT IS ORDERED, ADJUDGED, AND DECREED that:

- 12 1. The Commissioner is hereby appointed as Receiver of Friday Health, a Nevada-domiciled insurer,  
13 and authorized to enter the business and immediately oversee the operation and conservation or  
14 rehabilitation of the business. NRS 696B.290.
- 15 2. Friday Health’s officers, directors, stockholders, members, subscribers, managers, agents,  
16 employees, and all other persons are permanently enjoined from: (1) wasting or disposing of any  
17 assets or property of FRIDAY HEALTH, or (2) transacting any further business on behalf of  
18 FRIDAY HEALTH except as expressly directed or approved by the Receiver. NRS 696B.270(1).
- 19 3. Any and all persons are permanently enjoined from the commencement or prosecution of any  
20 actions by or on behalf of FRIDAY HEALTH, or against FRIDAY HEALTH. Further, all persons  
21 are restrained from obtaining any preferences, judgments, attachments, or other liens as to any  
22 property of FRIDAY HEALTH, or making any levy against FRIDAY HEALTH or against their  
23 assets or any part thereof. NRS 696B.340.
- 24 4. All persons other than the Receiver are permanently enjoined from disbursing, committing,  
25 transferring, substituting, or withdrawing any funds from FRIDAY HEALTH’s accounts, or  
26 removing other property from, controlled, or owned by FRIDAY HEALTH except as expressly  
27 directed or approved by the Receiver. NRS 696B.270(2).
- 28 5. All providers of health care services, as defined in the policy of insurance, and any other person

1 that has provided or agreed to provide health care services to members or enrollees of Friday  
2 Health, directly or indirectly, pursuant to any contract, agreement, or arrangement for that purpose  
3 with Friday Health are permanently enjoined from

4 a. Amending, changing, altering, or terminating any and all implied or express contractual  
5 obligations or agreements.

6 b. Interfering in any manner with the efforts of the Receiver to assure that Friday Health  
7 members and enrollees in good standing receive health care services to which they are  
8 contractually entitled.

9 NRS 696B.270.

10 6. The Receiver is hereby vested with title to all of FRIDAY HEALTH's real and personal property  
11 of every kind whatsoever and take possession of the assets wherever located, whether in the  
12 possession of FRIDAY HEALTH or its officers, directors, employees, consultants, attorneys,  
13 agents, managers, parents, subsidiaries, affiliated corporations, or those acting in concert with any  
14 of these persons, and any other persons, including, but not limited to, all property, offices  
15 maintained or utilized by FRIDAY HEALTH, books, papers, contracts, deposits, stocks,  
16 securities, rights of action, accounts, documents, data records, papers, evidences of debt, bonds,  
17 debentures, mortgages, furniture, fixtures, office supplies, safe deposit boxes, legal/litigation  
18 files, and all books and records of insurers, and administer them under the general supervision of  
19 the Court. NRS 696B.290(2).

1 7. The Receiver is hereby authorized to take any and all actions that he deems necessary in  
2 connection with this delinquency proceeding, and as provided in NRS chapter 696B and any other  
3 applicable law. The Show Cause Hearing currently scheduled on June 20th, 2023 is hereby  
4 VACATED.
