1 **ORDER**

2 Based on the foregoing, the Court finds Friday Health to be insolvent as defined in
3 NRS 696B.110 as it has failed to meet its obligations as they mature. As a result of the same,

4 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED,**

5 1. The Receiver has established sufficient grounds for liquidation pursuant to
6 NRS 696B.220;

7 2. Friday Health is formally placed into liquidation as of September 1, 2023, and the
8 Receiver is authorized to liquidate the business of Friday Health and wind up its ceased operations;


9 3. This Order establishes that the rights and liabilities of Friday Health and of its
10 creditors, policyholders, stockholders, members, subscribers and all other persons interested in its
11 estate shall be fixed as of September 1, 2023, except to the extent that the rights of claimants with
12 contingent or unliquidated claims are protected by NRS 696B.400 and NRS 696B.450;

13 4. Notwithstanding the foregoing, Friday Health's claims against others are not fixed as
14 of September 1, 2023; and

15 5. This Order is designated as a final order pursuant to NRS 696B.190(5).
