Petitioner, SCOTT J. KIPPER, COMMISSIONER OF INSURANCE, STATE OF NEVADA as Receiver ("Commissioner" or "Receiver") for FRIDAY HEALTH PLANS OF NEVADA, INC. ("Friday Health" or the "Company"), filed a Motion Requesting approval of Early Access Agreement and payments to the Nevada Life and Health Insurance Guaranty Association ("Motion") on November 1, 2024. The Court, having reviewed the Motion, and noting that no opposition has been filed, and good cause appearing therefor, GRANTS the Motion. The Motion is granted for good cause shown based on the reasons set forth in the Receiver's Motion and as unopposed under EDCR 2.20(e).

### **ORDER**

NRS 696B.415 specifies that the Commissioner, in his capacity as Receiver is to apply to the district court for authority to disburse money to Nevada guaranty associations from the marshaled assets of the receivership estate. NRS 696B.415(1). The statute further tasks the Receiver with determining the appropriate amount available to disburse to the guaranty associations while reserving sufficient assets to pay administrative expenses. NRS 696B.415(2). Based on the facts and arguments set forth in the Motion, the Court approves the Early Access Agreement attached to the Motion and approves payments to the Nevada Life and Health Insurance Guaranty Association ("NLHIGA").

### Accordingly, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED:

- 1. The Early Access Agreement between the Receiver and NLHIGA is approved.
- 2. The Receiver is authorized to make an initial payment to NLHIGA of \$2,500,000.00 and is granted the ability to provide additional funds to NLHIGA pursuant to the Early Access Agreement as deemed warranted, based on available receivership funds.
- 3. Payments by the Receiver to NLHIGA shall be made pursuant to the priority of claims and early access provisions contained in NRS 686C.330 and NRS 696B.415.

IT IS SO ORDERED.
