We provide trauma healing support, resources, and advocacy for trauma victims, aiming to foster healing, resilience, and long-term recovery.

OTVI adopts a multifaceted approach to trauma support by offering direct support services such as counselling, therapy, and practical assistance to trauma victims. The organization focuses on community engagement to raise awareness about trauma and its effects and build robust support networks. Additionally, OTVI works on advocacy and policy influence to shape policies and legislation that support trauma victims.

Additionally, the DQSI will

serve as the external representative for OTVI Nigeria, engaging with various stakeholders and donor agencies to foster collaborative relationships. This effort aims to position OTVI (across Nigeria, the USA, and other potential countries) as a leader in bridging the gap between trauma and care.

#### The Role Dimension

The Director, Program Quality, Strategy, and Influencing (DQSI) holds primary responsibility for strategic program planning, design, implementation, and monitoring and evaluation in alignment with the Program Quality and Influencing Approach.

The DQSI will lead, manage, and support all aspects of Program Monitoring and Evaluation to ensure the delivery of high-quality and integrated programming that adheres to the OTVI Organizational Strategy, as well as organizational standards, frameworks, and procedures.

The DQSI reports directly to the Executive Director and the Board of Trustees. As a member of the Organizational Leadership Team (OLT), the DQSI also chairs the Quality and Innovations Program Team.

This role involves direct supervision and support for the Program Team, which includes Advisors, Specialists, and Managers.

The DQSI will maintain close working relationships with Program area teams as needed. Additionally, the position entails reporting directly to the Executive Director and the Board of Trustees on the management of all risks associated with program delivery, including budget oversight, people management, and legal compliance.
