
Having knowledge in pre-hospital and hospital medicine has led to my passion in Mobile Integrated Health.

He is a veteran of the Department of Justice, having served twice in Washington, D.C.: from 1991 to 1993 as an Attorney-Adviser in the Office of Legal Counsel, and from 2017 to 2021 as a Deputy Assistant Attorney General in the Environment and Natural Resources Division (ENRD). During his tenure at ENRD, Mr. Grant supervised more than a hundred Department litigators advancing the interests of the United States and its agencies in both enforcement and defensive matters, both civil and criminal.

In addition to his service in the Department, Mr. Grant has decades of experience in private practice in Washington, D.C. and Sacramento. That experience includes arguments in the U.S. Supreme Court, the California Supreme Court, and numerous other federal and state courts.

Mr. Grant served as a law clerk to Chief Justice Warren E. Burger (retired) and Associate Justice Clarence Thomas during the Supreme Court's October 1994 Term. Earlier he served as a law clerk to Judge Edith H. Jones of the U.S. Court of Appeals for the Fifth Circuit in Houston, Texas.

Our communities are the heart of our society's future. The ongoing loss of our children and loved ones continues to leave a devastating impact. It is essential that we educate others so they can make informed decisions about the dangers of substance use including the misuse of illicit drugs and opioids, which continue to cause devastating harm in our communities.

My name is Javon Williams, and I am the CEO and founder of the Lamont Meyers Foundation (LMF). The foundation was established September 20th, 2023, in honor of my beloved son, Lamont Meyers, who tragically passed away from fentanyl poisoning on February 8, 2020 on his 19th birthday after ingesting a pill he believed was Percocet. His passing inspired me to take action to ensure others do not have to endure similar tragedies.

Our mission is to help stop and prevent fatal drug overdoses and poisoning in our communities by ensuring Narcan is readily available and accessible. With 98% of fake drugs on the streets containing fentanyl, countless lives are at risk.

In hopes of saving lives, we created the 2nd Chance Kits, which is our opioid harm reduction kits designed to give someone the opportunity for a second chance at life.

We actively collaborate with other nonprofits, churches, schools, and community organizations across Sacramento, Solano County, and the Bay Area to expand our reach and strengthen our impact. I also served for two years on the Sacramento County Alcohol and Drug Advisory Board, working alongside other advisory board members to provide recommendations to county officials on strategies and policies to address substance use and overdose prevention.

Through education, prevention, and access to lifesaving tools, the Lamont Meyers Foundation works every day to protect and empower our communities.

My name is Carol Wilson. I lost my oldest precious daughter December 1, 2023 in Elk Grove, CA.

To this day there has been no justice for my daughter, and when she had gone to local hospitals her condition was downplayed and rushed - as was her investigation. There was evidence of dealers reaching out to her soliciting this poison (Fentanyl). We raised Melissa in Elk Grove starting around 8 years old.

She was popular in the Elk Grove schools. She was funny, could land jobs easily, believed in God, and was loved deeply by her grandparents on both sides, her sisters, Sharon and Abreena, her mom and dad, and Uncle Albert. She developed anxiety which progressed. Doctor appointments were scheduled usually months down the road. Eventually, dealers would take advantage of her vulnerability. Which led to us losing her.

I'm sharing for awareness and maybe my advice can prevent anyone or a family from enduring this excruciating pain. Thank you, Melissa's mom... Forever 34

In the late nineties, Angela began her journey toward becoming a life coach. As a medical social worker working in acute and ambulatory settings, she observed a relational pattern between patients and physicians. She realized that both patients and physicians were instantly thrown into a very personal unsolicited relationship. A relationship traditionally seen as hierarchical—the physician at the top, diagnosing, recommending, and the patient on the receiving end; the two could not be more different, or could they? Angela's natural curiosity and her personal belief in the interconnectedness of all beings led her on a search for one common theme patients and physicians shared.

By thoughtfully developing rich relationships with physicians and patients, indeed a theme surfaced – Self compassion!

In her twenty years, she observed patients who sometimes found themselves in life-threatening circumstances due to unconscious choice-making and lack of self-compassion.

Physicians, in their desire to serve at their highest and best, in turn, experienced the very same absence of self-compassion.

She foresaw the long-term consequences of an individual's inattentiveness to self especially those serving in the helping.
