As a condition of enrolling your minor child in the Junior Tennis Academy Program (the "Program") at the Binghamton Racquet Club ("BRC"), you, as the parent(s) and/or legal guardian(s) of the minor, hereby, on behalf of the minor,

- a. Represent(s) that said minor is in good health and proper physical condition to participate in physical activity;
- b. Acknowledge(s) that the minor has had a recent physical exam and has received permission from his/her physician to participate in the Program; and
- c. Assume(s) the risks and perils inherent in the participation of the Program pertaining to physical activities.

You further hereby acknowledge and agree that BRC shall not be liable for any damages arising from personal injuries or damages sustained by your minor child, in, on, or about the premises of BRC and/or while participating in the Program. You agree to assume full responsibility for any injuries and/or damages that might arise from the participation of your minor child in the Program and hereby forever release, absolve, indemnify and hold harmless BRC, and their owners, employees, instructors, teaching staff, coaches, and agents from any and all claims, demands, damages, rights or causes of action, present or future, known or unknown, from the minor's participation in the Program's activities at BRC.

You further hereby grant permission for your minor child to be photographed and/or videotaped by BRC and/or their designees in conjunction with tennis activities and for the purpose of future promotions by BRC. You expressly release and forever discharge BRC from any and all claims and demands of any kind whatsoever in relation to, or arising out of the use of the minor's image or likeness.

All cancellations must be in writing. The deposit and any prepaid fees will be refunded (less a \$25 administrative fee) IF written notice is received 30 days prior to the scheduled date of attendance. Cancellations made less than 30 days prior to the scheduled date of attendance will cause the forfeiture of the full deposit. **There will be no refund or adjustment in fee, for any reason whatsoever, should a student withdraw from the Program.** BRC does not assume liability for loss of personal property and/or for illnesses or injuries incurred at BRC.
