### **RE-OPENING OF THE GRIFFITH E. HARRIS GOLF COURSE HOURS OF OPERATION: 8 a.m. – 6 p.m.**

#### **THE GOLF COURSE AND DRIVING RANGE TO RE-OPEN MONDAY, MAY 4: SUBJECT TO THE FOLLOWING RULES:**

PLEASE READ THE FOLLOWING RULES CAREFULLY. THEY ARE INTENDED TO ENSURE YOUR HEALTH AND SAFETY, AND THAT OF OUR STAFF. ANYONE CAUGHT IN VIOLATION WILL BE ASKED TO LEAVE IMMEDIATELY AND MAY BE SUBJECT TO A LOSS OF GOLFING PRIVILEGES FOR THE SEASON.

1. SOCIAL DISTANCING OF AT LEAST 6 FEET MUST BE MAINTAINED AT ALL TIMES WHEN ON THE PROPERTY INCLUDING IN THE PARKING LOT, DRIVING RANGE AND ON THE GOLF COURSE.
2. EVERYONE MUST BE WEARING A FACE COVERING AT ALL TIMES WHEN ENTERING THE GRIFFITH E. HARRIS GOLF COURSE PROPERTY AND WHILE PLAYING GOLF. EXAMPLES CAN BE FOUND [HERE](#).
3. YOU MUST IMMEDIATELY LEAVE THE PROPERTY AFTER YOUR ROUND AND NOT CONGREGATE IN THE PARKING LOT.
4. GOLF CARTS ARE RENTED AS ONE PERSON, PER CART AND AVAILABLE ONLY AS LONG AS SUPPLY LASTS. CARTS, KEYS AND PULL CART HANDLES ARE CLEANED AND SANITIZED BETWEEN RENTALS.
5. THE PUTTING GREEN, PRACTICE BUNKER AND CHIPPING GREEN WILL REMAIN CLOSED UNTIL FURTHER NOTICE. THE RESTURANT AND PRO SHOP ALSO REMAIN CLOSED.
6. ONLY CREDIT/DEBIT CARD PAYMENTS WILL BE ACCEPTED. ALL PLAYERS MUST HAVE A RESERVATION TO PLAY (NO WALK UPS) AND MUST ARRIVE NO MORE THEN 15 MINUTES PRIOR TO THEIR TEE TIME.
7. THERE WILL BE NO DISTRIBUTION OF SCORECARDS OR PENCILS. FLAGSTICKS ARE NOT TO BE TOUCHED OR REMOVED. ALL BUNKER RAKES, BALL WASHERS AND WATER FOUNTAINS HAVE BEEN REMOVED.
8. 2019 MEMBERSHIP WILL BE EXTENDED UNTIL JUNE 15. AS OF JUNE 15, ANYONE WITHOUT A CURRENT MEMBERSHIP WILL PAY NON-RESIDENT RATES.
9. ONE RESTROOM WILL BE OPEN NEXT TO THE PROSHOP.

Although we will continue to sanitize and make every effort to provide a healthy environment, **PLEASE MAKE RESPONSIBLE DECISIONS, BASED ON YOUR PERSONAL RISK PROFILE, ON WHETHER TO EXPOSE YOURSELF TO OTHERS AND THE GOLF COURSE.**

We will continue to provide outdoor recreation to our customers during this heightened alert period as long as everyone obeys the above safety practices. We will continue to monitor the recommendations by the CDC, local, state and national authorities and keep you updated on changers at the course **IF YOU, A FAMILY MEMBER OR SOMEONE YOU HAVE BEEN IN CONTACT WITH HAS RESPIRATORY SYMPTOMS, PARTICULARLY A FEVER, DO NOT VISIT THE GRIFF.**
