### Reflecting on Visibility, Reputation, and Character

Visibility of CCDP and our growing membership is key to helping community members and potential candidates for office feel safe openly discussing their alignment with Democratic values. We have to lead the way by making sure we let others know we are Democrats and by remembering that our actions may inspire others to join, or avoid, us. Here's what you can do to positively increase CCDP's visibility:

 Attend one CCDP volunteer opportunity or event, or one public meeting (e.g. township, school board,

etc.) а month. Be open about stating you are а Democrat and your affiliation with CCDP when you attend а rally or other event. Help CCDP become more visible by asking us to sponsor/cosponsor events and activities with other organizations. Or, see what is on CCDP's action "wish list" but

lacking volunteers and help launch the project.

In addition to visibility, we should be aware of how we are perceived within and beyond our membership. We're all living through difficult times and respond to uncertainty differently. We need to be aware of how we respond in these situations and manage our emotions so they don't reflect on CCDP as a whole. Keep in mind this quote by author Robert McKee:

"True character is revealed in the choices a human being makes under pressure - the greater the pressure, the deeper the revelation, the truer the choice to the character's essential nature."

Here's what we can do to help CCDP maintain a reputation for inclusion and wisdom:

 Remember the huge diversity of thought that exists within and across political parties and look for common values and goals. Ask questions to understand someone's point of view

or actions. People are complex, and we all carry а lifetime of experiences that influence our beliefs and choices. Be aware of and challenge our own personal biases and consider how experiences and outdated assumptions might be limiting our ability to fully appreciate different points of view. Respect where others are

in their journey. So what if they use single serve plastic or drive а low mileage, gas vehicle. Many of us still do. When we judge, we make people feel unwelcome. lf they can't see themselves fitting in with us, they won't vote for our candidates or our policies.

CCDP is doing great work and we should celebrate that. We should also be

aware of how we can positively contribute to our visibility and reputation. What we are fighting for is critically important and we are glad to be on this journey working hand in hand with you!

### House Democratic Women Introduce Equal Pay Package

*By Tim Hughes*. Members of the House Democratic Progressive Women's Caucus have introduced a 10bill legislative package designed to promote pay

equity and fight gender-based wage discrimination in Michigan. The bills were introduced five days before the observance of Equal Pay Day, a symbolic day when women's earnings catch up to men's earnings from the previous year. According to statistics released last year by the U.S. Census Bureau, women in Michigan earned only 83% of the median salary paid to men.

"This package is rooted in the truth that every person, regardless of gender, deserves to be paid equally and fairly," said state Rep. Erin Byrnes (D-Dearborn). "Many Michiganders are struggling to make ends meet and dealing with higher costs. Pay equity is one way to combat this economic issue."

"It is unconscionable that pay gaps for women, and especially women of color, continue to persist in workplaces across Michigan," said state Rep. Helena Scott (D-Detroit). "Every person deserves to be valued for their work, and Michigan will only grow stronger by paying every worker fairly."

Legislation in the package attempts to decrease pay inequities by increasing salary transparency between employers and their prospective employees; requiring employers to obtain fair wage certification; prohibiting the awarding of state contracts to a person who does not have fair wage certification; prohibiting employers from discouraging employees from discussing their wages; giving employees the tools to fight back against wage discrimination, including the ability to anonymously report through the Civil Rights Division; and strengthening financial penalties for wage discrimination under the Elliot-Larsen Civil Rights Act.

HB 4289-4297 were referred to the **House Committee on Economic Competitiveness**. HB 4288 requires the state to use one or more objective and merit-based factors when hiring, including the applicant's relevant education or work experience. It has been referred to the **House Committee on Government Operations**.



#### Area Parks: Clinton County's Best-Kept Secret!

*By Melany Mack.* When we think of parks, beautiful green spaces or water features and pleasant thoughts of opportunities for recreation are usually top of mind.

Less often thought about, but arguably as important, is the role of parks in enhancing our quality of life, contributing to the economic vitality of our communities, and attracting new residents to the county. Indeed, parks and open spaces contribute to our physical, mental, and social well-being.

The **Parks and Green Space Commission** (PGSC), whose mission is to "acquire, develop and maintain a vibrant county park system that improves the quality of life in Clinton County" recently updated its 5-Year Park, Recreation, and Open Space Plan. It contains lots of useful information, including a recreation inventory of local parks and detailed demographic information about the county. The Commission sought community input during the process of updating the plan using an online survey and public, open-house style meetings. Responses revealed that parks are our county's best kept secret! Nearly 65% of respondents who had not visited a park in the prior year indicated that lack of information was the primary reason.

Clinton County has three county parks, Motz (opened in 2010), Clinton Lakes (opened in 2014), and Clinton Trails (acquired in 2023 and in the initial phases of development). Together, the parks offer myriad opportunities for hiking, boating, fishing, picnicking, swimming, and enjoying nature. In addition, Latoff Landing, a one-acre site purchased by the county in 2005, offers access to the Maple River for kayaking, fishing, and birdwatching, or observing nature. The PGSC and the Board of Commissioners are committed to improving universal access at all of these public spaces, and *no fees are required to access any of them*.

The PGSC is redoubling its efforts to better advertise the county parks in response to community input which clearly showed lack of information as the primary reason residents do not visit them. The commission is also actively reaching out to other entities in the county, including businesses, health care organizations, and libraries, to collaborate on events that could be hosted at the parks. Watch for information in CCDP's regular announcements about upcoming events.




