What Have YOU Done for Democracy Lately?



Tsernoglou Bill Fighting Intimate Deep Fakes Unanimously Passes Committee

By Tim Hughes. The House Criminal Justice Committee unanimously reported out legislation sponsored by State Rep. Penelope Tsernoglou (D-East Lansing) to fight the nonconsensual

dissemination of AI-generated sexual images. The Protection from Intimate Deep Fakes Act deals with the growing issue of deep fake AI technology creating highly realistic but fake sexual depictions of individuals that are used to harass and extort victims. Under Tsernaglou's bill, individuals who knowingly or recklessly disseminate these images or videos will face fines, imprisonment and civil damages. It also allows victims to seek damages and court-ordered relief, including temporary restraining orders and injunctions to prevent further harm.

The issue gained international notoriety earlier this year when AI-generated fake images of Taylor Swift went viral, leading to legislative efforts in several states to combat deep fake porn. According to the National Conference of State Legislatures, 40 states have pending deep fake legislation in the 2024 legislative session. At least 20 bills have already been enacted nationwide.

"By passing this bill out of committee, we are sending a clear message that Michigan will not tolerate these invasive and harmful practices," Tsernoglou said. "As AI technology evolves, it is crucial that our laws keep pace to protect our residents from new forms of abuse and exploitation, while reducing malicious behavior and ensuring the right to privacy."
