## Voices Needed to Support Renewable Energy in Clinton County!

*By Melany Mack.* The issue of modifying the county renewable energy ordinance as it relates to solar will

be on the agenda for the Board of Commissioners meeting this Friday, December 20. We need to make our voices heard! **Email me** and I can give you more information on signing an **online petition**, emailing county commissioners, and attending the meeting in person. Please consider adding your voice yet this week!

The county adopted a renewable energy ordinance earlier this year, but some of its provisions are overly restrictive. A few modifications to the ordinance will make it workable and enable projects that are in the planning stages to move forward. This would retain local control and create eligibility for Renewables Ready Communities Awards from the Michigan Department of Environment, Great Lakes, and Energy. These flexible incentives provide \$5,000 per megawatt for eligible utility-scale renewable energy projects and are available only to communities which undergo local permitting processes.

The changes needed to make Clinton County's ordinance workable are not unreasonable. They simply will make the ordinance compatible with state law and assure that utility-scale renewable energy developers can work directly with local governments on renewable energy projects. ## Republicans Flip House; Trifecta Is Gone

*By Tim Hughes*. The 2024 elections brought a big change to the power dynamics in state government. House Republicans took the majority away from the

Democrats, flipping a 56-54 Democratic majority to a 58-52 Republican margin of control. Democrats still hold the Governor's office and have a majority in the Senate, but by a slimmer margin. Kristen McDonald Rivet leaves the Senate to take her newly elected office in Congress, leaving a 19-18 majority, with 19 votes now needed to pass legislation. A special election will be scheduled to fill her spot.

House Republicans selected Minority Leader Matt Hall (R-Richland Twp.) to be the next House Speaker, while Democrats selected Rep. Ranjeev Puri (D-

Canton) as minority leader. Republicans gained the majority by defeating four Democratic incumbents, including Reps. Nate Shannon (D-Sterling Heights) in the 58th District and Jaime Churches (D-Wyandotte) in the 27th. Both lost to their Republican challengers in areas where Donald Trump performed well. Dems also lost the 109th District in the in the Upper Peninsula held by Rep. Jenn Hill (D-Marquette), a district that has not been represented by a Republican in more than 70 years. Rep. Jim Haadsma (D-Battle Creek) narrowly lost his Calhoun County 44th District.

With the loss of the House, the Democratic "Trifecta" of control over the House, Senate and the Governor's office will come to an end. While it was in effect, the "Trifecta" overturned anti-labor laws enacted by former Republican Governor Snyder, repealing right to work and restoring prevailing wage laws. They also enacted legislation providing for common sense gun laws, expanding the state's Civil Rights Act to include LGBTQ citizens and codifying abortion rights. Republican members will now hold all House leadership positions, appoint majorities to all House committees and dictate committee and floor agendas. They will have to contend with the Senate Democratic majority and Governor Whitmer, but will be able to negotiate issues from a stronger position.

Speaker Hall announced a top priority of spending \$2.47 billion more on road repair, without explaining where the money would come from. He claimed that school aid funding would be held harmless under his plan, but the numbers don't add up. State Sen. Jeff Irwin (D-Ann Arbor) said "If he doesn't address the massive hole for K-12, then it's really more of a press release than a proposal." The new 103rd Legislature will be sworn in on January 8. Senate members and their committees will continue in the new legislative session but all new legislation will have to be introduced before voting can begin.






## Coffee & Conversation Resumes January 14!

#### Local Spotlight - Phillips Orchard

talking with Brian Phillips of **Phillips Orchard and Cider Mill**. If you attended CCDP's Fall Festival at Phillips Orchard, you know what a beautiful setting it is, spanning 170 acres with 30 acres of apple trees and smaller orchards of pear and peach trees. The Market sits on Gratiot County Line Road, on the west side of US-27. Upon entering, there's a small bar and the whole Market is packed with knitted or crocheted items, photos, wines, jewelry, tee shirts, ceramic items, and the star product, produce. One room houses bags of numerous varieties of apples. In season,

bags of pears and peaches are also available. And then there's the bakery! Cookies, breads, and pies fill the counter and freezers. The staff is always friendly and very helpful, often going out of their way to ensure customers find what they want.

Brian and his husband Gregg Smyth also own **Phillips Cider Bar** in Frandor where the focus is on cider pressed at the Orchard as well as a variety of adult beverages, with many wines made in Michigan. To enhance the beverages, they also serve homemade pizza. For shoppers, the Cider Bar also has a small market section. Brian and Gregg's newest business, Phillips Cider Bar and Pizzeria, is expected to open in Maple Rapids, hopefully by the end of the year with 2 full-time and 2-4 part-time employees. Their bakers will make a Neopolitan style pizza with a thin crust, baked hot and fast.

The Phillips family has a long history in the Maple Rapids area. Brian told me how his grandmother in Maple Rapids rode her horse to another relative's house and from there caught the school bus. Community involvement and a sense of connection are also important to Brian. The orchard donates apples to numerous services, including the Greater Lansing Food Bank and the Allen Neighborhood Center. Brian explained that he likes to see his money "going in a good direction." His connection to the orchard is very important to him and he tries to make that show in his products. Visit the businesses he and Gregg own and see for yourself. I think they succeed.

#### Help Local Lansing Business Impacted by Hate

owned business at 2010 E. Michigan Ave. Strange Matter's mission has been to serve quality coffee and delicious baked goods, often with beautiful designs, while providing a safe space for community members to gather. Strange Matter has also been an active supporter of social justice causes by fundraising for organizations such as Uniting Three Fires Against Violence, a tribal domestic violence and sexual

assault coalition.

Unfortunately, starting in 2022, Strange Matter was targeted by a group of armed individuals calling themselves First Amendment Auditors. After the 2024 election, they started their anti-LGBTQIA2S attacks again. The goal of these individuals has been to film customers and employees while yelling slurs at them to get a reaction to then be posted online for monetary gain. These "auditors" are well-versed in free speech laws, and Lansing police have been unable to make arrests because they remain on public sidewalks. Strange Matter is spending money on window coverings, legal action, and other security measures to keep employees and customers safe and business sustained. In addition to making purchases at Strange Matter, please consider donating to their **safety fund**.

Supporting businesses like Strange Matter reminds us that we have daily political power, starting with how we spend our money. At a time when the propaganda machines would tempt people into turning on each other over identity politics, and as Democrats sit with the election results, what is happening to this business is a stark reminder of why listening to marginalized voices is important as they are akin to the yellow canaries used in mines trying to warn us all about the spectrum of violence that can occur from hate. Just because it isn't visible to all of us doesn't mean it's not there.
