## Legislative Update for Clinton County Democrats

### Democratic Legislative Leaders Outline Working Families Agenda

For the first time in four decades, Michigan Democrats control the Governor's office and both chambers of the Michigan Legislature. House Speaker Joe Tate (D-Detroit) and Senate Majority Leader Winnie Brinks (D-Grand Rapids) held a press conference on the first day of session, outlining a legislative agenda that shifts dramatically from the tone of the previously Republican-controlled Legislature.

"House Democrats are committed to supporting Michigan families, guaranteeing the rights of all Michiganders are protected and respected, ensuring workers know they are valued, protecting and investing in our future, and promoting safe and strong communities," said Speaker Tate.

"Our first and only order of business is to tackle the real challenges that folks are facing by implementing an agenda that makes Michigan an even better place to call home," said Majority Leader Brinks.

The Democratic leaders said they were putting Michigan's working families at the center of their new agenda. Their priority legislation includes:

**Repeal of Retirement Tax** – Rep. **Angela Witwer** (D-Delta Twp.) and Sen. **Kevin Hertel** (D-St. Clair Shores) are sponsoring legislation that would repeal a 2011 retirement tax imposed under former Governor Rick Snyder that costs 500,000 Michigan senior households an average of \$1,000 a year. (HB 4001 and SB1)

**Increasing the Earned Income Tax Credit (EITC)** – Currently, Michigan gives low-income citizens a tax credit equal to 6% of the federal EITC. The credit level had previously been 20% but was cut to 6% by Governor Snyder to help fund a \$1.8 billion business tax break. Legislation sponsored by Rep. **Nate Shannon** (D-Sterling Heights) and Sen. **Kristen McDonald Rivet** (D-

Bay City) would raise the credit back to 20% by 2025, a move that would help 700,000 working families to get \$600 in tax relief, according to the Michigan League for Public Policy. The senate version of the bill would raise the credit to 30% by 2025. (HB 4002 and SB 3)

**“Right to Work”** – Former Governor Snyder signed a so-called “right to work” law in December of 2012. Under that law, workers in a union shop could stop paying dues while enjoying the wages and benefits negotiated by the union and requiring union officials to represent them in grievances and arbitration. These “free riders” would be able to sue the union for failure to represent them if they didn’t follow through. Legislation sponsored by Rep. **Regina Weiss** (D-Oak Park) and Sen. **Darrin Camilleri** (D-Trenton) would repeal this anti-worker law. (HB 4004, HB 4005, and SB 5)



**Restore Prevailing Wage Act** – Michigan enacted the Prevailing Wage Act in 1965, requiring construction workers to be paid decent wages and benefits on state-sponsored construction projects. Republicans repealed the law in 2018, claiming it would save the state money. Studies have shown that a prevailing wage requirement does not increase costs because the use of skilled, trained labor is more efficient. Governor Whitmer reinstated prevailing wage in 2021 through administrative contract bidding requirements. Legislation sponsored by Rep. **Brenda Carter** (D-Pontiac) and Sen. **Veronica Klinefelt** (D-Eastpointe) would restore the state’s prevailing wage law. (HB 4007 and SB 6)

**Civil Rights for Sexual, Gender Identity** – The **1976 Elliott-Larsen Civil Rights Act** outlaws discrimination in employment, education, housing and public accommodations. Legislation sponsored by Rep. **Jason Hoskins** (D-Southfield) and Sen **Jeremy Moss** (D-Southfield) would expand the law to include anti-discrimination protections for sexual and gender identity. (HB 4003 and SB 4)

**Codify Abortion Rights** – When the U.S. Supreme Court reversed *Roe v. Wade*, Michiganders were going to fall under a 1931 law that criminalized abortion services. Voters overwhelmingly approved a constitutional amendment last November guaranteeing reproductive freedom. Legislation sponsored by Rep. **Laurie Pohutsky** (D-Livonia) and Sen. **Erika Geiss** (D-Taylor) would repeal Michigan’s 90-year-old anti-abortion law. (HB 4006 and SB 2)

## Whitmer’s Inaugural: “Work Together and Get Things Done”



Governor Whitmer, in her inaugural address, told Michigan residents that “Our task is clear: focus on the fundamentals, work together, and get things done.”

“In November, Michiganders spoke with a clear voice. They want the ability to raise a family without breaking the bank, strong protections for constitutional rights, and leaders focused on the fundamental issues that matter most to their lives.”

she said. “They expect us to embody the values they live up to every day—grit and grace. They deserve practical problem solvers who get things done.”

Whitmer will outline her policy priorities in the State of the State message in Lansing on Jan. 25.

## A brief message from Elissa Slotkin:

Representing mid-Michigan in Congress has been the greatest honor of my life, and it's a privilege to continue the work we started to improve the lives of hardworking families of the new 7th district. In this new term, I'm eager to work across the aisle to continue to address the challenges everyday Michiganders face by lowering the cost of prescription drugs and health care, bringing our manufacturing jobs back to the United States, countering the threats posed by the Chinese Communist Party, protecting Michigan's lakes and environment, and honoring our commitment to our veterans. Over the last two years we've made great strides in all of these areas, often with bipartisan support, but it's clear there is more work to be done. I'm ready and willing to work with anyone – no matter their party – to address these issues as we head into the new year. It's time to get to work.



Elissa Slotkin made significant progress on many of these issues in the 117th Congress: she was a key co-author of the [Honoring Our PACT Act](#) to expand health care for veterans impacted by toxic burn pits and [worked aggressively](#) to pass the CHIPS and Science Act to incentivize an American semiconductor industry, both of which had bipartisan support. Slotkin also voted to pass the Inflation Reduction Act, which has [capped insulin prices for seniors](#) at \$35 per dose and limited out of pocket prescription drug spending for Medicare enrollees. In the new Congress, Slotkin will also continue her bipartisan work to protect Michigan's environment and lakes, strengthening U.S. supply chains for both military and critical goods such as medical supplies, and making government more transparent and accountable.

## 6th District Commissioner John Andrews



It's an exciting time to be a new county commissioner! As the second Democrat on the Board of Commissioners, I'll be working with fellow Democratic Commissioner Dwight Washington and our Republican colleagues to shape policy in Clinton County.

My strong commitment to environmental stewardship will inform my work on the commission to help assure proper development of the MSU mega site (also called the *Michigan Manufacturing Innovation campus*). The mega site spans more than 1,600 acres in Eagle Township and may contain an electric vehicle battery manufacturer and/or micro chip factory. I will encourage my fellow commissioners and county residents to expand the use of alternative energy solutions throughout the county. The climate crisis is a global problem, but some of the solutions lie in the decisions and practices of local



governments. The county also is engaged in expanding access to fiber-to-the-home broadband internet infrastructure in the county, something of keen interest to me, given my background in information technology. You can read more about this later on in this newsletter.

I will strive to keep my constituents updated about these and other important issues that come before the Commission.

In 2016, I ran for a seat as a commissioner because I thought I could make a difference for our community. As a commissioner for the past six years, I'm proud of the influence I have had in Clinton County and the Tri-County region on issues that are central to my core values: environmental conservation, community well-being, and economic sustainability. I am very enthusiastic about the privilege of serving a third term. Thank you for your support in returning me to office!

The "2022 Blue Wave" in Michigan, especially in the Tri-County Region and in Clinton County, makes the prospects for environmental, social, and economic growth seem exponentially more promising. Further, the cadre of Democrats now in the majority in the State House and Senate share common goals for a sustainable future. Our opportunity to harness our political will, procure financial resources, and engage people could not be more promising and potentially impactful.

This year in my role as a Commissioner, I will serve on the boards of several social service committees that affect health and well-being throughout our region, including the Tri-County Office on Aging, Capital Area Community Services, and the Early Childhood Council. I look forward to working with my Board colleagues and our new County Administrator, John Fuentes, to move the county closer to being a sustainable community where we are all proud to live and call home.

# Update on Clinton County's Broadband Initiative

Did you know that Clinton County is in the process of addressing broadband infrastructure access? Within the past year, the Clinton County Board of Commissioners has dedicated \$3 million of American Rescue Plan funds to explore the issue of broadband access to unserved and underserved county residents and pursue proposals from internet service providers to address this problem. The goal is to eventually provide fiber-to-the-home infrastructure in selected areas. This process has included surveying citizens, outreach to localities, and creation of a Broadband Task Force to guide expansion of this infrastructure.



**The update provided at the December 16 Board of Commissioners meeting noted the following:**

- The tentative award date for proposals for internet service providers has been extended to Friday, January 6, 2023 to allow the evaluation team to evaluate proposals.
- The evaluation team includes the County IT Director, Finance Director, Deputy Administrator and Administrator. The team has been working with Plante Moran to review technical and financial aspects of the proposal.
- The Federal Communications Commission released an updated National Broadband Map on 11/18/2022, with the intent to provide more accurate location-based broadband availability data. The website can be viewed at <https://broadbandmap.fcc.gov/home>.
- The 60-day grant window is planned to open in January.
