- 1. ATTENDANCE All Councillors present.
- 2. DECLARATIONS OF INTEREST AND REQUEST FOR DISPENSATIONS none.
- 3. **MINUTES OF PREVIOUS MEETING** the final minutes of the Parish Council meeting of the 5th March 2020 will be approved at the next legally binding meeting of the Council.

4. LEGAL UPDATE

- 4.1. **Public meetings.** There is currently a worldwide global pandemic, and following government advice to stop the spread of the virus all Wroxham Parish Council public meetings have been cancelled until the end of June. Following advice, and until new regulations are in place, decisions will now be made by the Officer of the Council (the Clerk) after seeking the views of members. Only urgent decisions will be made, anything else will be deferred. Wroxham Parish Council agrees to undertake this by holding Full Council and Committee meetings virtually until otherwise instructed. This meeting was recorded to provide a public record.
- 4.2. **Annual Parish meetings.** These are a legal requirement and Wroxham's was scheduled to take place on the 7th May 2020 which has now been cancelled. Await further advice.

5. REPORTS

- 5.1. **District & County Councillors news** Cllr Fran Whymark has been central in setting up Operation Wroxham & Hoveton. He now sits on the emergency committee of the District Council. He is currently self-isolating. Cllr Martin Murrell is working with his local Parish of Salhouse to set up a relief scheme there.
- 5.2. Review of logged reports from Norfolk Police on the Crime System 1st to 31st Mar 2020 7 incidents: Burglary Residential Non Dwelling shed break from last year or the year before where items were taken; Common Assault historical claim from a few years ago; Fear or provocation of violence unknown male shouted threats at children skateboarding; two incidents of ill treatment/neglect of person lacking capacity by anyone responsible for that person's care both a report of staff not looking after a resident at a Care Home; Making off without payment fuel bilking; Theft other parts of metal shed, in bits in alleyway near victim's house, have been taken.
- 6. OPERATION GOOD NEIGHBOUR This is an emergency relief project to provide support for the elderly and vulnerable in Wroxham and Hoveton. The scheme has been launched quickly and efficiently working

with the Wroxham Benefice, Hoveton Parish Council, Wroxham & Hoveton Good Neighbour scheme and is being led by Councillor Fran Whymark. Clerk has applied for, and been awarded, a grant for £1000 from the Norfolk Community Foundation to support Operation Good Neighbour.

 CLOSURE OF PLAYGROUNDS – Following government ruling Agnes Gardener Playground has been locked up to prevent social gathering. The Wherry Gardens playground has also been locked in association with Hopkins Homes.
