To report less urgent crime or disorder, to contact the police with general inquiries or to speak to a local officer.



In an emergency always dial 999

Police 999 call handlers strive to answer all calls within ten seconds.

You should dial 999 if:

- There is a danger to life
- Violence is used or threatened
- A serious crime (violent crime/burglary) is in progress or likely to occur
- A suspect for a serious crime is nearby
- There is a road traffic collision involving personal injury or danger to other road users
- A vulnerable person needs urgent attention.

Advice and best practice for Neighbourhood Watch Scheme members

Information sharing

- Before you share local information with others, make sure it is factually correct.
- Do not share information that identified victims, companies, or other personal details.
- Always use blind copy when forwarding emails onto members, and encourage others to do the same.

Passing suspicious information

As your coordinator, I encourage you to report anything you see or hear to the police:

- If it's unusual—note it down.
- Call 101 if you are concerned.
- Never put yourself, or others, at risk.
 Let me know after you have made a report to the police.
