Third member of Chester drugs gang jailed

A third member of a Chester drugs gang that was operating in Chester has now been jailed.

Gary Roebuck, 33, of Alan Street, Northwich, appeared at Chester Crown Court on Friday 15 November where he was sentenced to two years in prison. The 33-year-old had previously pleaded guilty of two counts of Conspiracy to supply the supply of Class A drugs.

His sentencing follows the sentencing of Connor Robins and Michael Curtis who both appeared at Chester Crown Court on Wednesday 9 October. Robins, 28, of Clover Lane,

Chester, was jailed for five years and Curtis, 47, also of Clover Lane, Chester, was sentenced to three years in prison. Both men had previously been found guilty of two counts of conspiracy to supply Class A drugs.

The court heard how in June 2023 officers from Chester Proactive Policing Team launched operation Starship in response to intelligence that a drugs line was being operated in the Lache area of Chester. The number was being used to send flare messages on a daily basis, offering to supply heroin and crack cocaine.



During their enquiries officers established that the phone line was being controlled by Robins. In order to minimise his risk of being detected Robins recruited two other men to work for him - Gary Roebuck and Michael Curtis. Roebuck was given the task of looking after the phone and taking orders on behalf of Robins, while the Curtis acted as a chauffeur, helping him to collect the drugs from Liverpool and deliver them to users across Chester. After gathering a catalogue of evidence against the men all three

were arrested and charged with drugs offences.

Following the sentencing, DC Richard Connolley, of Chester Proactive Policing Team, said: "I welcome the sentences handed to trio and I hope they act as a warning to others involved in the supply of illegal drugs. Robins thought that by taking a hands-off approach he would be able to avoid detection, and simply pass the blame onto Curtis and Roebuck, while keeping all of the profits. However, he clearly underestimated the dedication and commitment of the team here at Chester to ensure that all those involved in the supply of illegal drugs are held accountable for their actions."

DS Roy Wellings added: "While Robins, Curtis and Roebuck are now behind bars, our fight against illegal drugs remains ongoing and information from the public is vital. I'd urge anyone with any information in relation to drug-related activity in their community to get in touch."

Man jailed for more than 12 years for rape and sexual assault

A man has been sentenced to more than 12 years in prison for multiple sexual offences against two women.

Robert Houghton, of Moss Lane, Macclesfield, appeared at Chester Crown Court on Tuesday 5 November where he was jailed for 12 years and six months. The 29-year-old was found guilty of multiple sexual offences, which included rape, attempted rape, sexual assault and causing a female to engage in sexual activity without consent.



In January 2023, a woman reported that between 2020 and 2022, Houghton had raped and attempted to rape her. He would be sexually aggressive towards her and would even force items into her mouth, so she struggled to breath. The offences occurred in the Macclesfield area of Cheshire. Houghton was arrested in relation to the offences but denied the allegations put to him. He was released on bail pending further enquiries and ultimately charged.


In February 2024, another woman reported that she had been sexually assaulted by Houghton in Congleton. During the incident, which occurred in 2022, Houghton had touched her without her permission and despite her asking him to stop, he then forced her to touch him. Houghton was also arrested and charged with these offences. On top of his custodial sentence, he is subject to restraining orders in respect to both victims.


Following his sentencing, DC Doug Whitfield said: "I would like to commend the victims in this case for speaking to police about what happened to them. While they will never be able to forget what they have been through, I hope the lengthy sentence handed down to Houghton will give them some sense of closure. Houghton is clearly a sexual predator and is now in custody where he cannot subject further women to this abhorrent behaviour. He showed absolutely no regard for his victims; he knew exactly what he was doing and ignored his victims' pleas for him to stop.


"I'd like to take the opportunity to encourage anyone who may have also been a victim of sexual assault to please get in touch. We will do all we can to tackle any incident of this nature."

Nantwich anti-social behaviour hotspot property closed down by police

Police in Nantwich have secured a closure order following reports of drug abuse, disorder and crime at a property in the town.







The occupant has since been ordered to leave the property and find alternative accommodation, with all windows and doors being secured for a period of three months. Anyone who enters the address during that time will be committing a criminal offence and could be arrested.

PC Thomas Jennings said: "We are dedicated to keeping this neighbourhood and its residents safe, so securing this closure with their help is fantastic news and I hope it encourages others to work with us to make



their communities safer for everyone. I want to urge anyone with concerns about ASB or other criminality in their community to please contact local officers and we will do everything we can to address these issues and achieve justice."

Efit released following Great Boughton burglary

Police investigating a burglary at a property in Great Boughton have released an efit of a man they would like to speak to in relation to the incident.

Between 5.30pm and 6pm on Wednesday 6 November, an unknown man forcibly gained accessed to an address on Belgrave Road, Great Boughton. Whilst inside the property, the man was disturbed by the occupant and fled along Belgrave Road.

The man was described as white, being in his 30s, around 5'7" tall, of stocky build, clean shaven and wearing a brown beanie hat and a blue zipped up jacket. As part of ongoing enquiries officers are keen to hear from anyone who witnessed the incident, has CCTV or dashcam footage or was in the area at the time of the incident.

DI Rupert Morrey, of CID Proactive West, said: "I'd urge anyone who recognises this man, or the man himself, to please contact us so that we can progress with our investigation. Tarporley Police have launched an initiative to provide Key Stage 2 students at Tarporley Primary School with free lights for their bikes.

As it continues to get darker earlier, Tarporley Police have joined forces with the team at Halfords Northwich and Community Councillor Charles Hardy of Cheshire West and Chester Council to provide all Key Stage 2 pupils at

Tarporley Primary School with free bike lights so they can be seen when out and about riding.



The initiative was put into gear by PCSO Jorge Ferreira and PC Paul Gilchrest of Northwich LPU, with it being supported from the get-go by schools own Junior Safety Officers, Isabelle Brocklehurst and Jessica Bompa, who will continue play an active role as this project continues.

PC Paul Gilchrest, who helped with initiative, said: "This is a great project that we are extremely proud to bring to the pupils of Tarporley Primary School, so that they can be easily seen by other pedestrians and road users on their bikes before school, after school or on weekends when it may not be particularly bright outside.

"This would not have been possible without the help of the great team at Halford's Northwich and the generous donation made by Councillor Hardy at Cheshire West and Chester Council. I'd also like to thank Tarporley Primary School's own JSO's Isabelle and Jessica who have helped us with this project and whom we will continue to work with as we ensure that all the Key Stage 2 students have access to these bike lights.

Two charged following Winsford stabbing

Detectives investigating a stabbing in Winsford have charged two people in relation to the incident.

Declan Dixon, 19, of Victoria Square, Winsford, and a 17-year-old boy of the Winsford area, were arrested in connection with a serious assault which occurred on Delamere Street on Monday 11 November. They have both since been charged with possession of a bladed article and wounding with intent. The pair were remanded in custody and are due to appear at Chester Magistrates' Court today, Wednesday 13 November.

Three charged following offences in Widnes

Detectives from Widnes LPU have charged three teenagers in connection with an incident in the town.

Following the incident, a 16-year-old boy was arrested on Sunday 10 November, and a 14-year-old boy, and a 15-year-old boy were arrested on Monday 11 November. They have since been charged with violent disorder and robbery. The 15-year-old has also been charged with possession of a bladed article, and the 16-year-old has also been charged with wounding with intent. The charges all relate to offences which occurred on Hurst Street, Widnes, on Sunday 10 November. The trio have been remanded in police custody and are set to appear at Chester Magistrates' Court today, Wednesday 13 November.

Appeal for information following serious collision in Congleton

Officers from Cheshire Police are appealing for witnesses and video footage following a serious collision in Congleton.

At 5.08pm on Wednesday 6 November, police were called to reports of a collision on the Clayton Bypass. Officers attended the scene and found there had been a collision between an orange Land Rover Discovery and a pedestrian. The pedestrian, a 74-year-old woman, was treated at the scene by paramedics before being taken to hospital. She remains in Royal Stoke Hospital at this time. Her injuries are described as serious. The driver of the car, a 42-year-old man, was uninjured. Enquiries in relation to the collision are ongoing.

Constable Archie Love, of the Roads and Crime Unit at Cheshire Police, said: "This was a serious collision which has left an elderly woman with serious injuries, and we are committed to doing all we can to establish what took place. As part of our enquiries we're keen to hear from anyone who was in area and witnessed the collision taking place. The same goes for anyone with any dashcam or CCTV footage which may aid the investigation. I'd urge anyone with any information to call us on 101 or visit the website, quoting IML 1957270."

Family pays tribute following fatal collision in Walton

A family have paid tribute following a fatal collision on the A56 Chester Road, Walton on Sunday.

Jayne Green, 42, from Warrington was a passenger in a vehicle involved in the collision on Sunday 10 November at 6.08pm. The driver of the Seat, a 65-year-old



man, and the rear seat passenger of the Nissan, Jayne Green, sadly died at the scene. Two other passengers in the Nissan were taken to hospital with serious injuries.

The family said: "Jayne who is a mother, sister, daughter, and partner will be sadly missed by friends and family."

The family have requested privacy at a time of deep sadness, while they support other family members who were travelling in the same vehicle and are receiving specialist medical treatment for serious injuries.

Ellesmere Port man charged with fraud offences

Officers investigating the fraudulent sale of concert tickets across the UK have charged a man in relation to the offences.

Jordan Moore, of Smithy Lane, Ellesmere Port, has been charged with seven counts of fraud by false representation and one count of threatening to share an intimate photograph without permission. The charges relate to the sale of fraudulent of convert tickets and the fraudulent sale of equipment. The 31-year-old has been released on bail and is set to appear at Chester Crown Court on Friday 20 December.

Two county lines drug dealers sentenced following investigation by Warrington officers

Two members of a Merseyside OCG who took over the address of a vulnerable man have now been sentenced thanks to work by detectives from Warrington Proactive CID.

Jack Parkinson appeared at Liverpool Crown Court on Tuesday 24 September where he was jailed for 37 months. Luke Derby appeared at the same court on Friday 8 November where he was sentenced to two years in prison, suspended for two years. Parkinson, 18, of Garway, Liverpool, while Derby, 19, of Radbrook Close, Halewood, had both previously pleaded guilty to two counts of possession with intent to supply class A drugs (crack cocaine and heroin).

During the hearing, the court was told how on Wednesday 10 January officers received a call from a concerned member of the public who reported concerns for the safety of a vulnerable man at an address in the Orford area of Warrington.

Officers attended the address and both Parkinson and Derby were arrested at the property. The vulnerable man was also located safe and well. A number of mobile phones were seized from the pair, along with a quantity of cash. A golf ball size package, which was thrown from a rear window, was also recovered from the scene. The package was later found to contain individual wraps of crack cocaine and heroin.

During questioning, both Parkinson and Derby refused to answer any questions out to them by officers, they also refused to reveal the PIN numbers for the mobile phones. Despite their silence, officers were able to gather a catalogue of evidence that proved the pair were both members of a Merseyside organised crime gang (OCG) who had been dealing drugs in the Warrington area. The pair had exploited the vulnerable occupant of the address, in order to use his home as a base to deal drugs from — often called Cuckooing.

Following the sentencing, PC Simon Gibson, of Warrington Proactive CID said: "I welcome the sentences handed to Parkinson and Derby, who are both callous criminals who exploited a vulnerable man in order to profit from drug dealing. Illegal drugs can have a devastating impact on not only drug users, but the community around them. Here in Warrington, we are doing all we can to stop drug activity on our streets to

make the town a safer place to live and visit while also making it extremely difficult for these gangs to operate.

"However, this is not an issue that we can tackle alone, and I want to take this opportunity to urge residents to keep spotting the signs of vulnerability. Keep an eye out if they feel something isn't right and to report it to us on 101 or Crimestoppers anonymously on 0800 555 111. We will always act on any information we receive and I would urge anyone who believes this activity is happening near to them, to get in touch."

Man charged following firearms incident in Nantwich

A 31-year-old man who was arrested following a firearms incident in Nantwich has now been charged.

Matthew Alcroft was arrested at around 2.14pm on Wednesday 6 November after Crewe officers conducted a warrant at an address in Nantwich. The 31-year-old has since been charged with possession of a prohibited weapon, namely a section 1 Firearm and possession of ammunition for a firearm without a licence. Alcroft appeared at Chester Magistrates' Court on Saturday 9 November, where he was remanded in custody. He is next set to appear at Chester Crown Court on Monday 9 December.

Man charged in connection with sex offences

A man has been charged in connection with sex offences in Northwich.

Yunus Erdogan was arrested at an address on Beeston Street, Northwich, at 2.38pm of Saturday 9 November. Following questioning, the 25-year-old was charged with attempting to facilitate the commission of a child sex offence. He has been remanded in police custody and is set to appear at Chester Magistrates' Court today, Monday 11 November.

Two people charged with supplying class A drugs in Winsford

Detectives investigating the supply of illegal drugs in Winsford have charged two people.

At 11.40am on Friday 8 November, officers Northwich Proactive CID officers arrested a 44-year-old woman at a self-storage unit on New Road, Winsford, as part of an ongoing investigation. A search was subsequently undertaken on the unit where officers recovered approximately £43,500 of class A drugs (cocaine and heroin). A 33-year-old man was also arrested nearby in relation to the incident. Following questioning, Iain Alexander, 33, of Robinson Lane, Winsford, and Helen Reynolds, 44, of Ledward Street, Winsford, have both been charged with two counts of conspiracy to supply Class A drugs. The pair have been remanded in custody and are set to appear at Chester Magistrates' Court later today, Monday 11 November.

Appeal renewed following fatal collision in Chester

Police are renewing their appeal for witnesses and dashcam footage following the death of a child who was involved a collision in Chester.

At around 5.12pm on Tuesday 12 November, officers were called to reports of a collision on Wrexham Road, near to the entrance of Kings School. Officers attended the scene and found there had been a collision between a grey Nissan Qashqai and a pedestrian. The pedestrian, an 11-year-old boy, sustained serious injuries and was treated at the scene before being taken to Alder Hey hospital. Sadly, the boy passed away

this morning, Saturday 16 November. His family are being supported by specialist officers. The driver of the Nissan, a 28-year-old woman from Wrexham, was uninjured during the incident and no arrests have been made. As part of ongoing enquiries, officers are now appealing for witnesses or anyone with information or CCTV footage to come forward.

Sergeant Russell Sime, of the Serious Collision Investigation Unit, said: "We understand that this was distressing incident, and our thoughts remain with the victim's family at this difficult time. As part of our ongoing enquiries we are asking for anyone who may have witnessed the incident, or has any information about it, to get in touch. The same goes for anyone who may have captured the incident on dashcam or on CCTV."
