## Agreed Upon Terms:

- Booth space provided, 10' x 10' for \$75 (if paid prior to 5/1/25 and \$100 if after 5/1/25).
- Two folding chairs provided.
- One 8' table provided.
- Vendor to provide signage, display materials, table clovers, anything else needed for booth.
- Vendor should arrive no later than 30 minutes prior to doors opening of convention and stay until the convention closes. Please have your booth set up and ready to go prior to the convention opening to the public.
- Please limit vendor personnel to 5 individuals at booth.
- Should Vendor deem it necessary to cancel this Agreement, Horror Fiesta is not responsible for any fees.
- Vendor is responsible for their own cash handling or other forms of monies collected by the Vendor, as well as security.
- Horror Fiesta will not be responsible for any damage, accidents, or injury that may happen to the Vendor, employees, or representatives, or their property from any cause whatsoever arising out of this Agreement, including the event.
- Vendor will indemnify and hold harmless Horror Fiesta, Exposition Gardens, the staff working the event and volunteers against any and all claims, liabilities, losses, damages, and expenses incurred (including reasonable legal fees), joint or several (including actions or proceedings in respect thereof) arising out of or in any way relating to bodily injury or death of any person or damage to real and/or tangible personal property, libel, or slander incurred that is caused by the Vendor, it's employees or representatives.
- Vendor booth fee can be paid via cash, check, Cash App, or Venmo.
- Early bird special: if paying before May 1, 2025, booth fee is \$75. If paying May 1<sup>st</sup> to June 1<sup>st</sup>, 2025, booth fee is \$100.
- All Vendor booth fees are due by June 1, 2025.
